Background

- The Panel was appointed in terms of Section 3A of the National Environmental Management Act, 1998 (Act No.107 of 1998).
- The Panel is appointed for a period of six (06) months (1st October 2021 31st March 2022).





Terms of References

To advise the Minister of Forestry, Fisheries and the Environment on:

- The significance and impact of the opening of the estuary mouth and how this relates to the implementation of the Global Environment Funds (GEF) 5 project interventions and the St. Lucia Estuary Management Plan;
- The exceptional circumstances, as defined in the estuarine management plan, that led to the decision to open the mouth, including those of an environmental, social, and economic nature;
- The impact of the mouth opening on 6 January 2021 on the functioning of the estuary system and the wetland system, as well as the associated environmental, social, and economic implications; and
- Develop guidelines for the immediate and ongoing management of the system.
