Report of the Select Committee on Security and Constitutional Development on the Protection of Personal Information Bill [B 9B- 2009] (National Assembly – sec 75), dated 12 June 2013:

The Select Committee on Security and Constitutional Development, having considered the subject of the **Protection of Personal Information Bill [B 9B- 2009] (National Assembly – sec 75)**, referred to it, reports that it has agreed to the Bill with the following proposed amendments:

Report of the Select Committee on Security and Constitutional Development on Proclamations made in terms of section 25 of the Protection of Constitutional Development Act, 2004 (Act No. 33 of 2004), dated 12 June 2013.

The Select Committee on Security and Constitutional Development received a briefing on the Proclamations made in terms of section 25 of the Protection of Constitutional Development Act, 2004 (Act No. 33 of 2004) as Democracy Against Terrorist and Related Activities Act, 2004 (Act No. 33 of 2004) as tabled in the following gazettes:

1. Proclamation No 39, Proclamation No 40, published in the Government Gazette No 35566, dated 6 August 2012;
2. Proclamation No 41, Proclamation No 42, Proclamation No 43, published in the Government Gazette No 35599, dated 17 August 2012;
