The Chairperson of the Agriculture and Rural Development Portfolio Committee, Hon. Nokuthula Sikakane, tables the Committee's Final Voting Mandate on the National Environmental Management: Air Quality Amendment Bill [B27D-2013], Section 76, as follows:

1. PROCESS FOLLOWED

The Speaker, Hon. Lindiwe Maseko formally referred the National Environmental Management: Air Quality Amendment Bill [B27D-2013], a Section 76 Bill to the Portfolio Committee on Agriculture and Rural Development, in terms of GPL Rules 252(1) (a) read with 254 (1) and 255 (1) for consideration and reporting.

On Friday, 21 February 2014 the Portfolio Committee on Agriculture and Rural Development convened a meeting to deliberate, consider the minutes and adopt the Final Voting Mandate on National Environmental Management: Air Quality Amendment Bill [B27D-2013] Section 76.

2. PRINCIPLE AND DETAIL OF THE BILL

The Bill seeks to amend certain provisions of the National Environmental Management Act, 2004 (Act No. 39 of 2004) to close certain regulatory gaps relating to atmospheric emissions licences.

3.1 FINANCIAL IMPLICATIONS OF THE BILL

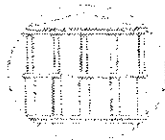
The Bill does not create financial liabilities to the province.

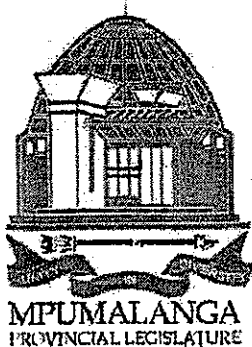

FINAL MANDATE FOR THE NATIONAL ENVIRONMENTAL MANAGEMENT: AIR QUALITY AMENDMENT BILL [B27D-2013]

(Section 76 Bills)

1. INTRODUCTION

The Chairperson of the Portfolio Committee on Agriculture, Land Reform, Rural Development, Environment & Nature Conservations, Hon NJ Galela, tables the Committee's Final Mandate on the *National Environmental Management: Air Quality Amendment Bill* [B27D-2013] as adopted by the Portfolio Committee on 20 February 2013.

2. PROCESS FOLLOWED

The Speaker of the Northern Cape Provincial Legislature, on receipt, referred the *National Environmental Management: Air Quality Amendment Bill* [B27B-2013] to the Portfolio Committee on Agriculture, Land Reform, Rural Development, Environment & Nature Conservations on 08 November 2013.

On 31 January 2014, the Portfolio Committee on Agriculture, Land Reform, Rural Development, Environment & Nature Conservations received a briefing on the Bill from the permanent Member of NCOP Hon G Mokgoro.

The public hearing was held on 11 February 2014, as per Committee resolution and both written and oral submissions were called for. The stakeholders engaged with the Members of the Provincial Legislature in respect of the Bill.

On 13 February 2014, the Portfolio Committee on Agriculture, Land Reform, Rural Development, Environment & Nature Conservations deliberated and considered the Negotiating Mandate of *National Environmental Management: Air Quality Amendment Bill* [B27B-2013]

3. PORTFOLIO COMMITTEE POSITION AT THE NEGOTIATING STAGE

The Portfolio Committee on Agriculture, Land Reform, Rural Development, Environment & Nature Conservations supports the Bill.

The House conferred on the Permanent Delegates the authority to participate in negotiations and to raise the concerns expressed.

4. COMMITTEE POSITION AFTER CONSIDERATION OF NEGOTIATING MANDATE BY THE NCOP SELECT COMMITTEE

The Portfolio Committee's Final Mandate is that the Northern Cape supports the *National Environmental Management: Air Quality Amendment Bill* [B27D-2013]

5. FINAL VOTING MANDATE

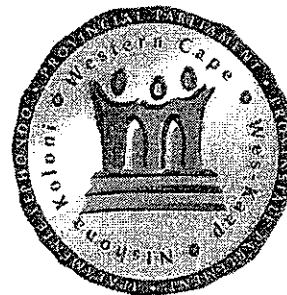

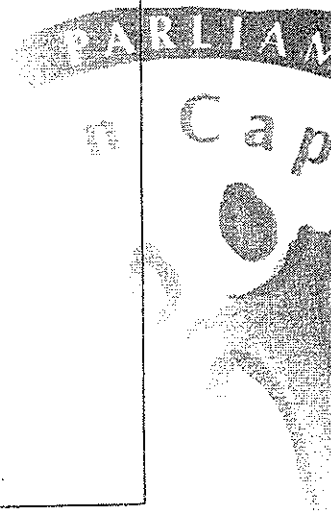
