



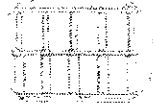
The Chairperson of the Agriculture and Rural Development Portfolio Committee, Hon. Nokuthula Sikakane, tables the Committee's Final Voting Mandate on the National Environmental Management: Air Quality Amendment Bill [B27D-2013], Section 76, as follows:

1. PROCESS FOLLOWED

The Deputy Speaker, Hon. Uhuru Moiloa formally referred the National Environmental Management: Air Quality Amendment Bill [B27B-2013], a Section 76 Bill to the Portfolio Committee on Agriculture and Rural Development, in terms of GPL Rules 252(1) (a) read with 254 (1) and 255 (1) for consideration and reporting on the 04th March 2014.

On Tuesday, 28 January 2014, the Portfolio Committee on Agriculture and Rural Development received a presentation on the Bill from the National Department of Environmental Affairs and a presentation of the opinion on the Bill from the Gauteng Department of Agriculture and Rural Development. In the same meeting, a Legal Opinion was submitted and presented by NCOP and Legal Services, and further, Research Analysis was submitted.

The Committee held a public hearing on Wednesday, 05 February 2014, to receive submissions from stakeholders and members of the Public. The Committee deliberated on and adopted the Negotiating Mandate on the Bill on Tuesday, 11 February 2014. On





**REPORT OF THE PORTFOLIO COMMITTEE ON ECONOMIC
DEVELOPMENT, ENVIRONMENT AND TOURISM ON THE
NATIONAL ENVIRONMENTAL MANAGEMENT: INTEGRATED
COASTAL MANAGEMENT AMENDMENT BILL [B 8D-2013]**

1. INTRODUCTION

The National Environmental Management: Integrated Coastal Management Amendment Bill [B 8D-2013] was referred to the Legislature of the Limpopo Province by the NCOP and the Legislature in turn referred it to the Portfolio Committee on Economic Development, Environment and Tourism for consideration.

2. PURPOSE OF THE BILL


To amend the National Environmental Management: Integrated Coastal Management Amendment Act, 2008, so as to amend certain definitions; to clarify coastal public property and the ownership of structures erected on and in coastal public property; to remove the power to exclude areas from coastal public property; to clarify and expand the provisions on reclamation; to clarify definitions and terminology; so simplify the administration of coastal access fee approvals; to simplify and amend powers relating to coastal authorisations; to replace coastal leases and concessions with coastal use permits; to extend the powers of MECs to issue coastal protection notices and coastal access notices; to limit the renewal of dumping permits; to simplify the composition and functions of the National Coastal Committee; to clarify the powers of delegation by MECs; to revise offences and increase penalties; to improve coastal authorisation processes; to provide for exemptions; to provide for transitional matters; to effect certain textual alterations; and to provide for matters connected therewith.

3. CONSIDERATION OF THE BILL

The Portfolio Committee on Economic Development, Environment and Tourism was briefed on the principle and provisions of the Bill by the NCOP Permanent Delegate during a Committee meeting held on 05 February 2014. The Committee decided not to conduct public hearings on the amendment bill.

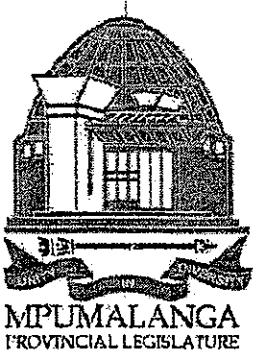
4. NEGOTIATING MANDATE

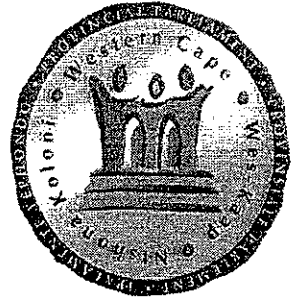


