

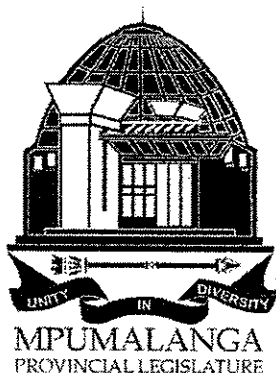

FINAL MANDATE FOR THE NATIONAL ENVIRONMENTAL MANAGEMENT: WASTE AMENDMENT BILL [B32B-2013]

(Section 76 Bills)

1. INTRODUCTION

The Chairperson of the Portfolio Committee on Agriculture, Land Reform, Rural Development, Environment & Nature Conservations, Hon NJ Galela, tables the Committee's Final Mandate on the *National Environmental Management: Waste Amendment Bill [B32B-2013]* as adopted by the Portfolio Committee on **19 March 2013**.

2. PROCESS FOLLOWED

- 2.1 The Speaker of the Northern Cape Provincial Legislature, on receipt, referred the *National Environmental Management: Waste Amendment Bill [B32B-2013]* to the Portfolio Committee on Agriculture, Land Reform, Rural Development, Environment & Nature Conservations on **27 February 2014**.
- 2.2 On **06 March 2014**, the Portfolio Committee on Agriculture, Land Reform, Rural Development, Environment & Nature Conservations received a briefing on the Bill from the NCOP Permanent Delegate, Hon GG Mokgoro and Officials from National Department of Environmental Affairs.
- 2.3 The Portfolio Committee resolved at the meeting of **06 March 2014** to hold public hearing on the referred Bill in Pixley Ka Seme Region (Douglas), to solicit the views of communities and stakeholders with regard to the *National Environmental Management: Waste Amendment Bill [B32B-2013]*
- 2.4 The public hearing was held on **11 March 2014**, as per Committee resolution and both written and oral submissions were called for. The stakeholders engaged with the Members of the Provincial Legislature in respect of the Bill.
- 2.5 On **13 March 2014**, the Portfolio Committee on Agriculture, Land Reform, Rural Development, Environment & Nature Conservations deliberated and considered the Negotiating Mandate of *National Environmental Management: Waste Amendment Bill [B32B-2013]*

3. **PORTFOLIO COMMITTEE POSITION AT THE NEGOTIATING STAGE**

The Portfolio Committee on Agriculture, Land Reform, Rural Development, Environment & Nature Conservations met on the 13 March 2014 to support the Bill.

The House conferred on the Permanent Delegates the authority to participate in negotiations.

4. **COMMITTEE POSITION AFTER CONSIDERATION OF NEGOTIATING MANDATE BY THE NCOP SELECT COMMITTEE**

The Portfolio Committee's Final Mandate is that the Northern Cape support the *National Environmental Management: Waste Amendment Bill [B32B-2013]*

5. **FINAL VOTING MANDATE**

In terms of Section 65 of the Constitution, the Portfolio Committee on Agriculture, Land Reform, Rural Development, Environment & Nature Conservations recommends that the House confer authority on the Head of its Delegation to the NCOP, to vote in support of the National Environmental Management: Waste Amendment Bill [B32B-2013]

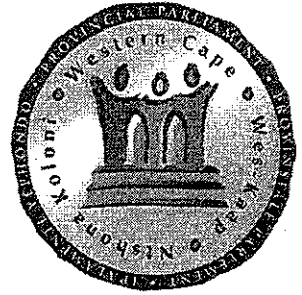

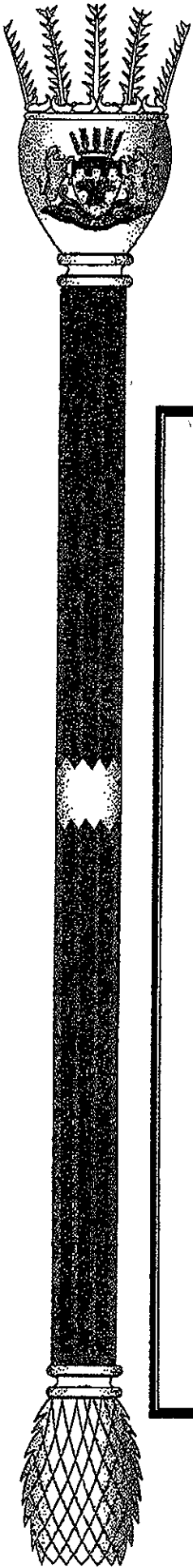
