FINAL MANDATE FOR THE NATIONAL ENVIRONMENTAL MANAGEMENT LAWS 3rd AMENDMENT BILL [B26B-2013]

(Section 76 Bills)

1. INTRODUCTION

The Chairperson of the Portfolio Committee on Agriculture, Land Reform, Rural Development, Environment & Nature Conservations, Hon NJ Galeia, tables the Committee's Final Mandate on the *National Environmental Management Laws 3rd Amendment Bill [B26B–2013]* as adopted by the Portfolio Committee on 19 March 2013.

2. PROCESS FOLLOWED

- 2.1 The Speaker of the Northern Cape Provincial Legislature, on receipt, referred the *National Environmental Management Laws 3rd Amendment Bill* [B26B–2013] to the Portfolio Committee on Agriculture, Land Reform, Rural Development, Environment & Nature Conservations on 27 February 2014.
- 2.2 On 06 March 2014, the Portfolio Committee on Agriculture, Land Reform, Rural Development, Environment & Nature Conservations received a briefing on the Bill from the NCOP Permanent Delegate, Hon GG Mokgoro and Officials from National Department of Environmental Affairs.
- 2.3 The Portfolio Committee resolved at the meeting of 06 March 2014 to hold public hearing on the referred Bill in Pixley Ka Seme Region (Douglas), to solicit the views of communities and stakeholders with regard to the National Environmental Management Laws 3rd Amendment Bill [B26B-2013]
- 2.4 The public hearing was held on 11 March 2014, as per Committee resolution and both written and oral submissions were called for. The stakeholders engaged with the Members of the Provincial Legislature in respect of the Bill.
- 2.5 On 13 March 2014, the Portfolio Committee on Agriculture, Land Reform, Rural Development, Environment & Nature Conservations deliberated and considered the Negotiating Mandate of National Environmental Management Laws 3rd Amendment Bill [B26B–2013]

3. PORTFOLIO COMMITTEE POSITION AT THE NEGOTIATING STAGE

The Portfolio Committee on Agriculture, Land Reform, Rural Development, Environment & Nature Conservations met on the 13 March 2014 to support the Bill.

The House conferred on the Permanent Delegates the authority to participate in negotiations.

4. COMMITTEE POSITION AFTER CONSIDERATION OF NEGOTIATING MANDATE BY THE NCOP SELECT COMMITTEE

The Portfolio Committee's Final Mandate is that the Northern Cape <u>support</u> the *National Environmental Management Laws 3rd Amendment Bill* [B26B–2013]

5. FINAL VOTING MANDATE

In terms of Section 65 of the Constitution, the Portfolio Committee on Agriculture, Land Reform, Rural Development, Environment & Nature Conservations recommends that the House confer authority on the Head of its Delegation to the NCOP, to vote in <u>support of the National Environmental Management Laws 3rd Amendment Bill [B26B-2013]</u>
