REPORT OF THE PORTFOLIO COMMITTEE ON SAFETY, SECURITY AND LIAISON ON STATE ATTORNEY AMENDMENT BILL [B 52B - 2013]

### 1. INTRODUCTION

The State Attorney Amendment Bill [B 52B-2013] was referred to the Limpopo Legislature by the National Council of Provinces (NCOP). The Bill was then referred to the Portfolio Committee of Safety, Security and Liaison. Subsequently, a negotiating mandate was conferred to Limpopo NCOP Delegates to negotiate in favor of the Bill. It is against this background that the Committee begs to report to this Honourable House for the formal conferral of a final mandate to the NCOP Delegates to support the Bill as amended.

### 2. PURPOSE OF THE BILL

The objective of the Bill is to amend the Attorneys Act, 1979, so as to further regulate the powers of the board of control of the Attorneys Fidelity Fund; the Child Justice Act, 2008, so as to further regulate the evaluation of the criminal capacity of a child; to provide for the delegation of certain powers and assignment of certain duties by the Cabinet member responsible for social development in respect of the accreditation of diversion service providers; to repeal provisions that make the Criminal Law and to provide for matters connected therewith.

### 3. BRIEFING ON THE BILL

The Portfolio Committee on Safety, Security, and Liaison had a meeting on 07 March 2014 and the NCOP Permanent Delegate did not brief the committee due to lack of quorum. A meeting was again held on 14 March 2014 and Members were briefed on principle and provisions of the Bill. The Committee thereafter conducted a provincial public hearing on 14 March 2014 in Capricorn District.

## 4. CONSIDERATION OF THE AMENDMENTS MADE ON THE BILL

The Portfolio Committee, having considered the amendments made on the Bill by the Select Committee on Security and Constitutional Development, found that the amendments are not affecting the substance and principle of the Bill.

### 5. RECOMMENDATION

The Portfolio Committee having considered and supported the Bill by the Select Committee on Security and Constitutional Development recommends to this House to confer a final mandate to the NCOP Permanent Delegates to support the Bill as agreed upon by the Select Committee and to vote in favor of the Bill to be passed into law.

### 6. CONCLUSION

In conclusion, the Committee moves that this report be adopted as a report of the august House and that a final mandate be conferred to the NCOP Delegates to vote in favor of the Bill to pass into law. I move accordingly.
