

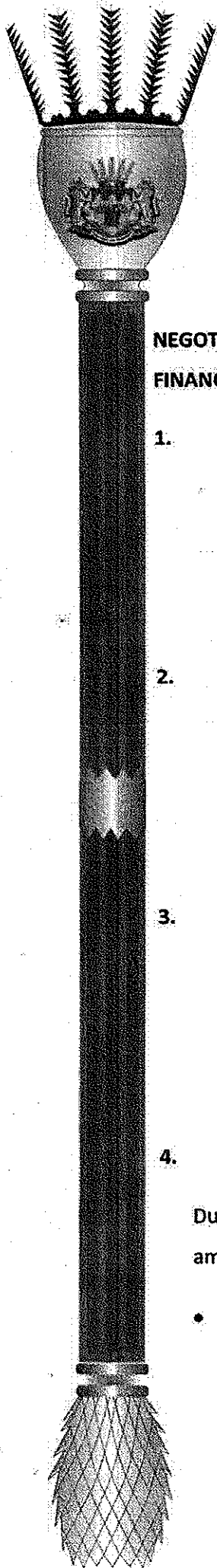

NEGOTIATING MANDATE OF THE PORTFOLIO COMMITTEE ON PROVINCIAL TREASURY ON FINANCIAL AND FISCAL COMMISSION AMENDMENT BILL, 2015 [B 1B-2015]

1. INTRODUCTION

Financial and Fiscal Commission Amendment Bill 2015, [B 1B-2015] was referred to the Legislature by the NCOP. The Legislature referred it to the Portfolio Committee on Provincial Treasury for consideration and to confer a negotiating mandate to NCOP Permanent Delegates.

2. PURPOSE OF THE BILL

The Bill seeks to enhance institutional and other governance arrangements and functioning of the Commission; to fully align FFC Act with Constitution and Public Finance Management Act and to give effect to section 219 (5) of the Constitution by introducing procedures for determining remuneration of Commission members.

3. CONSIDERATION OF THE BILL

The NCOP Permanent Delegate together with National Treasury, briefed the Portfolio Committee on Provincial Treasury on the provisions of the Bill during a meeting held on 20 May 2015. Upon the deliberations, the Committee agreed that written submissions should be sought from various stakeholders in the province.

4. BRIEFING BY NCOP AND NATIONAL TREASURY

During the briefing by National Treasury, the Committee found that the main amendments included amongst others the following:-

- Proposal of the creation of new administrative position of the CEO and also to have functions of accounting officer (AO) and secretary to Commission.

- Alignment of Commission's functions to Constitution and other legislation
- Membership arrangements, members' remuneration, members' conduct and rule-making powers
- Alignment to PFMA.

The Committee welcomed amendments made on the Bill.

5. NEGOTIATING MANDATE

The Portfolio Committee having considered the Bill hereby confer a negotiating mandate to the National Council of Provinces' Permanent Delegate to negotiate in favour of the Bill.
