

## **Background**

- The investigation of the Heritage Foundation was prompted by a discovery of an alleged irregular payment which was made to a service provider who never completed their assigned project.
- UBAC (Pty) Ltd was appointed through proper procurement processes to conduct a forensic investigation into all irregularities which were reported in the 2011/12 audit report including the funds allocated to "The Heritage Foundation" for the period 2011 to 2013.
- In total the Entity paid R1,4 million for the Forensic Investigation in the irregularities that were raised in the disclaimer audit report of 2011/12 as well as the activities of the Heritage Foundation





## **Background cont.**

- An MOU was entered into between SAHRA and The Heritage Foundation on 17 January 2011. SAHRA was represented by the former CEO, Ms S Van Damme and The Heritage Foundation by the Managing Director, Mr GN Opperman.
- In terms of this MOU, it is stated that "the Parties are desirous of entering into an arrangement for the establishment of a framework for the conservation and management of mutually agreed white and black concentration camps, graves and cemeteries, including the Burgher graves (Anglo- Boer South African War (1899-1902) in South Africa."
- Funds totalling R 2,250,000.00 were transferred from SAHRA to The Heritage Foundation for the restoration, conservation, and management of identified burial and memorial sites in terms of a MOU signed by the parties. The payments were made as follows:
  - 31 May 2011 R 750,000.00;
  - 9 November 2012 R 750,000.00; and
  - 31 May 2013 R 750,000.00.





# Objectives of the Heritage Foundation Investigation

- Conduct a review of the respective MOU's entered into between SAHRA and The Heritage Foundation and to establish compliance
- Investigate any irregularities identified with regards to the restoration and
   conservation management of identified burial and memorial sites in term of the
   MOU;
- Determine if there was any preferences and / or segregation in respect of work undertaken by the "The Heritage Foundation
- Reconcile and review all payments made to "The Heritage Foundation "by SAHRA;
- Request and review the Statements of Income and Expenditure for the respective years relating to funds received from SAHRA;

# Objectives of the Heritage Foundation Investigation

- Request and review the breakdown of expenditure incurred in respect of funds received from SAHRA;
- Identify and investigate any irregularities in terms of the Statement of
   Income and Expenditure and breakdown of expenditure as provided by "The
   Heritage Foundation";
- Conduct physical site inspections where necessary;
- Determine ownership of sites and investigate any irregularities identified;
- Conduct interviews, where necessary with relevant stakeholders at SAHRA and "The Heritage Foundation";



#### **Findings**

- That SAHRA nounces are a sequired to a sequire immediate refund of the unspent funds together with any interest that may be due.
- The Heritage Foundation has contravened section 11, and section 15(6) of the MOU (
   Additional Projects without consultation).
- It would appear that the former CEO Ms S Van Damme, Mr D Sibiya and Mr T Phili failed to protect the interest of the Black Concentration Camps/ Heritage sites by allowing the MOU to focus only on White Concentration Camps/ Heritage sites.
- •There was no budget provided for the following:
  - ≟⊋Salaries;
  - Security;
  - Purchasing of new vehicles; and
  - Other general expense





### **Management Comments**

We have reviewed the forensic report and do not agree with the conclusions reached;

- All work executed by the Heritage Foundation was in line with the MOU. UBAC incorrectly linked the expenditure to projects which were preliminary indentified in an email, while the MOU did not identify any specific sites. The work done by General Opperman included Black and white concentration camps as per the MOU. It should be noted that sites were only identified after the funds were transferred.
- The finding that only R313 502 of the expenditure is legitimate is not correct. It should further be noted that project reports with photos were provided by the Heritage Foundation to UBAC, which served as physical evidence of the work done by the Heritage Foundation.





## Management Comments cont.

• The findings that the Heritage Foundation breached clause 15(9) which indicates that the funds should be expensed within 6 months, was not strictly adhere to, however the audited reports submitted by the Heritage Foundation indicate that the total expenditure for the 2011/2012 financial year amounted to R765 040 and the 2013/2014 financial year amounted to R750 043. The funds were thus spent in full in the respective financial years except for 2011/2012 year for which a saving of R15 645 was realized.

It should be noted that The Heritage Foundation did expense more funds than received over the 3 year period.





### Management Comments cont.

- In terms of clause 11 of the MOU, "VARIATIONS," it is stated that "No variation, modification, or relinquishment of any of the terms in this Agreement or deviation by consent will be valid unless stated in writing and signed by both parties. Such variation, modification, relinquishment, or consent shall only apply to a specific case and only for the purpose and to the extent it was made for."
- The finding that the Heritage Foundation breached clause 11 is unfounded as the projects which were outside the list of projects was condoned by SAHRA by providing more funding.
- The fact of the matter is that the project was not properly managed by SAHRA which then allowed the Heritage Foundation to include other graves as and when they saw the need.





#### Management Comments cont.

- Therefore the amount of R1,6 million which the forensic report suggests that should be
  recovered if the projects done were not part of the initial approved list is not advisable
  as the projects undertaken related to same intended purpose of rehabilitating the
  concentration camps.
- The assets bought during the 3 year period by The Heritage Foundation are small assets with a cost value of R37 000 and two vehicles with a market value of R165 000, as per the list submitted by General Opperman in the report dated 08 November 2014. The MOU is silent about the assets acquired for the execution of the project. Our view is that these assets should remain with the Heritage Foundation as they are continuing to maintain the graves.





# Conclusion

- Based on the analysis of the report and the meetings held with the Heritage Foundation, SAHRA concluded that there were no material irregularities and that all work undertaken falls within the ambit of our mandate.
- The report is now closed and there are plans to further engage the Heritage Foundation for continued partnership.
