DEAR SPEAKERS AND MINISTER.

PLEASE ACCEPT THE PRAYERS OF THE COMMUNITIES THROUGH THE PHTL-WC AS SET OUT IN THIS PETITION AND AS PROVIDED FOR BY LAW.

PRAYER 1:

THAT MINISTER BREDELL IDENTIFIES THE IDENTIFIED TRADITIONAL LEADERS, THREW THEIR RESPECTIVE TRIBAL AUTHORITIES, WITH THE MUNICIPAL MANAGERS ON THE MUNICIPAL COUNCILS AS PROVIDED BY ACT 117/1998.

PRAYER 2:

THAT THE NA OR NCOP OR WCG ENACT THE ESTABLISHING RULES OF THE PHTL-WC AS PRAYED BY THE MINISTER. (AND SO ORDERED BY HONOURABLE JUDGE ROGERS OF THE WC HIGH COURT IN CASE 4881/2014 THAT AN ACT MUST BE LEGISLATED TO BE RECOGNISED.

PRAYER 3:

THAT THE NHTL ACCEPTS THE THREE MEMBERS OF THE PHTL-WC IDENTIFIED ON THE NHTL.

PRAYER 4:

THAT GOVERNMENT CONSULT THE “KHOISAN BILL” WITH THE INDIGENOUS KHOISAN COMMUNITIES AS PROVIDED BY LAW THROUGH THE PHTL-WC AND THEIR RESPECTIVE TRADITIONAL COUNCILS , -HOUSES, TRIBAL AUTHORITIES ECT.

PRAYER 5:

FOR THE AMENDMENT OF THE RULES OF THE NA, NCOP AND THE WCG TO MAKE PROVISION FOR PRAYER 4 AND WHENEVER THERE IS A BILL OR DECISION OR POLICY THAT HAVE AN IMPACT/BEARING ON THE INDIGENOUS/TRIBAL COMMUNITIES OF THE PHTL-WC.

THE INDIGENOUS/TRADITIONAL COMMUNITIES OF THE PHTL-WC HUMBLY THANK THE GOVERNMENT WHO MADE THIS PETITION OPPERTUNITY IN LAW AND ACCEPT THIS PETITION.
