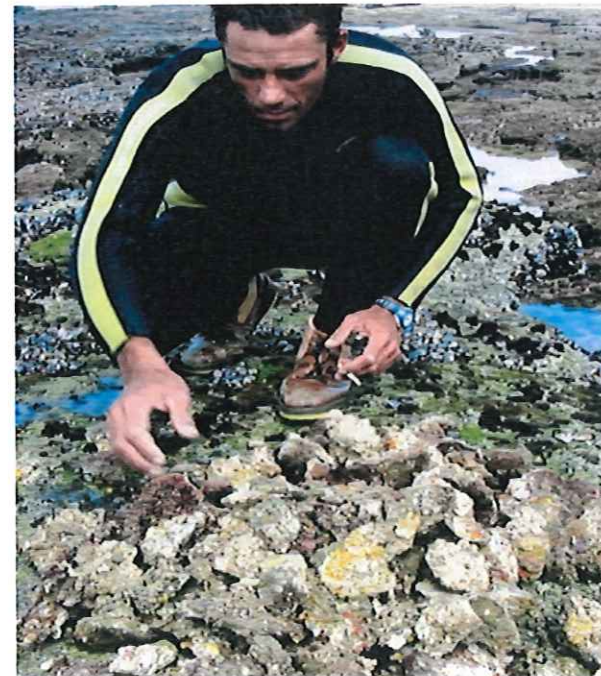

## Milestones achieved in 2016

- Amended MLRA promulgated - Mar
- SSF regulations approved - Mar
- Expression of Interest closed – Apr (316 communities registered)
- Registration conducted (NC, WC, EC, KZN) – Mar-Aug
- Socio-economic baseline survey conducted for all communities – Mar -Aug
- Verification and assessments conducted (NC, WC, EC, KZN) – Mar -Aug
- Announcement of provisional lists of successful fishers (NC, WC) Aug, Oct
- Appeals process (NC, WC) – Sep, Nov
- Appeals assessed (NC) - Oct

- Registration and verification by numbers:
  - 4 coastal provinces
  - 5 months community work
  - 55 DAFF officials & 60 service provider staff
  - 316 communities
  - 22 601 people registered
