1. Introduction





- The eviction of persons is regulated by law.
- The following legislation regulates different situations:
 - The Extension of Security of Tenure Act, 1997 (Act No. 62 of 1997) (ESTA);
 - The Land Reform (Labour Tenants) Act, 1996 (Act No. 3 of 1996);
 - The Trespass Act, 1959 (Act No. 6 of 1959);
 - Prevention of Illegal Eviction from and Unlawful Occupation of Land Act, 1998 (Act No. 19 of 1998) (PIE); &
 - Rental Housing Act, 1999 (Act No. 50 of 1999).

Introduction (2)



- The South African Police Service (SAPS) respects the rights entrenched in section 26 of the Constitution of the Republic of South Africa, 1996, placing an obligation on Organs of State and others regarding the right of access to adequate housing, the taking of reasonable legislative and other measures, within available resources, to achieve the progressive realisation of this right and that no one may be evicted from their home or have their home demolished, without an order of court made after considering all the relevant circumstances.
- Both unlawful occupation of and illegal eviction from land infringe upon basic constitutional human rights as entrenched in the Constitution.
- Government should therefore deal with the Constitutional rights of both occupiers and landowners in a careful and balanced manner.

Introduction (3)



- If the person "trespassing" is an occupier, that person enjoys the protection of the LTA, ESTA or PIEA and the police member should immediately advise the complainant to obtain legal advice or consult an attorney in order to obtain an eviction order in terms of the applicable legislation.
- No person may evict an occupier except on the authority of an eviction order of a competent court.

2. Extension of Security of Tenure Act, 1997 (Act No. 62 of 1997)





Extension of Tenure Act



- An occupier in terms of ESTA is a person living (residing) on land with the owner's consent.
- This consent does not have to be express (in writing or orally) but may also be given tacitly.
- The following persons are not occupiers:
 - A person using the land in question mainly for industrial, mining, commercial or commercial farming purposes, but including a person who works the land for himself or herself and only employs a member(s) of his or her family.
 - A person earning more than the prescribed gross income (currently R 5000.00)
- Section 9(1) of ESTA provides that an occupier may be evicted only in terms of an order of court issued under this Act.
- Section 23(1) provides that it is an offence to evict an occupier, except on the authority of an order of a competent court. (Land owner commits an offence if he/she evicts an occupier without court order).

3. Role of the South African Police Service

BACK TO BASICS





- If ESTA, PIEA, LTA or the Rental Housing Act is applicable, the land owner must approach a court for an order of eviction.
- SAPS members may not assist land owners to "evict" or remove so-called "illegal occupiers".
- The occupier may not be removed from the land in question, unless it is as a result of a lawful arrest for an offence that warrants his or her arrest.

South African Police Service's Responsibility (2)



- Only a sheriff and persons authorised by a court to assist the sheriff may carry out an eviction order, provided that the sheriff must at all times be present during such eviction or actions authorised by the court (e.g. demolition and removal of buildings or structures), subject to the conditions as determined by the court.
- In situations where there is sufficient information to indicate that a sheriff and his or her employees may be exposed to injury, death or damage to property, members of the SAPS will be requested to assist the sheriff to perform law and order, as well as protection service.
- The sheriff may request assistance (protection) from the SAPS with the execution of a court order where that sheriff expects resistance
- <u>Members of the SAPS may not participate in the eviction, but must render protection to</u> <u>the sheriff and his or her staff.</u>
 - A person, who wilfully obstructs or interferes with the duties of a sheriff or his or her assistants in the performance of their duties, is guilty of an offence.



- The SAPS in partnership with the community, metropolitan police services and other agencies devise effective methods to promote public safety as well as reassuring the community that they are protected.
- To ensure this, the SAPS must play a pro-active role in attempting to identify and diffuse any possible conflict before it escalates to violence.
- This is done by communicating with the public, organisers and participants.
- The mandate of the SAPS, as set out in section 205(3) of the Constitution of the Republic of South Africa is, inter alia, to maintain public order, protect and secure the inhabitants of South Africa, to uphold and enforce the law and to prevent and investigate crime.
- Public Order Policing Units may in terms of National Instruction 4/2014 be deployed to combat serious and violent crime includes stabilizing outbreaks of public violence at incidents of (and the combating of) serious and violent crime and dealing with any occurrences of crowd gathering during the management of incidents to protect persons and property.



- The SAPS must ascertain whether any of the following offences had been committed (and if so, investigate such offence):
 - Common law offences: assault, murder, malicious damage to property, etc.;
 - Trespassing- Section 1(1) of the Trespassing Act;
 - Payment for orchestrating unlawful occupation- section 3 of PIEA;
 - Eviction of occupiers without a court order; &
 - Unlawfully lock out a tenant or to unlawfully shut off the utilities of the rental housing property.

 - The requirements of obtaining a court order to evict persons.
