## Introduction

Statistics South Africa (Stats SA) is a national government department accountable to the Minister in the Presidency: Planning, Monitoring and Evaluation.

Stats SA produces and disseminates statistics under two broad statistical programmes, namely Economic Statistics, and Population and Social Statistics. Both these programmes involve data collection through censuses, surveys and administrative data sources. The statistical programmes are supported by six clusters that provide:

- i) Survey operations services;
- ii) Leadership to the South African National Statistics System (SANSS);
- iii) Expertise on methodology and standards for official statistics;
- iv) Information, communication and technology services, including publishing services for the production and effective management of official statistics;
- v) Provincial support, stakeholder management services, corporate communication services and international relations; and
- vi) Financial and human resource services.

Stats SA has identified five strategic outcomes and related strategic objectives that will guide the organisation in achieving its vision and mission. Under each objective, outputs and targets were defined that will be monitored on a quarterly basis as required in terms of section 5.3 of the Treasury Regulations (The Accounting Officer must establish procedures for quarterly reporting to the executing authority, to facilitate effective performance monitoring, evaluation and corrective action).

## 1. Organisational performance overview

This document reports on the overall performance of the organisation against set targets and key projects in the Work Programme. Stats SA has 813 targets in the 2016/17 Work Programme, which align to its overall strategic direction. This report focuses on progress in the 4th quarter and comprises a narrative report that includes reporting against strategic objectives, a summary of organisational and cluster performance, an expenditure report, a report against strategic risks and the Estimates of National Expenditure. The DPME-prescribed Excel spreadsheet has been completed and forms part of the report.

Stats SA has achieved 87% of its annual targets as at 31 March 2017 of which 5% were achieved earlier than scheduled and 4% were achieved later than scheduled. 13% of targets were not achieved.

Stats SA's adjusted baseline allocation for 2016/17 is R2,538 billion. Of the allocated budget, 55,5% is for compensation of employees, 32,6% is for goods and services, 0,7% is for transfers, and 11,2% is for payment of capital assets. The departmental actual spending as at 31 March 2017 amounted to R2,461 billion, representing 97% of the adjusted baseline allocation. The available budget as at 31 March 2017 amounts to R76,903 million.

The Stats SA establishment consists of 3 511 posts, of which 3128 (89,0%) are filled, comprising 46,5% male and 53,4% female staff members. 87,0% of employees are black African, 6% white, 5,3% coloured and 1,7% Indian. Filled SMS posts constitute 59,4% males and 40,6% females. 1,2% of employees constitute staff members with disabilities. The vacancy rate as at 31 March 2017 was 10,9%.

# 2. Overview of organisational and programme performance against annual and quarterly targets

**Stats SA** has achieved 87% of its annual targets as at 31 March 2017 of which 5% were achieved earlier than scheduled and 4% were achieved later than scheduled; 13% of targets were not achieved.

**Programme 1:** The **Office of the SG** has achieved 86% of its annual targets as at 31 March 2017; 14% of targets were not achieved.

**Programme 1: Corporate Services** has achieved 62% of its annual targets as at 31 March 2017 of which 6% were achieved earlier than scheduled and 2% were achieved later than scheduled; 38% of targets were not achieved.

**Programme 1: SANSS** has achieved 75% of its annual targets as at 31 March 2017; 25% of targets were not achieved.

**Programme 2: Economic Statistics** has achieved 98% of its targets as at 31 March 2017 of which 2% were achieved earlier than scheduled; 2% of targets were not achieved.

**Programme 3: Population and Social Statistics** has achieved 77% of its targets as at 31 March 2017 of which 6% were achieved earlier than scheduled and 19% were achieved later than scheduled; 23% of targets were not achieved.

**Programme 4: Methodology, Standards and Research** has achieved 89% of its targets as at 31 March 2017 of which 2% were achieved earlier and 2% later than scheduled; 11% of targets were not achieved.

**Programme 5: Statistical Support and Informatics** has achieved 50% of its targets as at 31 March 2017; 50% of targets were not achieved.


**Programme 6: Statistical Collection and Outreach** has achieved 88% of its targets as at 31 March 2017 of which 8% were achieved earlier than scheduled and 4% were achieved later than scheduled; 12% of targets were not achieved.

**Programme 7: Survey Operations** has achieved 83% of its targets as at 31 March 2017 of which 3% were achieved earlier than scheduled and 27% were achieved later than scheduled; 17% of targets were not achieved.

## 3. Report against strategic outcomes

## 3.1 Strategic outcome 1: Informed nation

Informing the nation will be achieved by focusing on the following 3 strategic objectives:



## 3.1.1 Expand the statistical information base

## a) Economic dynamics

Published 4<sup>th</sup> quarter GDP estimates, a report on supply and use tables and a research report on reviewing and improving data sources in March as scheduled. Quarterly flash GDP estimates were compiled in February as scheduled.

#### The following integrative economics reports were compiled:

- Report on information and communication technology satellite account in March as scheduled;
- Report on input-output tables in March as scheduled; and
- Report on tourism satellite account scheduled for March published earlier than scheduled in December.

A discussion document on statistics of the non-profit sector in South Africa was compiled. The document was not published as a report as scheduled. The assessment on the quality of the data and processes used by the Department of Social Development was not finalised by SANSS and the required detail integrative account information from SARB was not available. The report will be discontinued.

#### The following research reports on improving national accounts statistics were compiled:

- Internal position papers on Research and Development satellite account and integrated economic accounts. The documents were not published as discussion documents as scheduled. The exercise that commenced in 2016/17 was a feasibility study to establish the possibility of publishing discussion documents. The study showed gaps in the required data sources and a decision was taken to publish the research results as internal position papers;
- An integrative report on factors affecting economic activities in March as scheduled; and
- A virtual system visualising the Growth Accounting Framework was developed in March.

#### Short-term indicators/periodic reports published as scheduled during the quarter included:

- 12 monthly releases on short-term indicators, including mining (production and sales), manufacturing (production and sales), generation and consumption of electricity, building plans passed and completed, retail trade sales, motor trade sales, wholesale trade sales, land transport, liquidations and insolvencies, civil cases for debt, food and beverages, and tourist accommodation;
- Quarterly release on manufacturing: utilisation of production capacity by large enterprises; and
- A periodic report on the 2015 mining industry survey.

Research to improve industry statistics which included the calculation of weights for deflators (Retail 2012) was done in Q3 and implemented in Q4.

An annual report on the Domestic Tourism Survey scheduled for June 2016, was published in March 2017 due to poor quality of printed questionnaires which resulted in delayed data processing. The biannual report on Domestic Tourism scheduled for December 2016, was subsequently delayed and will be published in May 2017.

A report on comparative analysis of Stats SA and South African Tourism's estimates scheduled for March 2017 was not completed due to delays with other tourism statistics deliverables. The report will be completed in May 2017.

Published three tourism and migration releases as scheduled. A quality self-assessment on international tourism statistics scheduled for March was not completed due to HR constraints. It will be done in 2017/18.

A research report on the NHTS pilot for digital data collection due in September was not compiled due to funding constraints. The target will be undertaken only if funding becomes available. A research report on providing technical support to improve the RMTC was compiled as scheduled.

Published quarterly release on the financial statistics of private sector enterprises in March as scheduled. Research reports on the proposed capital expenditure survey and engaging stakeholders on research initiatives were compiled in March as scheduled.

Published quarterly release on the financial statistics of municipalities in March as scheduled. Research reports on QSFM data at lower level and collaboration on data coordination were compiled earlier than scheduled in guarters 1 and 3.

## b) Price stability

- Published CPI and PPI for December, January and February as scheduled.
- A research report on the residential property price index due in March 2017 was not completed due to failure to obtain data from the Office of the Chief Registrar of Deeds. The target will be discontinued.
- A research report on Transport, Storage and Communication Services due in March 2017 was not completed due to human resource constraints. Resources were reprioritised for PPI reweighting and to further update the research report on Construction indices. Research will be done in 2017/18.

#### CPI re-weighting training journey

The new Consumer Price Index (CPI) weights were released in January 2017. The weights are based on the Living Conditions Survey (LCS) conducted during 2014/15. The LCS determines what households spend their money on and CPI uses this information to update the basket of goods and services that will be priced to produce the inflation figure. The first inflation figure calculated from the new weights, for January 2017, was released on 15 February, and it was 6,6%. Reweighting is done every 5 years. In addition to the new products that are introduced into the basket, some operational developments are also introduced in order to improve the quality of the data and the efficiency of the processes. Improvements include methodological changes and system changes.

Price Collection is the most important process in the survey value chain. Price collectors responsible for collecting CPI prices are based across the country in all nine provinces. They are the most important link in the CPI value chain as they have to initiate the new products that are in the reweighted basket. They started initiating these products in October 2016, conducting a parallel collection with the previous basket. In order to keep staff members updated with developments, training of CPI staff is organised for the months of February to April. The main objectives of the training is to present new weights and basket to staff, review the methodology and introduce the new desktop and mobile collection systems. (PIC)

## c) Employment, job creation and decent work

- The quarterly releases on Employment and Earnings and Average Monthly Earnings was not published as scheduled. The releases were postponed to 7 April to allow for linking of the historical series.
- Published results of the Quarterly Labour Force Survey in February as scheduled.
- A report on the Survey of Activities of Young People (SAYP) scheduled for June 2016 was completed later than scheduled in March due to editing and processing of data.
- A module on the Survey of Employers and Self-employed (SESE) scheduled for March 2017 was not completed as scheduled due to changes to questionnaire design from CAPI to PAPI. It will be completed in May 2017.

• A report on the school to work transition survey scheduled for June 2016 was not completed as scheduled due to HR constraints and editing and processing of data. It will be completed in July 2017.

#### Drought conditions leads to a decline in households engaged in Agricultural activities

The number of South African households engaged in agricultural activities decreased between 2011 and 2016. This was one of the key findings of a report on Agricultural Households released by Stats SA on 27 January. The report is based on findings from the 2016 Community Survey, which was conducted in March 2016. The report showed that there were 550 000 (19,1%) fewer agricultural households in 2016 (2,33 million) than in 2011 (2,88 million). This decline was mainly due to the drought experienced throughout the country during 2014 and 2015. Between 2011 and 2016 there was a decline of 6,6% in the proportion of South African households engaged in agriculture.

Published compendium on EEA indicators in March as scheduled.

## f) Living circumstances, service delivery and poverty

- A thematic report on Water and Sanitation was published earlier than scheduled in November due to reprioritisation of activities.
- Published report on service delivery based on CS 2016 data in March as scheduled.
- A statistical release on the poverty profile and expenditure patterns in South Africa scheduled for December was published later than scheduled in January due to the approval process.
- Methodologies for the generation of poverty estimates for small-area estimates was finalised. The report provides poverty levels at provincial level. The outcome of the research and inputs from technical experts suggested that further interrogation on small-area estimation techniques is necessary before releasing a poverty profile at lower levels of geography. A training workshop to equip officials with the skills for further analysis is scheduled for May 2017.

#### LCS profiles income and expenditure of South African citizens

On 27 January, the Statistician-General released the Living Conditions Survey (LCS) 2014/2015 data at a press briefing held at ISIbalo House in Tshwane. The LCS is a household-based sample survey conducted every five years countrywide over a twelve-month period. The survey aligns to the National Development Plan (NDP) and Sustainable Development Goals (SDGs) Agenda 2030. Living Conditions Survey data are used to profile poverty and inequality in South Africa. It also serves as an input in the reweighting of the Consumer Price Index (CPI) basket of goods and services, and informs the development, benchmarking and maintenance of household national accounts. There were a few challenges faced during the data collection phase, such as

a higher non-response rate, respondents that had difficulty estimating their dwelling units' value and respondent fatigue. Gauteng had the lowest response rate, followed by Western Cape. Provinces with the highest response rate were Limpopo, Eastern Cape and Mpumalanga.

## g) Population dynamics

- A discussion document on the assessment of data quality on emerging population and spatial issues scheduled for December 2016 was not completed due to the reprioritisation of activities. It will be completed in Q1 of 2017/18.
- A discussion document on CS 2016 data quality scheduled for September 2016 was not completed due to dependency on municipal boundaries data. It will be completed in Q1 of 2017/18.
- Compiled three scientific research papers on population statistics in March as scheduled.
- An annual release on mortality and causes of death scheduled for November was published in February due to delayed data processing and HR constraints.
- An annual release on marriages and divorces scheduled for February was not completed due to human resource constraints and the late acquisition of data from Department of Home Affairs. The report is undergoing internal quality assurance checks and will be published in Q1 of 2017/18. The dataset will be published thereafter.
- An annual report on documented immigrants (including asylum seekers) scheduled for July was not completed due to the late receipt of data from Home Affairs. It will be published in Q1 of 2017/18.
- A report on perinatal deaths scheduled for March was not completed. A decision was taken internally to conduct intensive quality assurance before publishing. The report will be published in Q1 of 2017/18.
- Published dataset on Mortality and causes of death was as scheduled.
- A CRVS strategic plan scheduled for October 2017 was not completed due to stakeholder consultation. Work will continue in 2017/18.
- Compiled research reports on alternative data sources for mortality and research outcomes on NPR in March as scheduled.
- Compiled two thematic reports based on the 2016 Community Survey data (Demographic Indicators and Adolescent Fertility). A need to conduct in-depth analysis based on some levels of indicators from the main Demographic indicator report was identified, which resulted in the compilation of the Adolescent thematic report.

## h) Gender and vulnerable group statistics

Reports on vulnerable group indicators and the elderly were completed in March as scheduled.

## i) Safety and security

- An annual statistical release on the Victims of Crime Survey scheduled for September was completed later than scheduled in February due to delayed data processing, the editing and imputation system and a decision to re-weight the data series using the municipal level estimates that are based on the 2016 population model.
- A thematic report on housebreaking/home robbery scheduled for March was not completed due to delayed VOCS release. It will be completed in Q1 of 2017/18.
- Compiled report on technical support to stakeholders in March as scheduled.

## j) Health

A thematic key indicators SADHS report scheduled for March was not completed due to delays in finalisation and weighting of the dataset. Weighting was concluded in March and the report will be published in Q1 of 2017/18.

#### k) Education

A thematic report on education scheduled for March was completed in February. Work was completed earlier than anticipated.

#### 3.1.2 Develop new and innovative statistical products and services

#### a) Integrative research and analysis

The following research reports were compiled:

- Report on specific aspects of selected municipalities scheduled for March was completed in December, due to improved methodological processes and research data and availability of data sources;
- The international move towards combining data from censuses, surveys and registers to derive more frequent population estimates at low geographic levels a South African perspective;
- Service delivery protests in SA municipalities;
- Developing a database of protests SA;
- Recommendations to increase the response rate of data collected by Statistics SA in the Pretoria region;
- The use of administrative/external data sources for the poverty and inequality statistics agenda scheduled for September was completed in March due to dependency on SARS for access to IRP5 data.

Two research reports on socioeconomic demographic and development issues were not compiled due to HR constraints. The targets will be discontinued.

#### 3.1.3 Revolutionise data systems

#### a) Data revolution

A data revolution framework and strategy were not compiled due to international developments relating to the UN World data forum. Work will continue in 2017/18.

#### UN World Data Forum

The inaugural United Nations World Data Forum (UNWDF) was held in Cape Town from 15 to 18 January 2017. It is at this forum that experts on global data meet to find ways to strike a balance between public good and privacy. The achievements of the forum included building a broad consensus on how to harness the power of data for sustainable development, and boost the collaboration and resources needed to carry the work forward. The singular focus was an attempt towards achieving standard measurement tools to monitor the Sustainable Development Goals (SDGs).

# 3.2 Strategic outcome 2: Trusted statistics

Trusted statistics will be achieved by focusing on the following 5 strategic objectives:



## 3.2.1 Institutionalise quality management

## a) Quality management

- Compiled proposal on a quality management system as scheduled.
- A CS 2016 evaluation report scheduled for March was compiled earlier than scheduled in July when the CS project was concluded.
- Compiled reports on monitoring and evaluation of DTS and QLFS as scheduled.

## 3.2.2 Innovate the statistics value chain for better efficiency

## a) Plan, design, build, collect, process and disseminate

- Provided methodological support to stakeholders as scheduled.
- Research initiatives to improve methodological practice and systems included the following:
  - o Implementation of small-area estimation (SAE);
    - o Conducting of comparative study to validate SAE for household surveys;
    - o Quality assessment of the Master Sample frame;
    - o Designing of methodologist capacity building programme; and
    - o Compiling of seasonal adjustment methodological notes for the land transport survey, liquidations and insolvencies and civil cases for debt.
- A report on collaboration and partnering in design of innovative data collection methodologies for census/surveys was not compiled as scheduled. Collaboration and partnering efforts have been amalgamated under the Transition Project (PAPI–CAPI). A position paper has been compiled to inform the innovative and integrative planning. The report will be concluded once the project has been completed.
- Compiled report on the maintenance of the Master Sample as scheduled.
- VOCS National training was conducted in March.
- Research initiatives to improve survey operations included:
  - o The development of a data collection strategy;
  - o The compilation of a report on collaboration and partnering in the design of a digital data collection system; and
  - o Implementation of a quality assurance tool.
- Data processing for the VOCS 2016/17 was not completed as scheduled due to slower questionnaire submission from the field. A total of 25 012 questionnaires were received. It is expected to be completed in Q1 of 2017/18.
- Data processing for the TUS has not commenced due to a delay in the commencement of the survey.
- A total of 5 623 PSUs were processed as at the end of March.

- A report on digital data collection piloted for household surveys scheduled for March 2017 was not compiled due to a scope change requested by the SG. The revised date of completion is January 2018.
- Compiled report on processing Community Survey data using new technology as scheduled.

#### Stats SA ready to move with the world of technology

"Stats SA will be moving away from using paper to gadgets when collecting data," said Deputy Director-General for Population and Social Statistics, Dr Kefiloe Masiteng, as she opened the Computer-Assisted Personal Interview (CAPI) Transition Project Integrated Planning Workshop. The workshop was held on 08 March 2017 at ISIbalo House in Tshwane. The objective of this workshop was for Stats SA staff members from Head Office and the nine provinces to work together in planning the transition from the Paper-Assisted Personal Interview (PAPI) to the Computer Assisted Personal Interview (CAPI) methodology.

It is envisaged that transitioning to digital data collection will broaden the width of statistical collection to enable the production of statistics at lower levels of geography to narrow the identifiable gaps (information, quality and skills) and inform debate, decision-making and research within government and by the wider community of researchers and experts. At the workshop, five task teams were formed, namely Methodology and Evaluation, Corporate Services, Field Operations, Content Development and Analysis, and Communication, Stakeholder Relations and Dissemination. Breakaway sessions were held for each task team to discuss their role in ensuring the successful transition from PAPI to CAPI by 01 January 2018. The task teams have been given time to refine and finalise their strategies and plans. A final feedback workshop will be conducted to inform the way forward after all the plans are consolidated and one final plan is put in place.

- Compiled 2 Mbalo Brief publications and 45 series were updated on the system.
- A research reports on a data repository was not compiled due to a change in the operating procedure. The target will be discontinued.
- Research on alternative data delivery channels was not done due to HR constraints. The target will be discontinued.

- Dissemination of CS 2016 products was completed as scheduled.
- The integration of survey data and geography for special needs of users was and the improvement of access to public data files was not done not done due to HR constraints. The targets will be discontinued.

## 3.2.3 Adopt international standards and classifications

#### a) Statistical standards development

The following standards were not developed as scheduled:

- International Classification of Activities for Time-Use Statistics (ICATUS) due to the endorsement of a new international version. The Standards Approval Committee recommended that a new profile be developed based on the latest international version. The project will continue in 2017/2018.
- International Classification of Crime for Statistical Purposes (ICCS): During the stakeholder consultation process, it was realised that ICCS is a complicated standard that requires participation of and consensus between internal and external stakeholders, in particular the Safety and Security cluster of government. Further consultation with external stakeholders has been scheduled. The project will continue in 2017/2018.
- International Classification of Status in Employment (ICSE): The standard went through the stages of consultation as per SDLC; however, the Standards Approval Committee (SAC), recommended that further consultation with key stakeholders be undertaken. The project will continue in 2017/2018.

The following standards were reviewed/developed as scheduled:

- Standard on measuring and reporting response rate;
- Standard on Master Sample maintenance;
- Standard on data confidentiality (v2);
- Standard on measuring and documenting sampling errors;
- Standard on statistical data collection; and
- Standard on the maintenance of the business frame.

The following initiatives to improve standards development were completed as scheduled:

- Standards awareness programme for provinces was implemented;
- Standards registry was compiled; and
- Priority standards in SANSS were identified.

## 3.2.4 Increase stakeholder focus, communication and marketing

#### a) Integrated communications and stakeholder management

A media coverage analysis for quarter 4 has been delayed due to HR constraints. It will be completed in April 2017.

Initiatives to improve corporate communications included the following:

- Report on the CS 2016 communications rollout campaign scheduled for September was completed in March;
- Communication product for municipalities;
- Report on user-friendly electronic products developed;
- Report on communication of relocation project; and
- Report on new communication channels and tools developed for employee engagement.

A knowledge management environment scheduled to be established in March was not done due to HR constraints. The target will be discontinued.

#### Taking statistical capacity to grassroots newsrooms

A media engagement workshop was held at ISIbalo House on 24 March 2017. The purpose of the workshop was to equip community media journalists with the knowledge and tools they can use to report more accurately about the communities they serve. The workshop, which is the second in a series of engagements intended to encourage the media to make use of Stats SA data, was attended by reporters from grassroots media outlets, Caxton Community Newspaper, the Midrand Reporter and the Tshwane Capital.

- A user satisfaction report scheduled for July 2016 was completed in March 2017 due to HR constraints.
- Monitoring of the usage of the CRM system was not done due to HR constraints.
- Institutionalising of integrated stakeholder management was not done due to HR constraints.

## 3.2.5 Designate statistics as official

A SASQAF quality statement for the QLFS was compiled as scheduled. The quality statement for the South African Protected Area Database (SAPAD) was not completed in March. The statement has to be presented to the Data Quality Assurance Team. Work will continue in 2017/18.

The following reports on improving independent quality assessments were compiled as scheduled:

- Practice guidelines and handbook published for independent assessments; and
- SASQAF roll-out strategy and plan for SA.

# 3.3 Strategic outcome 3: Partners in statistics

Partners in statistics will be achieved by focusing on the following 3 strategic objectives:



## 3.3.1 Strengthen collaboration to build statistical sampling frames

## a) Geospatial frame

- The Dwelling Frame 2016 was updated with 762 184 points in 64 municipalities, resulting in 8 246 092 points from the 2015 base of 7 483 908 points. This translates into a 10,18% growth in dwellings in the updated municipalities.
- Demarcation was done in Northern Cape and Free State. This involved the demarcation and merging of place names (PNs) and enumeration areas (EAs). In the Northern Cape, EAs grew by 5,46% from last year's baseline, while PNs grew by 1,82%. For Free State, EA baseline growth was 1,91% and PN growth was 5,72%.

Progress for the improvement of the Dwelling Frame was reported as follows:

- Publishing of the complete Dwelling Frame as scheduled.
- Maintenance and updating of EAs in Northern Cape and Free State. Northern Cape grew from 3 060 to 3 227 EAs and Free State from 6 439 to 6 562 EAs.
- A geospatial research report on the NDP goals was not compiled due to human resource and skills constraints. The target will be discontinued.
- The establishment of the Spatial Information Framework (SIF) maintenance and geostatistical analytics platforms was not done due to delays in the procurement of software through SITA. National Treasury granted permission to Stats SA on 15 February 2017 to procure using the internal process. Work will continue in 2017/18.

## b) Business Register

- The updating and maintenance of the Business Register was done with the completion of 99% of large business surveys. The target of 90% was exceeded due to increased productivity.
- A report on performance and quality indicators for the Business Register was compiled as scheduled.
- A final financial sampling frame was completed as scheduled.

The following documents on improving the Business Register were compiled as scheduled:

- Research paper on improving the functionality of the Business Sampling Frame;
- Report on revised business rules;
- Reviewed BSF quality management framework; and
- Business case for units' model.

# 3.3.2 Lead the development and coordination of the national statistical system in South Africa

## a) Economic and social statistics subsystems

- The National Strategy for the Development of Statistics (NSDS) was not compiled as scheduled due to the proposed legislative changes in the Statistics Act, which will inform the strategy. The target has been delayed until 2018/19.
- A clearance protocol was implemented on the South African Police Service: Clearance report on Crime Statistics.
- SASQAF Lite was applied to the SAPS Crime Statistics and the Department of Science and Technology Research and Development Survey.
- The development of the economic and social statistics subsystem strategies and plans is dependent on the NSDS. Work will continue once the NSDS has been finalised.

## b) Information management in the SANSS

Initiatives for improving information management in the SANSS included the following:

- Service Level Agreements on data sharing were signed with the SA Police Service and the Department of Social Development;
- Blueprint for a SANSS-wide data repository was developed;
- Report on expanding the use of the E-data transfer tool amongst SANSS members; and
- Report on expanding the use of a dissemination tool amongst SANSS members.

## c) Statistical reporting

• A report on SDG indicators was compiled as scheduled.

## d) Statistical support and advice

Support was provided to the following six departments as scheduled:

- Department of Environmental Affairs: Mapping report on South African Waste Information System (SAWIS);
- Road Traffic Management Corporation: Scanning report on Accident Report forms;
- Mpumalanga Department of Economic Development and Tourism: Field operation report (MEBS phase 2);
- Civilian Secretariat for Police Service: Technical support report on Census of Police Stations;
- Department of Energy: Mapping report on Energy Statistics; and
- Department of Justice and Constitutional Development: Mapping report on small claims court system.

Diagnostic assessments were conducted for the Departments of Justice and Constitutional Development Energy and Environmental Affairs.

A handbook on Diagnostic Assessments was compiled as scheduled.

# 3.3.3 Strengthen international collaboration and partnerships and lead statistical development in Africa

## a) International collaboration and partnerships

- An international statistical best practice benchmarking framework scheduled for June was compiled in March 2017 due to skills constraints.
- Guidelines for bilateral and multilateral collaboration scheduled for September was compiled in March 2017 due to resource constraints.
- A report on Stats SA's participation in international programmes was compiled as scheduled.
- A report on the implementation of a framework for the international programme was compiled as scheduled.

#### International Population Conference call for papers resoundingly answered

The International Population Conference (IPC) 2017 call for papers closed on 15 December 2016. The numbers show a high level of interest with over 4 400 paper and poster submissions being reviewed and considered for sessions at the conference. The countries with the most submissions were India and the United States, with South Africa and Nigeria coming in third. This is the first time the conference will be held in sub-Saharan Africa. When the delegates converge in Cape Town, South Africa from 29 October to 4 November 2017, it is encouraging to know that African countries will be well represented. This is a platform to bring regional and global issues to the forefront. The IPC covers 19 themes with Theme 9: Health, Mortality and Longevity receiving the highest number of submissions, followed by Theme 13: Migration and Urbanisation, and Theme 17: Sexuality and Reproductive Health. Almost 9 000 reviews are underway, with each submission being reviewed twice – once by the session convenor and once by the theme convenor. Session convenors are now finalising their programmes. The programme for the conference will be announced in April, and authors will be notified if their paper or poster has been accepted at that time. Conference registration opens on 15 April 2017.

#### The 48<sup>th</sup> session of the United Nations Statistical Commission

The United Nations Statistical Commission (UNSC), established in 1947, celebrated its 70th anniversary at its 48<sup>th</sup> session which was held from 7 to 10 March at the United Nations Headquarters in New York. The theme for the session was, *"Celebrating 70 years of global statistics"*. The SG was invited to speak at the opening session.

The UNSC is the highest decision-making body for international statistical activities, especially the setting of the UNSC statistical standards, the development of concepts and methods, and their implementation at national and international levels. The SG, together with Ms Aija Zigure, President of the Central Statistics Bureau of Latvia, gave commemorative statements at the 70th anniversary celebrations.

The first report that was discussed at the Commission was the report of the Inter-Agency Expert Group for SDG indicators where the commission was invited to express its views and adopt the revised global indicator framework for the goals and targets of the 2030 Agenda for Sustainable Development, including some refinements. Subsequently, the global indicator framework was adopted and it was agreed upon by the United Nations Statistical Commission at its 48th session as a voluntary and country-led instrument.

The second report on Sustainable Development Goals was a Report of the High-Level Group for Partnership, Coordination and Capacity-Building for Statistics for the 2030 Agenda for Sustainable Development, of which South Africa is a member.

Other topics dealt with at the UNSC included reports on national accounts, system of environmental economic accounting, geospatial information, quality assurance in a global statistics system including a revival of a working group on a generic quality assessment framework which South Africa volunteered for and a report on social statistics which included the time use classification as well as a report on the international comparison programme. Decisions were taken on these topics and will be made available on the UNSD website.



#### Dr Tamer Tandogan visits Stats SA

From 27 February to 3 March 2017, Stats SA hosted Dr Tamer Tandogan, a consultant from an international group of consultants commissioned by the African Development Bank. The purpose of the visit was to undertake a baseline study on industrial statistics compilation capacities in the tripartite member/partners states, as well as support the formulation of industrial statistics strategies, roadmaps and capacity building programmes. South Africa is one of the 16 countries selected to be part of the study. His mission was commissioned by the Common Market for Eastern and Southern Africa (COMESA) Secretariat on behalf of the Tripartite Free Trade Area comprising COMESA, the East African Community (EAC) and SADC. The assignment was taken within the framework of the African Development Bank support on the Tripartite Capacity Building Programme for the tripartite member partner states. He visited South Africa after a similar visit to Statistics Botswana, followed by a visit to the Lesotho Statistics

Office. The study focused mainly on industrial statistics areas and the statistical Business Register, coupled with quality, survey methodology, training, planning, budgeting and other economic statistics topics.

## b) Statistical development in Africa

- An African peer support framework scheduled for June was compiled in March 2017 due to HR constraints.
- A report on Stats SA's support in establishing African Centres of Operational Excellence scheduled for December was compiled in March 2017 due to HR constraints.
- Compiled report on the 12<sup>th</sup> Africa Symposium on Statistical Development (ASSD) as scheduled.
- Compiled report on Stats SA's support in the evaluation of the APAI-CRVS programme as scheduled.

#### Delegation from Mozambique

A delegation of four from the Mozambique Institute of National Statistics visited Stats SA from 20 to 22 February 2017. Dr Beto Cordeiro, Director of the Institute, led the delegation. The institute was opened in 2008 with the aim of building statistical capacity in the country. The purpose of their visit was to gather experience and knowledge on how to produce relevant statistics at small-area level and how to strengthen their National Statistical System, and to obtain information about Stats SA's training offerings. Presentations included Stats SA'S training model, Dissemination of National Statistics, Project Management, Document Management and the South African Statistical Quality Assurance Framework (SASQAF).



#### Enhancing Vital Statistics in Namibia

A delegation of five, led by Ms Liina Kafidi from the Namibia Statistics Agency (NSA), visited Stats SA from 15 to 17 February 2017. The purpose of the visit was to familiarise our Namibian counterparts with the South African systems of recording and coding causes of death and the implementation of ICD-10 coding in general. ICD-10 is the 10<sup>th</sup> revision of the International Statistical Classification of Diseases and Related Health Problems, as published by the World Health Organization.

Stats SA has a Memorandum of Understanding with the NSA to collaborate and advance common goals in the areas of skills and capacity development, statistical production (including data management and dissemination), coordination of national statistics systems, strategy formulation and implementation in enhancing the profession of statistics, and the exchange of experts who will critically look at each other's National Statistical Systems (NSS) and make appropriate recommendations to ensure SADC countries plan and use timely and evidence-based statistics and data.

Namibia is in the process of improving causes of death statistics and is moving from ICD-9 to ICD-10. An understanding of ICD-10 coding informed the visit, allowing Stats SA to share experiences and lessons learnt during implementation. A team of two from Stats SA went to Namibia to conduct ICD-10 training to ensure a seamless migration and assist with enhancing the production of vital statistics in the country.

#### Stats SA hosts Somali delegates

On 15 March 2017, Stats SA welcomed a delegation of three Consumer Price Index experts from Somalia. The delegation comprised Mr Mohammed Noor as head of the delegation and Mr Abdulkadr Dahr Ahmed (both from the Ministry of Planning and International Cooperation in the Federal Government of Somalia) and Mr Hassan Ahmed Aidid from the Ministry of Planning and International Cooperation in Puntland State.

The visit stems from previous visits made to Stats SA to collaborate on statistical matters and on statistical development assistance to be given to Somalia as a country emerging from conflict, and one of the countries which could not participate in the 2010 Round of Population and Housing Censuses. In 2014 Somali, delegates with a representative from Statistics Sweden visited South Africa to gain insights into the management and organisation of a national statistics office as well as statistical production overall.

This visit culminated in an expression of interest to formalise the collaboration between the two national statistics offices into a Memorandum of Understanding (MoU). The Consumer Price Index (CPI) and Gross Domestic Product (GDP) were identified as priority training areas. The delegation is the first of four delegations to be hosted between March and July for on-the-job training on CPI and GDP.

#### SUT in the Midst of System of National Accounts 2008 Implementation

There has been increased demand for the implementation of the System of National Accounts 2008, especially the Supply and Use Tables as a tool for benchmarking the production and use side estimates and to compare and contrast data from various sources and improve the coherence of the economic information system. It was on this basis that the Southern African Customs Union (SACU) in collaboration with Stats SA, organised a two-day workshop on Supply and Use Tables (SUT) from 27 to 28 March 2017 at ISIbalo House, Pretoria. The workshop brought together national accounts experts from all SACU member states, i.e. Botswana, Lesotho, Namibia, South Africa, and Swaziland. South Africa chaired the workshop.

The objective of the workshop was to broaden the member states' knowledge of the SUT framework, and for South Africa to share her practical experience in the development of the SUT. The workshop also focused on the conceptual structure and composite elements of the tables. All these long term measures aim at the development of the SUT, implementation of a system of national accounts 2008, and adoption of more recent base years by all member countries towards harmonising Gross Domestic Product (GDP) compilation amongst member states. The workshop will also assist member countries to develop their indicative work plans.

Member states unanimously agreed that the two-day interactions whetted their appetite and suggested that a follow-up workshop for a five-day period be considered, where they can zoom into the SUTs from elementary level to complex implementation. The study tours were also identified as another mode of learning whereby countries would be taken through discussions and practical work in the technical areas concerned.

#### Visit by Zambia Ministry of Labour and Social Security and Ministry of National Development Planning

On 29 March 2017, a delegation of ten from the Ministry of Labour and Social Security and National Development Planning of Zambia visited Stats SA to learn about the state of labour market and information systems in terms of data collection, analysis, and dissemination and coordination practices in the country.

The one-day meeting formed part of the delegation's week-long visit planned with the Department of Labour and other organisations in South Africa regarding labour. In their objective statement regarding their visit, the delegation mentioned that Stats SA was identified for this visit, which was also informed by the Memorandum of Understanding that exists between Zambia and South Africa.

# 3.4 Strategic outcome 4: A capable organisation

In becoming a capable organisation, the organisation will focus on the following 5 strategic objectives:



## 3.4.1 Drive legislative reform

Three legislative reform documents for the SANSS were not compiled in March as scheduled. Work will continue in 2017/18:

- Consultation with international statistical agencies on the draft amendment bill is in progress. Work will continue in 2017/18.
- The compilation of draft statistics regulations to roll out the Stats Act is dependent on the draft amendment bill. It is expected to be finalised in March 2019.
- A strategy to rollout the new legislation is dependent on the draft amendment bill and regulations. It is expected to be finalised in March 2019.

## 3.4.2 Enhance corporate governance and administration

## a) Strategic planning, reporting and monitoring

The following planning, reporting and monitoring documents were compiled as scheduled:

- The 2017/18 Work Programme was tabled in Parliament in March 2017;
- An evaluation framework for Stats SA has been developed based on the national evaluation framework; and
- A report on the Strategy in Action programme was compiled in March 2017 outlining the strategic communication initiatives rolled out in the organisation through REATA.

## b) Programme and project management

- Monthly management reports were compiled as scheduled;
- Eight clusters were supported and empowered in operational planning and reporting;
- Seven projects were supported during the quarter (CS 2016, SADHS, MPAT, 28<sup>th</sup> International Population Conference (IPC) of IUSSP 2017, National Citizen Satisfaction Survey 2016, Transition from PAPI to CAPI, and the Stats SA Business Management Continuity Project; and
- The management information repository was enhanced as scheduled. Training was conducted and the system will be rolled out and implemented during April and May 2017 for the 2017/2018 financial year.

## c) Internal audit services

• Twenty audits were conducted during the 4<sup>th</sup> quarter.

Reports to improve internal audit services included:

- A quality assurance framework which was approved by the Audit Committee;
- A report on the CS 2016 audit conducted; and
- A combined assurance framework which was approved by the Audit Committee.

A report on external quality assurance was not compiled. The quality assurance will be done in 2017/18.

## d) Governance, risk and compliance

A Corporate Governance report for Q3 2016/17 was tabled at the RMSC in January, the Chief Director's Forum and Exco in February and the Audit Committee in March 2017.

Improvement initiatives for corporate governance included the following:

- A review of the Compliance Plan;
- A review of the Governance Programme; and
- A report on strengthening the risk identification and assessment process.

#### e) Financial administration and management

• 78% of goods and services were procured from black-owned institutions for the period April 2016 – March 2017. The achieved target deviates from the planned target by 3% due to efforts in place to ensure that goods and services are procured from adequately certified BEE suppliers.

Initiatives to improve financial management and administration included the following:

- A report on asset disposal; and
- A report detailing payments to CS 2016 fieldworkers was compiled earlier than scheduled after the closure of the project.

The testing of an audit progress monitoring system was not done as scheduled. The business case was approved by the Business Modernisation Technical Committee. However it was indicated that this will be a replica of another system developed for strategic management which is still in the development phase. Once that system has been commissioned, the same system will be customised for the APM solution needs.

#### f) Human resource management systems

- 82 posts were advertised in 2016/17 financial year and 66 (75%) were filled within 12 months (as per Public Service Regulations).
- The vacancy rate as at 31 March was 10,9%. Due to budget cuts, recruitment has been suspended.
- 94% of performance contracts (2016/17) were signed as at 31 March 2017.
- 99,6% of performance evaluations (2015/16) were submitted as at 31 March 2017.
- 83% of grievance cases were addressed within 30 days.
- 77% of disciplinary cases were addressed within 30 days. The target of 80% was not achieved due to the unavailability of witnesses and other relevant parties.
- The implementation of revised standard operating procedures and management controls was not completed.
- An E-recruitment system for contract applications was developed in 2015/16 and has been implemented.
- The placement of staff affected by the relocation was finalised in the 2<sup>nd</sup> quarter.
- A report on providing HRM support to CS 2016 was not compiled.

#### g) Safe and enabling work environment

- Security and compliance appraisals and OHSA were conducted in the Northern Cape and Western Cape offices.
- Records management and registry services were implemented in Q2.
- The implementation of a security classification system was not completed. Guidelines were compiled and submitted to the State Security Agency (SSA). Implementation will commence once approval is obtained.
- A post-relocation programme was rolled out as scheduled.
- A report on logistical services provided to CS was completed in Q2.

## 3.4.3 Become the employer of choice

#### a) Talent management and employee wellness

The development of a scarce skills matrix and strategy and generic career pathways and a report on the pool of talent were not done as scheduled due to human resource constraints.

#### Fitness Programme at ISIbalo House

The Stats SA Fitness Programme is a workplace-based programme designed to create an environment for employees to get active and realise the benefits of their efforts, while engaging with, competing against and motivating each other in the workplace. The programme is conducted in collaboration with the Government Employees Medical Scheme (GEMS) as the sponsor. The programme aims to decrease obesity and non-activity, assist weight management and reduce clinical risks, thereby achieving improved wellness and beneficial lifestyle choices for employees.

#### 3.4.4 Invest in ICT to align to organisational growth

#### a) Server network environment, end-user support, ICT security and risk management

The ICT environment was under review. Targets for 2016/17 were not achieved as scheduled and will be discontinued.

The revised strategic focus and priorities for 2016/17 was the building of a new data centre at the new premises and the development of a disaster recovery infrastructure. The targets were achieved as planned.

#### b) Modernise and innovate business processes

- 100% of IT solutions were developed on time.
- Documents on innovation of business processes included a business modernisation and a test automation strategy and a business case for the test automation tool.

## 3.5 Strategic outcome 5: Statistical leadership

To achieve statistical leadership as an end state, the focus will be on the following 3 strategic objectives:



## 3.5.1 Invest in statistical leadership and management

## a) Statistical leadership and management

The expansion of CRUISE participation to the municipalities was not done. The target will be discontinued due to HR constraints.

A statistical leadership and management programme was developed as scheduled.

One of Stats SA's priorities is to ensure that all employees are equipped with the right skills and knowledge to meet the long-term goals of the organisation. Stats SA celebrated the achievements of eleven CRUISE (Centre for Regional and Urban Innovation Statistical Exploration) graduates who were awarded Master's Degrees in MPhil: Urban and Regional Science by the University of Stellenbosch at a graduation ceremony held on 15 March 2017. The 2016 CRUISE was founded in 2009 in a collaboration between Statistics South Africa and the Department of Geography and Environmental Studies at the University of Stellenbosch.

#### 3.5.2 Invest in building statistical capability and competence

#### a) Statistical capability at tertiary level

- 19 bursaries were awarded to learners at local universities.
- Course content and curriculum of tertiary partners was not assessed as scheduled.

#### Stats SA hosts career development workshop

On 17 March 2017, Stats SA hosted Grade 12 Economics learners from Ruabohlale Secondary School in Soshanguve for a one-day career development workshop held at ISIbalo House. This workshop is one of Stats SA's many Corporate Social Investment (CSI) programmes initiated to address the low output of statistics qualifications produced by universities in South Africa. Learners displayed interest as they were taken through a series of presentations that included the calculations of economics statistics such as the GDP and the CPI. Learners were also given an opportunity to explore career paths within economics statistics that they could venture into, as well as the skills and qualification requirements. The learners were enthusiastically involved and engaged with subject experts throughout the workshop.



# ISIbalo Young African Statisticians shine at the 4<sup>th</sup> African International Conference on Statistics (AIC)

The 4<sup>th</sup> African International Conference on Statistics took place in Polokwane at the Protea Ranch Resort, from 20 to 23 March 2017, hosted by the University of Limpopo in collaboration with the University of Maryland, Baltimore, based in the United States. The theme of this prestigious conference was New Methods of Data Analysis and Statistical Applications to Big Data. In line with the mandatory pillars of the ISIbalo Programme as well as ensuring that young statisticians are retained, particularly in Africa, ISIbalo Young African Statisticians were there to showcase their work by presenting posters of their research papers.

A special poster session was sponsored by the SAS Institute and Professor Sinha, who is the Chair of the International Organising Committee for the conference. The judging panel consisted of local and international professors with distinct expertise in statistical research, and their criteria were best reporting, best use and application to Big Data, as well as best visuals. The winners were announced at a Gala Dinner. In third place was Zimbabwean PhD candidate at the University of Cape Town, Sean Thulani Sithole, on Zimbabwean Youth Migration and Food Security Nexus. In second place was a Young Statistician from Stats SA's Bloemfontein office, Ntebogeng Madlopha on Factors associated with divorce in South Africa. The SAS Award for Best Research Poster went to one of our own, Mr Jimmy Khosa, who works at the Limpopo Provincial Office in Polokwane. He indeed made Limpopo proud with his poster on Spatio-Temporal Analysis of Adolescent Fertility Rates in South Africa.



## b) Building capacity inside Stats SA

- The appointment of 100 interns by January 2017 was not concluded due to internal processes. Interviews are in progress and are expected to be finalised in Q1 of 2017/18.
- 1 390 staff members were trained during the year.
- 272 bursaries were awarded to employees for 2017 academic year.
- 6 bursaries were awarded for foreign study.
- The enrolment of 30 students in the 1-year Certificate in Official Statistics was not achieved due to HR constraints.
- The development and rolling out of a re-skilling programme was not achieved due to HR constraints.
- A report on training support provided to CS was compiled.
- The alignment of training materials with unit standards for accreditation and an assessment of the Elearning programme was not done due to HR constraints.

## 3.5.3 Build a united and diverse organisation

## a) Transformation and change

Documents on transformation and change developed in Q4 included a values programme and a diversity programme. An assessment report on talent management was not compiled due to HR constraints. The target will be discontinued.

# 3.6 Provincial and district offices: Sustainable and responsive statistical infrastructure

#### a) Trusted statistics: Plan, design, build, collect, process and disseminate

- Continuous Data Collection for household surveys is in progress for the QLFS, GHS, DTS and VOCS. Average response rates reported were over 90%.
- 5 stakeholder workshops were conducted during the quarter.
- 16 fact sheets were produced during Q4.
- Dissemination of CS 2016 results was done in all provinces and reports on dissemination activities were compiled.
- Quality improvements to surveys were implemented in 8 provinces. Mpumalanga experienced HR challenges. Mpumalanga has quality guidelines that were developed during 14/15 and these are the bases for implementation of quality improvements by Provincial Quality Monitors and District Survey Coordinators in the districts in Mpumalanga and the implementation of this is ongoing. The target will be discontinued.
- Communications, advocacy and publicity plans were implemented in 8 provinces. The plan is being finalised in Gauteng.

Stats SA Northern Cape Office held a stakeholder workshop in Kimberley on 22 February 2017. The theme of the workshop was, "statistics for all, leaving no one behind", and was a showcase of Stats SA's products and services available to stakeholders. Attendees included delegates from all spheres of government in the province. Presentations included SDGs, IDP analysis, SuperCross and the non-financial statistics of municipalities.

Stats SA Eastern Cape Office exhibited at the Working World Exhibition, organised by Inkanyezi Events and hosted at the Nelson Mandela Stadium in Port Elizabeth from 28 February to 03 March 2017. The exhibition attracted more than 100 exhibitors from all parts of the province including the private sector, business, government departments, universities, public entities, parastatals, NGOs, and FET and TVET colleges. Approximately 10 000 students from various schools in the Nelson Mandela Bay Metro and Sara Baartman District Municipality attended the event.

A stakeholder information sharing session was held on Friday, 17 March 2017 at the llembe District Office in KZN to share information with key stakeholders. The workshop was attended by representatives of governmental and non-governmental organisations around Stanger. Attendees included chief planners in llembe District who are members of the District Task Team (DTT) and Operation Sukuma Sakhe (OSS), a flagship project of the Office of the Premier (OtP) previously known as the War on Poverty Project. The purpose of the workshop was to deliberate on the Sustainable Development Goals (SDGs) and how they were linked with the Integrated Development Plans (IDPs).

#### b) Partners in statistics

#### Geospatial frame

The updating of municipalities for the maintenance of the geospatial frame was done in 8 provinces. In Eastern Cape, the target was not achieved due to reprioritisation of activities.

#### Statistical coordination

- Partnerships with organs of state on the SIF were established in Northern Cape, Limpopo and Western Cape. The target was not achieved in 6 provinces due to HR constraints, delayed signing processes and stakeholder consultation. Work will continue in 2017/18.
- Statistical support was provided to SANSS partners in Eastern Cape, Free State, KZN, Northern Cape, Mpumalanga, North West and Western Cape. There were no requests for support in Gauteng and Limpopo.
- A data holding inventory was conducted in Free State. The target was not achieved in Mpumalanga due to HR constraints and will be discontinued.
- The establishment of provincial statistical coordination structures was achieved in KZN, Northern Cape, Limpopo and Western Cape. The target was not achieved in other provinces due to HR constraints and the absence of guidelines from HO. The target will be discontinued.

- The assessment of statistical capability and infrastructure for one organ of state was completed in 7 provinces. The target was not achieved in Eastern Cape and Mpumalanga due to the absence of guidelines from HO and HR constraints. The target will be discontinued.
- The mining of data sources was done in Northern Cape and Western Cape. The target was not achieved in 5 provinces due to HR constraints and lack of support from HO. The target will be discontinued.

#### SG hands over the Eastern Cape IDZ Report

The Eastern Cape Provincial Cabinet, including prominent stakeholders from business and civil society, gathered at the East London Industrial Development Zone (ELIDZ) to debate the 'provincial budget' and for the official release of the ELIDZ census results conducted by Stats SA during the 2015/16 financial year. The breakfast gathering took place in East London, Eastern Cape, on 3 March 2017 when the SG, joined his National Treasury counterpart, Lungisa Fuzile as well as Industrial Development Corporation Eastern Cape Regional Manager, Kingsley Dell-Robertson, to reflect on some of the pertinent issues of the province.

Presenting the East London Industrial Development Zone (ELIDZ) Report, the SG reported income at the industrial zone had grown threefold from R2 billion in 2013 to R7 billion in 2015. He attributed the huge growth to the increase in capital expenditure by companies operating in the industrial zone. As early as 2013, the ELIDZ approached Stats SA to conduct a 'census' on financial information, ratio of exports and imports as well as level of employment at ELIDZ. Since then, ELIDZ has worked closely with Stats SA to monitor the economic growth.



## c) Capable organisation

- Audit recommendations were implemented in the provinces.
- A proposal on statistical regions was not compiled by Gauteng as scheduled. The target was not a part of the province's strategy and will be discontinued.

## d) Statistical leadership: Building statistical capacity in the SANSS

11 SuperCross training sessions and one Math4Stats workshop were conducted in the provinces in Q4.


