REQUEST FOR DECLASSIFICATION OF CLASSIFIED DOCUMENTS: SILVERTON CAS 155-07-2011 (FRAUD, THEFT AND/OR CORRUPTION) AND LYTTELTON CAS 432-11-2011 (FRAUD, THEFT AND/OR CORRUPTION) IN TERMS OF SECTION 29(2)(c) AND 24(3) OF IPID ACT 1 OF 2011.

#### 1. INTRODUCTION

The independent Police Investigative Directorate and the Inspector Genearl of Intelligence are conducting joint investigations on the above matters. Members of the DPCI who were involved in the initial investigation have been roped into the joint investigation.

#### 2. BACKGROUND

- 2.1 The request for the declassification of certain classified documents flows from the abovementioned investigation.
- The documents in question were allegedly created to facilitate the committing of offences and presented facts to internal auditors and the Auditor General which were not accurate. Had the South African Police Service's and the Auditor General knew the true nature of the expenditure they would have been able to identify the offences.
- 2.3 The documents in question will also not endanger any current or past project and/or agents and only relates to the actual procurement of certain items apart from the agents specifically refer to below. The declassification of the said documents might have a small financial effect as it would mean the two (2) vehicles in question will not be suitable for covert work. The vehicles can however be utilised in any other capacity.

- 2.4 It is clear from the breakdown below that the classified documents mentioned indicate alleged personal gain to the accused via the secret service account. As such no current and/or past project could be compromised.
- 2.5 It is also recommended that these documents be declassified in light thereof that the accused who were employees of Crime intelligence do not use that fact as a ground for the dismissal of some of the charges against them.
- In determining your assessment we need to stress that the reclassification of documents in terms of the Minimum Information Security Standard (Miss) document lays down a minimum standard for the handling of classified information in all government institutions, which states that security measures are not to be applied to cover up maladministration, corruption, criminal actions, or to protect individuals/officials involved in such cases.
- 2.7 To put the above-mentioned request into context it is important to state that the National Prosecuting Authority (NPA) have instituted criminal charges with respect to the following events that relates directly to CI:
  - The trade-in by Lieutenant General RN Mdluli ("Mdluli") on 2010-05-31 of his personal vehicle, a 2009 BMW 730 D with registration number XWT 151 GP, for a 2010 BMW 330d Sedan with engine number 21537366 and a 2010 BMW 530d Sedan with engine number 23567507, in order to generate a discount to finance a shortfall on his finance contract with BMW finance, South Africa in the amount of R90 526.01
  - A trip to Singapore undertaken by Lieutenant General RN Mdiuli from 2009-10-09 to 2009-10-16 where some of the expenses incurred were paid from the secret service account
  - A trip to China undertaken by Lieutenant General RN Mdluli and VL Mdluli between 2009-11-06 and 2009-11-14
  - A trip to Singapore undertaken by Lieutenant General RN Mdluli, Major General Lazarus, Colonel Barnard, Inspector G Mahwayi, Teresa Lyons, DG Naidoo and M Venter from 2009-11-21 to 2009-11-28
  - Rental of SR 563692 and SR 572047

SUBJECT: INVESTIGATION OF CORRUPTION AGAINST LT GENERAL PHAHLANE AND SERVICE PROVIDER, KEATH KEATING OF FDA

#### 1. INTRODUCTION

- 1.1 In the course of investigation of General Phahlane's corrupt relationship with the service provider Kriminalistik and Crimetech, the IPID investigation was able to uncover a further corrupt relationship with another service provider. FDA, owned by Mr Keith Keating. The investigation has detected possible crimes of Corruption, Fraud and money Laundering facilitated by car dealer, Mr Durand Snyman. The following allegations are at the centre of the investigation of Sinoville Cas 146/05/2017.
  - 1.1.1. General Phahlane and his wife Brigadier B Phahlane received vehicles alleged to be sponsorship by a Businessman Durand Snyman, a benefit which was neither due nor declared.
  - 1.1.2. Ms Josephine Phahlane, (General Phahlane 's sister) received a benefit of a vehicle which was allegedly purchased by Durand Snyman and delivered to her at Siyabuswa, a benefit which was not due to her.
  - 1.1.3. The vehicles that Durand Snyman gave to General Phahlane, Brigadier Phahlane, his sister Josephine Phahlane and Col Potgieter were purchased under a fictitious name of John Doe.

- 1.1.4. Keith Keating, SAPS Service Provider allegedly paid money into Durant Snyman's account which was used for the payment of the vehicles that General Phahlane, Brigadier Phahlane Josephine Phahlane and Col Potgieter benefited from unduly. These are the vehicles that are alleged to be sponsored.
- 1.1.5. Keith Keating, the Director of FDA has a contract with SAPS for the supply and maintenance of Roffin lights alleged to be worth approximately one billion rand. He also has contracts with TMS which is headed by General Phahlane's wife, Brigadier Phahlane. Our investigation has revealed that since 2010 Keith Keating Company FDA has been paid over 5 billion rand by SAPS (see Annexure A).
- 1.1.6. We also uncovered some suspicious transactions in favour of FDA, where for an example from issuing of an order to delivery and payment only took three days (see annexure 8).
- 1.1.7. The worst case was detected in the supply of 169 Forensic Light Sources by FDA. An order was generated on 2016/03/31 at 16h57 for an amount of R52 942 653.66 (see annexure C1). The invoice number INV16131 was submitted by the FDA on 2016/03/31(see annexure C2). The payment of R52 942 653.66 in favour of FDA was authorised and effected on 2016/03/31 under responsibility code 0075 TMS, the same in which Brigadier Phahlane(General Phahlane's wife) and Col Potgieter are based (see annexure C3). This transaction happened on the last day of the financial year 2015/2016, which clearly demonstrates corruption through fiscal dumping. The sequence of events may be construed to indicate that at the time when the order was issued, FDA was at the door with invoice and 169 Forensic Light Sources and different role players within SAPS (SCM and Management) were lined up for recommendation and approvals. This level of efficiency can only spell out one thing, "corruption". This is but one example; there are multitudes of similar transaction of "efficiency" involving FDA.

#### 2. INVESTIGATION HIGHLIGHTS

During the investigation, IPID uncovered that on 7/12/2015, a Toyota Hilux 3.0 4x4 single cab bakkie with registration number FB 21 DT GP was purchased from Naboom Toyota by an employee of InspectaCar, Hestie Groenewald. The vehicle was delivered to InspectaCar and paid for by InspectaCar, but processed in her name because car dealers are not allowed to sell vehicles to second hand dealers. The purchase price was R 377 360.22. The transaction was authorised by Snyman and recorded against Snyman's loan account with InspectaCar. The vehicle was given to Lt General Phahlane and insured it in his name on 15/12/2015. On 06 /01/2016 the vehicle was registered in Phahlane's name.

- 2.2 On 15/2/2016, VW Polo with registration number FC 98 TG GP was registered in the name of Brigadier Phahlane. The vehicle was insured by General Phahlane with effect from 19/2/2016. This vehicle was purchased by Snyman (acting in his personal capacity) from Bidvest McCarthy Volkswagen Wonderboom (VW Wonderboom) during January 2016. The purchase price was R 230 681.70. A salesperson at VW Wonderboom stated that, at Snyman's request, the vehicle was not to be registered to him or to his dealership, but was to be delivered to him with all the necessary manufacturer documents to enable him to register the vehicle on the NaTIS.
- 2.3 On 22/01/2016 Durand Snyman bought Hyundai i20 for an amount of R229 000.00. The Administrative assistant employed by InspectaCar stated that during January 2016, she was instructed by Ms Smith to invoice the vehicles, a VW Polo and Hyundai i20 under a fictitious name of 'John Doe'. Smith later asked for the files, and said that she had to make them "disappear".
- 2.4 She was instructed by Snyman to invoice the vehicles so that they could not reflect as stock, telling her that it was necessary because the vehicles were to be provided as sponsorships. He did not provide the details of the persons to whom the vehicles should be invoiced to. The invoice system required particulars of the parties to whom the vehicles were invoiced, and Smith had them invoiced under a fictitious name of 'John Doe'. She also inserted a false name for the salesperson involved. Payment was made to VW Wonderboom from InspectaCar's account on 13/01/2016 for an amount of R 230 681.70. The vehicle was not branded with InspectaCar's name or contact details.
- 2.5 During investigation it was further established that Durand Snyman gave General Phahlane's Sister, Josephine Phahlane a King Cab Ford Ranger which he purchased from Seising Motors in Mosselbay in March 2017. The total cost of the vehicle was R275 000.00.
- 2.6 Snyman provided an affidavit to the IPID dated 17 January 2017 in which he explained the sponsorship of the vehicles. He provided a supplementary statement thereafter, dated 3 February 2017, in which he explained that his relationship with General Phahlane was not corrupt.
- 2.7 The Independent Police Investigative Directorate uncovered that Durand Snyman did not give the vehicles to General Phahlane, Brigadier Phahlane, Josephine Phahlane and Col Potgieter as Sponsorship but that they were financed by Keith Keating the owner of FDA. Col Potgieter is based at TMS under the command of Brigadier Phahlane (Phahlane's wife).
- 2.8 On 13/01/2016 Keith Keating deposited an amount of R809 000.00 and on 04/03/2016 deposited an amount of R275 000.00 into Durand Snyman account via Namibian Bank 'Bank Windhoek" (see

annexure D). The total amount deposited by Keith Keating into Durand Snyman account is R1084 000.00 and the total cost of the vehicles alleged to be sponsorship is R1082 041.90

2.9 Payments of these vehicles by Durand Snyman where done shortly after Keith Keating deposited money into his Windhoek bank account. Forexample, on 13/01/2016 Keith Keating deposited R809 000.00 into Durand Snyman account and on 14/01/2016 the later transferred R230 681.70 to Mccarthy VW for a VW Polo, the same one which was given to Brigadler Phahlane as a sponsor.

2.10 IPID is in the process of conducting an in-depth investigation into the contracts and payments made to Keith Keating companies by SAPS as well as his alleged corrupt relationship with members of SAPS.

#### 3. RECOMMENDATION

The IPID recommends that Brigadier Phahlane and Col Potgieter be suspended or be moved from TMS to allow the Directorate's investigation team to access all necessary documents and witnesses. The continued presence of the two officers may jeopardise the investigation.

It is also recommended that no further payments are made to FDA until the investigation is concluded.

Subject: Alleged fraud and corruption against members of Crime Intelligence and I-view Integrated System (Brooklyn Cas 565/11/2017).

#### 1. INTRODUCTION

The Independent Police Investigative Directorate is investigating a case of fraud and corruption in terms of section 28(1)(g) of IPID Act, 1 of 2011. The investigation stems from a request made by the Minister of Police and Inspector General of Intelligence regarding corruption involving millions of rand in the Crime Intelligence division of the police. On 13/11/2017, an urgent meeting was held between IPID and the informant wherein information surfaced regarding possible destruction of evidence in Crime Intelligence offices and offices of the implicated Service Provider, Brainwave trading as I-view. The IPID was made aware of an existing contract with I-View Integrated System and fraudulent activities. There also appear to exist corrupt relationships with Major General Nemutanzhela, Major General Makhele, Lt General Phahlane and the Service Provider. The State allegedly suffered a loss of R54 000 000.00 for a system which was hastily procured without proper procedures being followed.

The Directorate raided the offices of Crime Intelligence in Pretoria assisted by members of Inspector General of Intelligence resulting in the seizure of laptops, computers and cellphones. The second team went to Durban on 14/11/2017 and applied for a search warrant which was granted and executed at the identified operational center of I-view Integrated System in Durban. The operation resulted in the seizure of laptops, computers and cellphones.

#### 2. INVESTIGATION HIGHLIGHTS

- 2.1 It is alleged that between 20 December 2016 and 31 March 2017 a procurement process was initiated between the Crime Intelligence (CI), a division of the South African Police Services (SAPS) and a company called Brainwave Projects 1323cc trading as I-View integrated Systems with registration number CK 2005/125830/23. During preliminary investigations it was established that there were gross irregularities in the procurement process resulting in the State suffering a loss of more than R54 000 000.00.
- 2.2 It was established that tender processes were not correctly followed and no proper application was made. Only two quotations were obtained. The one was from Brainwave Projects 1323cc trading as I-View Integrated Systems with registered address 346 Mathews Meyiwa Road, Greyville Durban in the amount of R33 858 000.00. The other was from Perfect Source Professional Services (Pty) Ltd with registration 2014/202395/07 and registered address 20 Marti Chanel, 264 Main Avenue, Ferndale, Randburg (as recorded on the quotation invoice provided to the SAPS) in the amount of R45 715 191.15. However, according the Central Supplier Database used by Government, the recorded business address of Perfect Source Professional Services is 15 Monta Vista, 71 Valley View Avenue, Morning Side, Durban.
- 2.3 When comparing both quotations, it became clear that the description columns were identical. It is only the amounts that differed. However, according the Central Supplier Database used by Government, I-View Integrated Systems is registered as suppliers of electrical equipment and components and Perfect Source Professional Services is purely human resource management services. It also indicates that Perfect Source Professional Services was non-tax compliant on 04 October 2017 and therefore not eligible to provide a quotation. In this regard Perfect Source Professional Services provided a tax clearance certificate indicating tax compliance from 19 November 2016 to 20 November 2017. This was also not disclosed as far as it could be established. It is clear that the above mentioned inflated "cover quote" was supplied by Perfect Source Professional Services to ensure the awarding of this contract to I-View Integrated Systems.
- 2.4 During the investigation, the owner Perfect Source disputed having submitted any quotation to Crime Intelligence for an amount of R45 715 191.00. However she suspected that her husband might have used her e-mails to provide a cover quote for I-View since he is a best friend of the owner of I-view integrated system. She further stated that she saw an amount of R700 000.00 deposited into her business account by I-View, which she suspected to be kickback for a cover quote. Her husband allegedly took the money and she was left owing over forty thousand rand in tax (R40 000.00).

2.5 The investigation is continuing to establish the extent of the involvement of police members both in CI and management

#### 3. NEW ALLEGATION OF CORRUPTION

3.1 On 2017/12/14 the Directorate received a tip-off regarding further transaction which is worth forty five million rand (R45 000 000.00) directed to Brainwave, trading as I-view Integrated System. The amount is alleged to be for the payment of a Graber system which its value is between seven million rand (R7 000 000.00) and ten million rand (R10 000 000.00). It was also brought to our attention that such amount of money directed to I-View Integrated System was in fact to be laundered for buying of votes at the ANC conference.

3.2 The Directorate engaged number of SAPS senior officials, whom some confirmed that such transaction was being pushed at all cost resulting in a strained relationship amongst senior members. It is against this background that the Directorate find this alleged transaction suspicious. It is also interesting to note that the same company which is being investigated by the Directorate is said to be the only company which is able to supply the system.

#### 4. RECOMMENDATION

The IPID recommends that the transaction of R45 000 000.00 directed to I-View Integrated Systems be stopped with immediate effect. It is further recommended that SAPS suspends all its dealings with Brainwave, trading as I-view Integrated System until the investigation is concluded.

The IPID referred disciplinary recommendations against Major General Nemutandzela to Acting Divisional Commissioner of Crime Intelligence Major General Ngcobo on the 07 November 2017, see attached Annexure "A".

Section 30 of the IPID Act provides that "the National Commissioner or the appropriate Provincial Commissioner to whom a recommendation regarding disciplinary recommendation matters were referred as contemplated in Section 7(6) and (7) must within 30 days of receipt thereof, initiate disciplinary proceedings in terms of the recommendations made by the Directorate and inform the Minister in writing and provide a copy thereof to the Executive Director and the secretary".

iPID has learnt with dismay that SAPS and General Ngcobo in particular as the Divisional Commissioner of Crime Intelligence failed to comply with the above provisions and also failed to comply with SAPS disciplinary regulations by ensuring that the disciplinary action is taken against Major General Nemutandzela.

As a result of this failure General Nemutandzela returned to work from suspension after 60 days lapsed without any action taken by SAPS.

Your office is requested to initiate disciplinary recommendations pursuant to Section 30 of the IPID Act against Major General Nemutandzela. IPID also recommends that you initiate appropriate disciplinary action against General Ngcobo for failing to initiate disciplinary action against General Nemutandzela in line with Section 30 of the IPID Act.

#### Summary of Allegations:

It is alleged that on or about January 2013 and February of the same year, two requests for procurement of blinds and curtains were submitted and authorised respectively. The first request was R478 900.00 for Waterkloof Heights Safe House, which was allegedly sourced from Umvuzo Wethu Promotions. The second quotation was worth R84 105.00 for Brooklyn Safe House, which was allegedly sourced from Siboniseng

The investigation uncovered that neither Umvuzo Wethu Promotions nor Siboniseng Construction installed the blinds and curtains as per their approved quotations. In both instances, the service provider that rendered the service was in fact industrial Corporation CC trading as Panda Blinds. It was also uncovered that, the company that was awarded R478 900.00 did quote the amounts as reflected on the approved quotes.

The actual cost for the Blinds in the Waterkloof Heights Safe House was R63 057.96 and not R478 900.00. The actual cost for the Brooklyn Safe House was R15 705.64 and not R84 105.00. The total amount claimed from Secret Service Account Funds was R563 005.00 whereas the actual cost for the service rendered was

Major General M.O Nemutanzhela approved the Standing Advance of R563 005.00 to be paid in cash. The SSA Funds was arranged even before the procurement process was properly followed and that the procurement process was arranged after the funds were already paid.

There is evidence to sustain prima facie case of Corruption and Contravention of Public Finance Management

- IPID is further conducting investigation of allegation of corruption against other members of Crime Intelligence including some involved in the above cases. The allegations relate to a corrupt relationship with the service provider I-View.
- IPID request that the documents on the I-View investigation that are in possession of the IGI be declassified and provided to IPID, as well as the

downloaded data on the computers and cellphones of Lieutenant Colonel Mahwayi, as it relates to the I-View investigation. The downloading was done by Crime Intelligence Cyber Unit, Colonel Smith.

- IPID also request declassification of the personal file of Captain "KGB"
   Tshabalala who is currently registered as Crime Intelligence Agent. Files from both Crime Intelligence and Personnel Division are requested.
- 6. Information provided to us by sources within Crime Intelligence indicates that Captain "KGB" Tshabalala was being paid by SAPS Crime Intelligence from the SSA fund while he was serving his sentence in prison. We request SAPS to provide declassified documents in this regard and answer the following questions:-
- 6.1 Who authorized and approved the re-appointment of Captain Tshabalala to the Police in September 2016?
- 6.2 Who approved Captain Tshabalala's conversion to an agent programme in September 2016?
- 6.3 Who authorized his payment as an agent while he was in prison from May 2013?
- 6.4 Why Captain Tshabalala was handled by Warrant Officer Nembwill who is in IT section and who is not responsible to handle agents?
- 6.5 Why Captain Tshabalala was not removed from SAPS persal system after his dismissal in June 2013?
- 7. You are advised that the continued retention and payment of Captain Tshabalala as an agent is in contravention of the SAPS policies and the PFMA and therefore unlawful. Appropriate action must therefore be taken by SAPS to remedy this situation and recover the resultant irregular, fruitless and wasteful expenditure.
- 8. The approved MISS document provides that "security measures are not intended and should not be applied to cover up maladministration, corruption, criminal actions, etc, or to protect individual officials involved in such cases".

REQUEST FOR DECLASSIFICATION OF CLASSIFIED DOCUMENTS: SILVERTON CAS 155-07-2011 (FRAUD, THEFT AND/OR CORRUPTION) AND LYTTELTON CAS 432-11-2011 (FRAUD, THEFT 1. INTRODUCTION

The Independent Police Investigative Directorate and the Inspector Genearl of Intelligence are conducting joint investigations on the above matters. Members of the DPCI who were involved in the initial investigation have been roped into the joint investigation.

#### 2. BACKGROUND

- The request for the declassification of certain classified documents flows from the 2.1 abovementioned investigation. 2.2
- The documents in question were allegedly created to facilitate the committing of offences and presented facts to internal auditors and the Auditor General which were not accurate. Had the South African Police Service's and the Auditor General knew the true nature of the expenditure they would have been able to identify the offences. 2.3
- The documents in question will also not endanger any current or past project and/or agents and only relates to the actual procurement of certain Items apart from the agents specifically refer to below. The declassification of the said documents might have a small financial effect as it would mean the two (2) vehicles in question will not be suitable for covert work. The vehicles can however be utilised in any other capacity.

- It is clear from the breakdown below that the classified documents mentioned indicate 2.4 alleged personal gain to the accused via the secret service account. As such no current
- It is also recommended that these documents be declassified in light thereof that the 2.5 accused who were employees of Crime Intelligence do not use that fact as a ground for the dismissal of some of the charges against them.
- In determining your assessment we need to stress that the reclassification of documents in 2.6 terms of the Minimum Information Security Standard (Miss) document lays down a minimum standard for the handling of classified information in all government institutions, which states that security measures are not to be applied to cover up maladministration, corruption, criminal actions, or to protect individuals/officials involved in such cases.
- To put the above-mentioned request into context it is important to state that the National 2.7 Prosecuting Authority (NPA) have instituted criminal charges with respect to the following events that relates directly to CI:
  - The trade-in by Lieutenant General RN Mdluli ("Mdluli") on 2010-05-31 of his personal vehicle, a 2009 BMW 730 D with registration number XWT 151 GP, for a 2010 BMW 330d Sedan with engine number 21537366 and a 2010 BMW 530d Sedan with engine number 23567507, in order to generate a discount to finance a shortfall on his finance contract with BMW finance, South Africa in the amount of
  - A trip to Singapore undertaken by Lieutenant General RN Mdluli from 2009-10-09 to 2009-10-16 where some of the expenses incurred were paid from the secret service account
  - A trip to China undertaken by Lieutenant General RN Mdluli and VL Mdluli between 2009-11-06 and 2009-11-14
  - A trip to Singapore undertaken by Lleutenant General RN Mdluli, Major General Lazarus, Colonel Barnard, Inspector G Mahwayi, Teresa Lyons, DG Naidoo and M Venter from 2009-11-21 to 2009-11-28
  - Rental of SR 563692 and SR 572047

- IPID is further conducting investigation of allegation of corruption against other members of Crime Intelligence including some involved in the above cases. The allegations relate to a corrupt relationship with the service provider I-View.
- IPID request that the documents on the I-View investigation that are in possession of the IGI be declassified and provided to IPID, as well as the

downloaded data on the computers and cellphones of Lieutenant Colonel Mahwayi, as it relates to the I-View investigation. The downloading was done by Crime Intelligence Cyber Unit, Colonel Smith.

- IPID also request declassification of the personal file of Captain "KGB" Tshabalala who is currently registered as Crime Intelligence Agent. Files from both Crime Intelligence and Personnel Division are requested.
- 6. Information provided to us by sources within Crime Intelligence indicates that Captain "KGB" Tshabalala was being paid by SAPS Crime Intelligence from the SSA fund while he was serving his sentence in prison. We request SAPS to provide declassified documents in this regard and answer the following questions:-
- 6.1 Who authorized and approved the re-appointment of Captain Tshabalala to the Police in September 2016?
- 6.2 Who approved Captain Tshabalala's conversion to an agent programme in September 2016?
- 6.3 Who authorized his payment as an agent while he was in prison from May 2013?
- 6.4 Why Captain Tshabalala was handled by Warrant Officer Nembwill who is in IT section and who is not responsible to handle agents?
- 6.5 Why Captain Tshabalala was not removed from SAPS persal system after his dismissal in June 2013?
- You are advised that the continued retention and payment of Captain Tshabalala as an agent is in contravention of the SAPS policies and the PFMA and therefore unlawful. Appropriate action must therefore be taken by SAPS to remedy this situation and recover the resultant irregular, fruitless and wasteful expenditure.

REQUEST FOR DECLASSIFICATION OF CLASSIFIED DOCUMENTS: SILVERTON CAS 155-07-2011 (FRAUD, THEFT AND/OR CORRUPTION) AND LYTTELTON CAS 432-11-2011 (FRAUD, THEFT

#### 1. INTRODUCTION

The Independent Police Investigative Directorate and the Inspector Genearl of Intelligence are conducting Joint investigations on the above matters. Members of the DPCI who were involved in the initial investigation have been roped into the joint investigation.

#### 2. BACKGROUND

- The request for the declassification of certain classified documents flows from the 2.1 abovementioned investigation.
- The documents in question were allegedly created to facilitate the committing of offences 2.2 and presented facts to internal auditors and the Auditor General which were not accurate. Had the South African Police Service's and the Auditor General knew the true nature of the expenditure they would have been able to identify the offences.
- The documents in question will also not endanger any current or past project and/or 2.3 agents and only relates to the actual procurement of certain items apart from the agents specifically refer to below. The declassification of the sald documents might have a small financial effect as it would mean the two (2) vehicles in question will not be sultable for covert work. The vehicles can however be utilised in any other capacity.

- It is clear from the breakdown below that the classified documents mentioned indicate 2,4 alleged personal gain to the accused via the secret service account. As such no current
- It is also recommended that these documents be declassified in light thereof that the 2.5 accused who were employees of Crime Intelligence do not use that fact as a ground for the dismissal of some of the charges against them.
- In determining your assessment we need to stress that the reclassification of documents in 2.6 terms of the Minimum Information Security Standard (Miss) document lays down a minimum standard for the handling of classified information in all government institutions, which states that security measures are not to be applied to cover up maiadministration, corruption, criminal actions, or to protect individuals/officials involved in such cases.
- 2.7 To put the above-mentioned request into context it is important to state that the National Prosecuting Authority (NPA) have instituted criminal charges with respect to the following events that relates directly to CI:
  - The trade-in by Lieutenant General RN MdJuli ("MdJuli") on 2010-05-31 of his personal vehicle, a 2009 BMW 730 0 with registration number XWT 151 GP, for a 2010 BMW 330d Sedan with engine number 21537366 and a 2010 BMW 530d Sedan with engine number 23567507, in order to generate a discount to finance a shortfall on his finance contract with BMW finance, South Africa in the amount of
  - A trip to Singapore undertaken by Lieutenant General RN Mdluli from 2009-10-09 to 2009-10-16 where some of the expenses incurred were paid from the secret service account
  - A trip to China undertaken by Lieutenant General RN Mdfuli and VL Mdfuli between 2009-11-06 and 2009-11-14
  - A trip to Singapore undertaken by Lieutenant General RN Mdluli, Major General Lazarus, Colonel Barnard, Inspector G Mahwayi, Teresa Lyons, DG Naidoo and M Venter from 2009-11-21 to 2009-11-28
  - Rental of SR 563692 and SR 572047

It would be appreciated if the documents referred to in paragraph 62 be declassified prior to the handing over of same.
- 3.5 The documents in question were obtained through different events and/or sources. The key attached to each document in respect of which declassification is required indicates from whom it was received, where it was obtained (if not a covert premises) and the date obtained.
- 3.6 The matter appeared before the Specialized Commercial Crimes Court, Pretoria on 06 July 2015 on which date this specific issue had to be addressed. This did not happen and as a result the matter was withdrawn.


