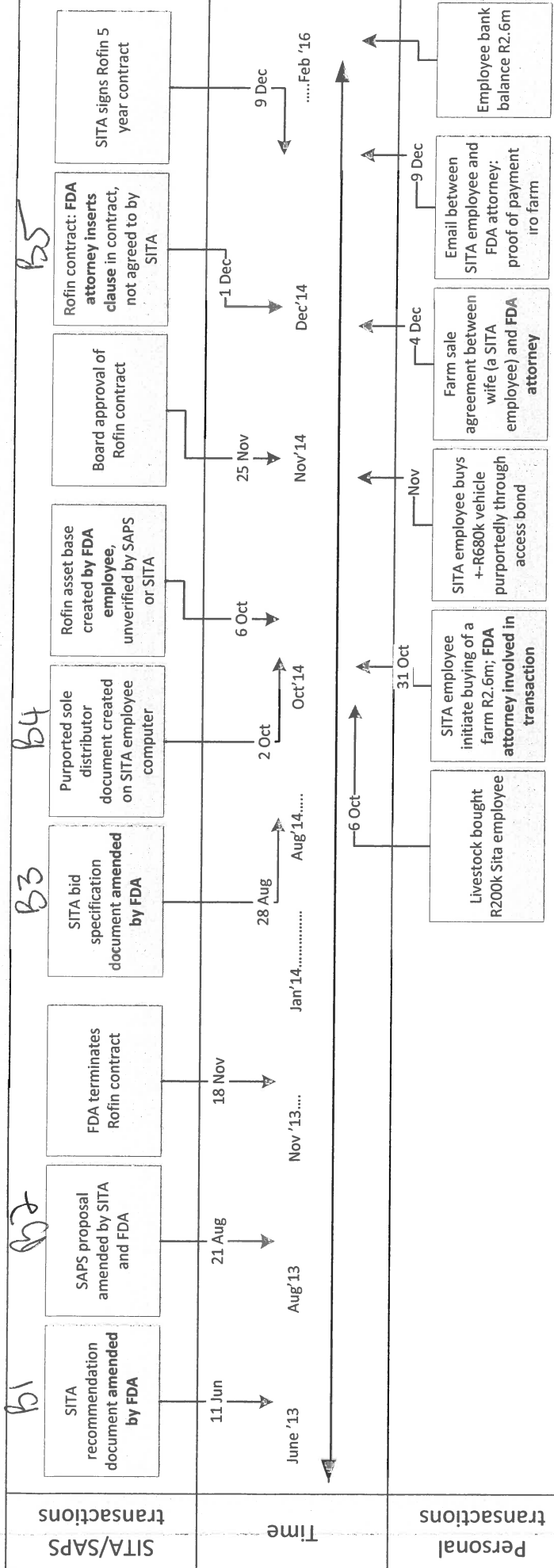


Timeline on ROFIN contract demonstrating possible corrupt relationships


