In terms of Section 15(4) (d) the Authorized Member has overall authority to direct measures relating to safety and security at the event.

In accordance with Section 16(1) (b) (c)(d)(e)(f)(g) the Event Safety and Security Planning Committee (ESSPC) must prepare an event specific safety and security plan and involve all the relevant safety and security role players.

In accordance with Section 16(3) the Event Safety and Security Planning Committee (ESSPC) must submit the details of a security service provider or a security officer whose service are employed at the event to the Authority to satisfy itself of

compliance with the Private Security Industry Regulation Act, 2001 (Act No. 56 of 2001).

In addition to the requirements as per the Safety at Sport and Recreational Events Act 2/2010, the following certificates must be obtained by ESSPC:

- ❖ Venue Grading Certificate
- ❖ Venue Safety Certificate
- ❖ Environmental Health and Safety Certificate
- ❖ Fire Safety Certificate
- ❖ Structural Certificate including temporary structures
- ❖ Public Liability Insurance Cover
- ❖ Electrical Safety Certificate

The organizer must continue to liaise with the Local Authority to ensure compliance with By-Laws and Legislation.

The applicable by-laws as well as any other relevant Regulations and Legislations must be adhered to.

Please take note that this categorization does not serve as an authority to host your event.
