- The Rural Safety Strategy was implemented in 2011.
- The aim of the Strategy is to address rural safety as part and parcel of an integrated and holistic day to day crime prevention approach, based on the principles of sector policing, which addresses the needs of the entire rural community, including the farming community.
- The pillars of the 2011 Strategy are as follows:
 - Enhance service delivery.
 - Integrated approach.
 - Community safety awareness.
 - Rural development .

INTRODUCTION (2)



- A JOINTS Priority Committee has been established on all levels to ensure that the Strategy is coordinated inter-departmentally, through the Joint Operational and Intelligence Structure (JOINTS) on national, provincial, cluster and police station level.

INTRODUCTION (5)

- The review is based on the following challenges, identified with the implementation of the existing Rural Safety Strategy:
 - Vastness of the rural areas.
 - Reluctance of farmers and farm workers to attend meetings due to the seasonal commitments.
 - Unreliable reporting.
- The reviewed Strategy will be piloted during the 4th quarter of 2018/2019.
- The reviewed Strategy will be implemented in the new financial year 2019/2020.







 - Correspondence regarding the Status implementation of the Rural Safety Strategy: 1st quarter of 2018/2019 dated 2018-07-30 and the 2nd quarter 2018/2019 dated 2018-10-11.
 - Correspondence regarding non compliance: Rural and Rural/urban mixed police stations not implementing the set criteria of the four pillars of the Rural Safety Strategy: 2nd quarter 2018/2019.
