FINAL MANDATE ON THE NATIONAL CREDIT AMENDMENT BILL [B30 - 2018]

1. INTRODUCTION

The Chairperson of the Portfolio Committee on Finance, Economic Development & Tourism, Hon M Matika, tabled the Committee's negotiating mandate as adopted by the Portfolio Committee on 28 November 2018 on the *National Credit Amendment Bill* [B30 – 2018].

2. PROCESS FOLLOWED

- 2.1 The Speaker of the Northern Cape Provincial Legislature has on receipt of the Bill referred the *National Credit Amendment Bill* [B30 2018], to the Portfolio Committee on Finance, Economic Development & Tourism on 19 October 2018.
- 2.2 the Portfolio Committee received a briefing on the Bill from the Northern Cape's Permanent Delegate to the NCOP, Hon W Faber, and the National Department of Trade and Industry on 07 November 2018.
- 2.3 The Portfolio Committee resolved to hold public hearings on the referred Bill in all five (5) regions of the Province and also called for written submissions to solicit the views of communities and stakeholders with regard to the *National Credit Amendment Bill*.
- 2.4 Five (5) Public Hearings were held on Monday, 26 November 2018 in all regions respectively as per Committee Resolution and both written and oral submissions were called for. The stakeholders engaged with the Members of the Provincial Legislature in respect of the Bill.

3. PORTFOLIO COMMITTEE POSITION AT THE NEGOTIATING STAGE

- 3.1 The Portfolio Committee on Finance, Economic Development & Tourism supports the Bill.
- 3.2 The House conferred on the Permanent Delegates the authority to participate in negotiations and to raise the concerns expressed.

4. COMMITTEE POSITION AFTER CONSIDERATION OF NEGOTIATING MANDATE BY THE NCOP SELECT COMMITTEE

The Portfolio Committee's Negotiating Mandate indicated that the Northern Cape will support the *National Credit Amendment Bill* [B30 – 2018].

5. FINAL VOTING MANDATE

In terms of Section 65 of the Constitution, the Portfolio Committee on Finance, Economic Development & Tourism recommends that the House confer authority on the Head of its Delegation to the NCOP to vote in support of the *National Credit Amendment Bill* [B30 – 2018].
