FINAL MANDATE ON THE DIVISION OF REVENUE AMENDMENT BILL [B15 – 2019]

1. INTRODUCTION

The Chairperson of the Portfolio Committee on Finance, Economic Development & Tourism, Hon N Maneng, tabled the Committee's Report on the ***Division of Revenue Amendment Bill [B15 – 2019]***, as adopted by the Portfolio Committee on the Friday, 22 November 2019.

2. PROCESS FOLLOWED

- 2.1 The Speaker of the Northern Cape Provincial Legislature has on receipt of the Bill referred the ***Division of Revenue Amendment Bill, 2019*** to the Portfolio Committee on Finance, Economic Development & Tourism.
- 2.2 On the Thursday, 21 November 2019, the Portfolio Committee received a briefing on the Bill by Mr E Pillay and Mr Molukanele from National Treasury, as well as the provincial NCOP Permanent Delegate, Hon W Aucamp.
- 2.3 The Portfolio Committee engaged in a public hearing in one region of the Province, namely Frances Baard, in Kimberley, on Thursday, 21 November 2019.
- 2.4 The Portfolio Committee considered the Negotiating Mandate on Friday, 22 November 2019 and voted in support of the Bill.

3. PORTFOLIO COMMITTEE POSITION AT THE NEGOTIATING STAGE

The Portfolio Committee on Finance, Economic Development & Tourism **supports** the Bill.

The House conferred on the Permanent Delegates the authority to participate in negotiations and to raise the concerns expressed.

4. **COMMITTEE POSITION AFTER CONSIDERATION OF NEGOTIATING MANDATE BY THE NCOP SELECT COMMITTEE**

The Portfolio Committee's Negotiating Mandate indicated that the Northern Cape will support the *Division of Revenue Amendment Bill [B15 – 2019]*.

6. **FINAL VOTING MANDATE**

In terms of Section 65 of the Constitution, the Portfolio Committee on Finance, Economic Development & Tourism recommends that the House confer authority on the Head of its Delegation to the NCOP to vote in support of the *Division of Revenue Amendment Bill [B15 – 2019]*.
