# Addendum to the Annual Performance Plan

2020/2021

### 1. Updated Situation Analysis

On 15 March 2020 a government gazette was published to declare a national state of disaster as a result of the outbreak of Coronavirus. Subsequently, a nation-wide lockdown was implemented aimed at curbing the spread of the virus which had an impact on business operational environment and mobility of the society at large. During the lockdown the IPID has been one of the departments rendering essential services. There was a need to respond to the eminent threat by ensuring the safety and protection of investigators and support staff. As a result, approximately R1.2 million has already been spent on procurement of personal protective equipment (PPEs), amongst other measures that were implemented in IPID offices. This was prioritized to ensure that service delivery is not disrupted.

The Department continues to experience budget pressures caused mainly by high case workload, therefore; baseline budget cuts might lead to catastrophic effect on the ability of the Department to effectively executive its constitutional and legislative mandate. The total budget allocation for the 2020/2021 financial year still remains at R355.6 million and the total actual budget required for IPID's current operations is R8.9 million; taking into account compensation of employees, contractual obligations and the remaining payments for the IPID Act section 23. During the special adjustments process, the National Treasury considered our resource constraints and took a decision based not to cut IPID's allocated budget based on the impact this will have on service delivery. Any savings that are being realized have been redirected towards investigation of cases and implementation of measures aimed at mitigating the impact of covid-19 on our officials.

Since the outbreak of covid-19 the Department has reported only five (05) cases of employees who tested positive for covid-19. The Department has been continuously implementing precautionary measures to curb the spread within the IPID offices.

A total intake was of 1 647 cases was received from 26 March to 30 June 2020 for different case classifications with the exclusion of systemic corruption. However; out of 1 647, a total of 645 cases were identified as cases that are related to the implementation or execution of the Lockdown Regulations. Investigation of cases continues; although there have been challenges encountered within the external operational environment. These challenges relate to temporary closure of some of Police premises and the Forensic Science Laboratory which leads to delays in receiving technical reports, witnesses or suspects that are quarantined, witnesses not adhering to safety measures by wearing masks. Investigations have not come to a halt due to measures that the Provincial management are continuously implementing.

During the first quarter of the 2020/2021 financial year improvement of ICT operational environment was prioritized to enable remote operations and virtual meetings. The impact of covid-19 on performance and the available budget on implementation of the tabled Strategic Plan 2020-2024 and Annual Performance Plan 2020/2021 were considered during the target review process. The Strategic Plan will not be adjusted and there will be few adjustments in the Annual Performance Plan under Programme 4: Compliance Monitoring and Stakeholder Management. The three (03) affected targets involve physical contact with external people which was impossible to execute since the beginning of the Lockdown; therefore, the approach was reviewed to minimize physical contact. Virtual applications will be utilized to conduct community outreach events and station lectures, including meetings with stakeholders. Targets were adjusted accordingly to accommodate the operational environment. The rest of the targets in Programme 1: Administration, Programme 2: Investigation and Information Management, and Programme 3: Legal and Investigation Advisory Services were not adjusted. Plans are in place to catchup on performance and to accommodate the new operational environment.
