OVERVIEW

- Influx of illegal immigrants settling in local communities which also result in human trafficking, child labour and/or forced labour.
- The establishment of criminal syndicates result in other crimes relating to employment such as job selling depriving local community members from employment.
- The lucrative cash benefits results in the collusion of SAPS members, security members, employees and community members which promotes a lawless and fearful environment.
- Criminal gang activities threaten the lives of employees and community members due to territorial fighting. Over 400 violent incident have been reported from 2013 to date.
- Illegal mining attracts other criminal activities such as prostitution, money laundering, theft, rape, murder and robberies etc.
- Illegal mining cost the state and mining house approximately R 11 Billion in taxes and R7 Billion revenue losses which could have benefited local communities.

OVERVIEW cont.

Illegal mining result in the exposure of community member and children to open shafts, hole and tunnels.

Illegal mining threaten sustainable investors in the mining sector which will result in mine closure and job losses in the community.


Illegal mining does not only threaten current jobs but also future employment opportunities for local community children.

No dedicated SAPS unit to curb illegal mining.

Corruption within the criminal justice system:

- bribing of the prosecuting authority;
- the court sentences relating to illegal miners do not act as a deterrent to illegal miners;
- participation of legitimate licensed dealers who purchase illegal gold and therefore encourage illegal mining.

SYNDICATE HIERARCHY



Level 1: Theft at source is normally the illegal miner who works underground, intruders, collectors and the smelters

Level 2: The regional buyers who also organise for the illegal miners to go underground, they pay security, banksmen and onsetters to allow the illegal miners to go underground. They move around in the Matjhabeng area.

Level 3: National buyers are usually in Gauteng area and they provide the money beforehand to the regional buyers for their workings in specifically the gold mine areas.

Level 4: International buyers still active in South Africa – they legalize the illegal gold through processes and sell it on the International market.

Level 5: International buyers outside South Africa who creates the demand in the overseas markets.

INTERNAL CHALLENGES

Huge amounts of cash paid to employees and security guards to assist with access and food supply The unsafe mining practices of illegal mines result in section 54 stoppages by the DMR, unsafe working conditions for employees and ultimately death and job losses.

Jeopardise the integrity of work places and the integrity of the ground conditions.

Set booby traps to prevent capture.

Territorial fighting which escalate to the point whereby firearms and explosive are used threaten the lives of employees and contractors.

No regard for safety result in underground explosions of methane gasses.

The opening of ventilation barricades by illegal miners reduces airflow to working areas.

Theft and damages significantly increase the costs of security, equipment and maintenance which threaten operational sustainability and job security.

Mine Management's reliance on employees to curb illegal mining.

SHAFTS CLOSED IN THE FREE STATE

All Harmony Gold Mine shafts and plants mentioned below were fully operational before the impact of Illegal Mining was identified.

According to law a mining company like Harmony Gold Mine for example, stays responsible for closed shafts & plants until they are rehabilitated (those in operation, including pump shafts).

Filling of these shafts only influences the vent flow, not travelling routes. Any access from these shafts to the underground workings is permanently stopped




OPERATION "KNOCK-OUT"


OPERATION "KNOCK-OUT"



Wednesday 21 October 2020

OFFICE OF THE PROVINCIAL COMMISSIONER: FREE STATE MOST FEARED ZAMA ZAMA KINGPIN AND FRIENDS SENTENCED TO LIFE

Virginia: The notorious Zama Zama kingpin, Eric David Dumisani Ndlovu (48) aka "David One Eye", Lefoso Makena Mosia (27), and Molefi Michael Mahloane (56) were all sentenced to life imprisonment today 21 October 2020 by the Bloemfontein High Court sitting in Virginia for the gruesome murder of Mahlomola Pin Mokoena (34). It was discovered during trial that in the evening of the 12 July 2017, the deceased went to a local tavern with a friend from Gauteng and they were later joined by Makena Mosia who was also a friend to the deceased. The three were planning to go and do some Zama (illegal mining) work. Makena then told them that they have to wait for a call before departing and after receiving the call, all three of them went to Phakisa cemetery in Odendaalsrus. At the cemetery, the three met with the Molefi Mahloane and the other unknown suspect. All five of them i.e the deceased (Mahlomola), Makena, Molefi, the Gauteng friend, and the unknown suspect went deep inside the cemetery. They were then joined by 'David one eye' who demanded his money for gold balls owed to him by Mahlomola and when he said he didn't have money, David instructed Makena and Mahloane to kill Mahlomola. They shot him execution style in the head and body. Mahlomola's Gauteng friend managed to run away and reported the matter to his police friend who referred him to the then Investigating Officer, former Warrant Officer Marumo. It was later discovered that Marumo was working for 'David one eye' after he falsified information in the court of law. Marumo was charged with defeating the ends of justice and sentenced to three years imprisonment then dismissed from the SAPS. "My appreciation for the thorough investigation by the Provincial Anti-Gang Unit in ensuring that of one the most feared, powerful, notorious criminal in the Goldfields, aka 'David one eye' is permanently removed from society", said the Provincial Commissioner of the Free State, Lieutenant General Baile Motswenyane

Vaal River – EGAF Redundant Gold Plant

EGAF/Pipe Yard is an old redundant plant that has been demolished and excavated, the next process will be to rehabilitate the area.

Perimeter fence and cctv surveillance still active on site.

Criminal elements has discovered some "rich" deposits in trenches that could not be excavated previously. Latest assay samples were tested to be between 2 and 69 gm/ton

ILLEGAL ACCESS

ILLEGAL ACCESS

- Access through old ventilation shafts, (not guarded or monitored) mostly in the Gold mining sector.
- Access via interlinked shafts of neighbouring mines.
- Redundant shafts where they break the seal.
- In the Free State syndicates uses Marashea's to protect the area with fire arms in order to enter and climb down the buntings and or to throw food down.









ILLEGAL ACCESS

- After the shaft hole is sealed.
- The illicit miners break the seal and go to the sub bank area where they cannot be seen.
- Foodstuff is then being put underground or illegal miners will climb down the shaft buntings or being lowered with a "pulley" to the next available level.
- To eliminate the risk and to counter the problem, the seal is opened and the hole is filled with rubble and building material and resealed again.
- The Security continuously conduct daily inspections, to ensure that no tampering occurs

between inspections.







ELAND SHAFT

On 14/08/2019 at 08:00 Operational Manager was escorting a mine employee and contractors who was testing the airflow on the different levels at Eland Shaft. On their arrival on Level 45, Station, Mr Zaaiman found a letter addressed to HGM at the station. He took the letter and it was handed in to the Investigations Department. SAPS and Security dockets were opened for intimidation.

CASES: ATTEMPTED MURDER OF SAPS AND SECURITY MEMBERS

On 16th January 2017 at about 21:00 at St Helena 1 C Vent Shaft – Security members Timo de Swart and van der Merwe posed as fisherman to observe movement with the night sight. They approached the area by foot with Captain Engelbrecht of the Welkom SAPS. The suspects started to shoot at them and critically wounded Captain Engelbrecht. Security members returned fire. Backup was called from the SAPS and other Security members. The area was swept but no suspects could be found. Heavy caliber firearms were used by the suspects. The crime scene will be investigated during day light. Captain Engelbrecht was taken to hospital for medical attention. SAPS opened a case. Welkom CAS: 247/01/2017.





KIDNAPPING AND MURDER

TSHEPONG MINE

On 28/09/2017 at 17:36 the Regional General Manager Mr Simphiwe Kubheka, Comp no: P9120615 was travelling inside his private vehicle, when he was fatally shot by unknown suspects opposite the main entrance at Tshepong mine. Two suspects were observed who fled the scene. Odendaalsrus SAPS were informed and took over the scene. Four men have been found guilty of the assassination of the mentioned Regional General Manager. Thabeso Elliot Khoase, mine employee at the time was the link between the illegal miners and the assassinators. They all were sentenced to life imprisonment. The four others were sentenced to two and four years respectively.



EXTERNAL CHALLENGES

The first challenge is that to some of the community sees the illegal miners are hero's.

Violence is escalating at an alarming rate and makes it difficult for security and the police to investigate.

The amount of money available for syndicate members and leaders to bribe police officials, security personnel, etc. runs into millions of Rand's.

The lack of a multidiscipline Task Team as per operation "Knock-out" in the Free Sate.

Operation "Knock-out" should be duplicated in other provinces.

Members of such operation should not originate or be stationed in the same province of operation.

Involvement of employees, security and contract personnel in illicit mining.

Involvement of law enforcement agencies in the illicit mining trade from SAPS to Public Prosecution.
