# Performance against Executive Authority's Priorities

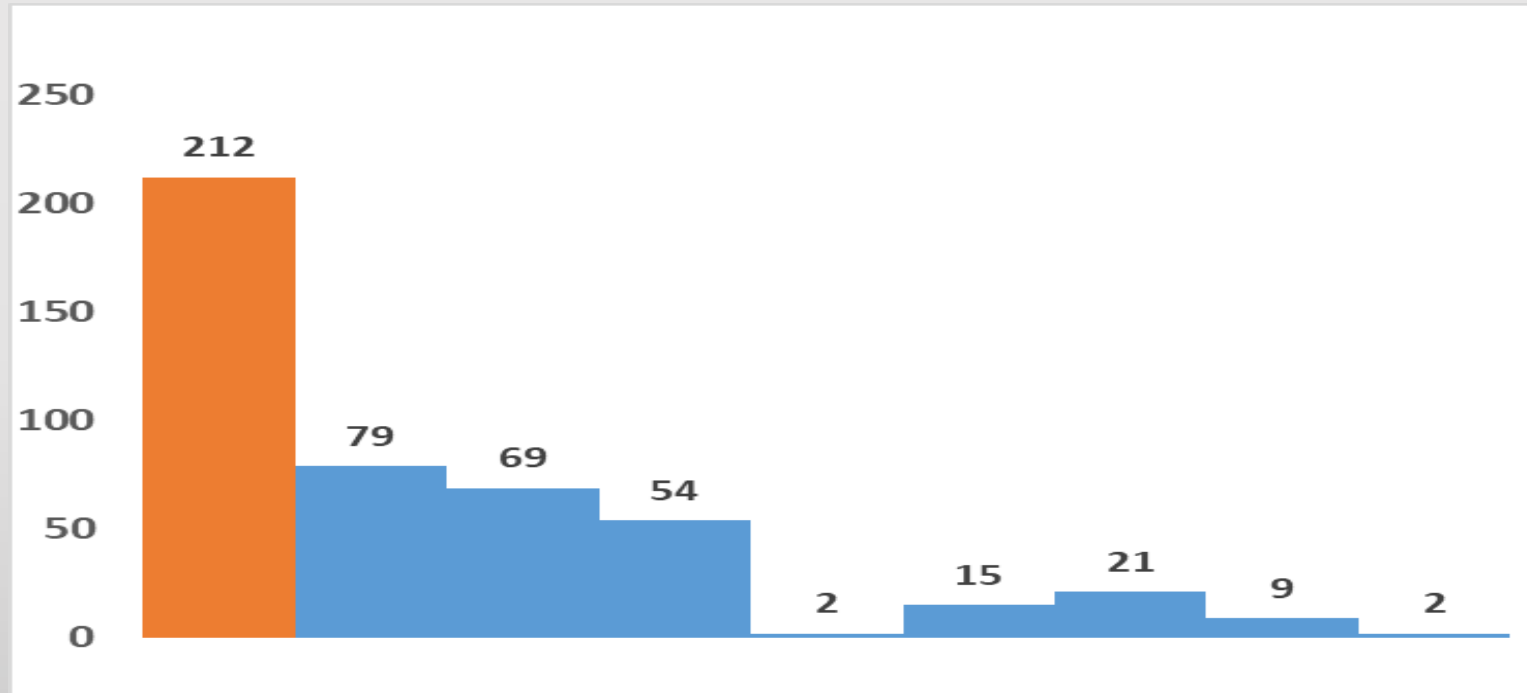
- **Priority 1:** Strengthening governance and oversight protocols to give effect to the provisions of the Act

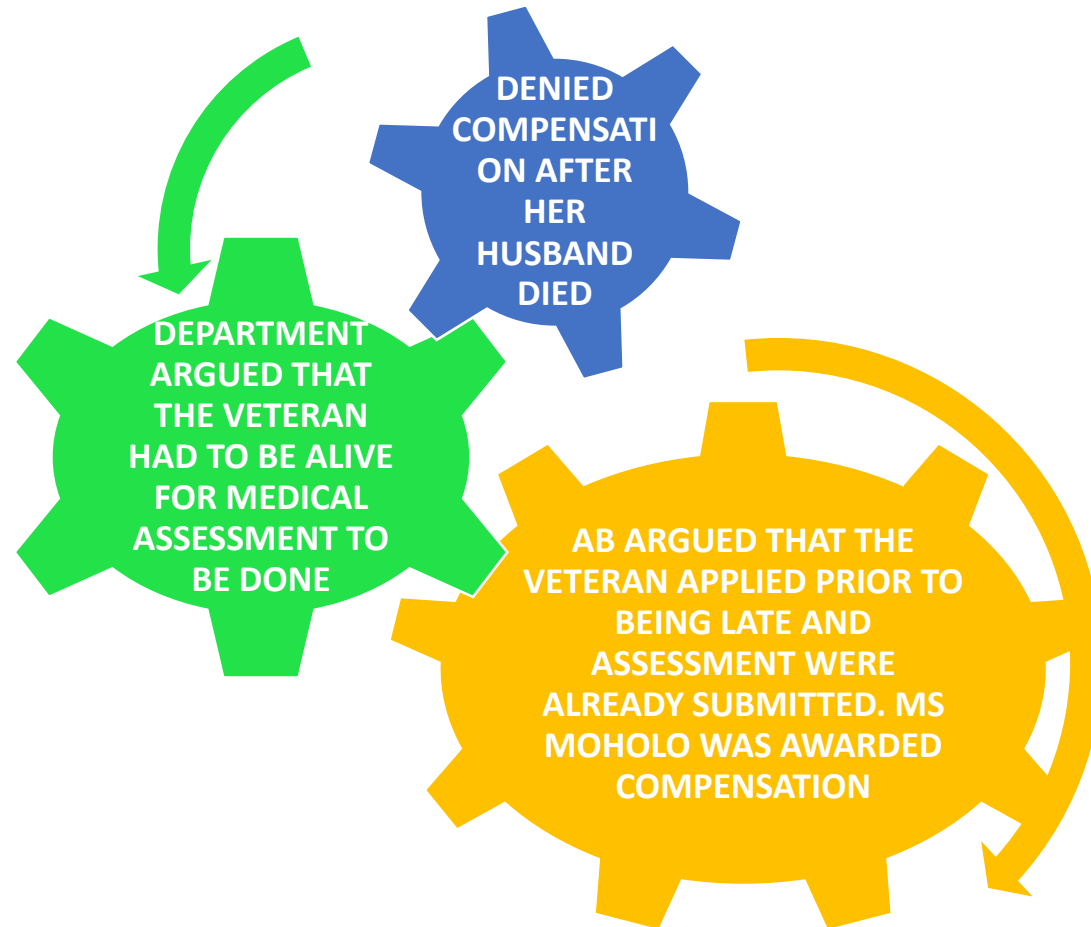


# AB Progress on Risk Mitigation

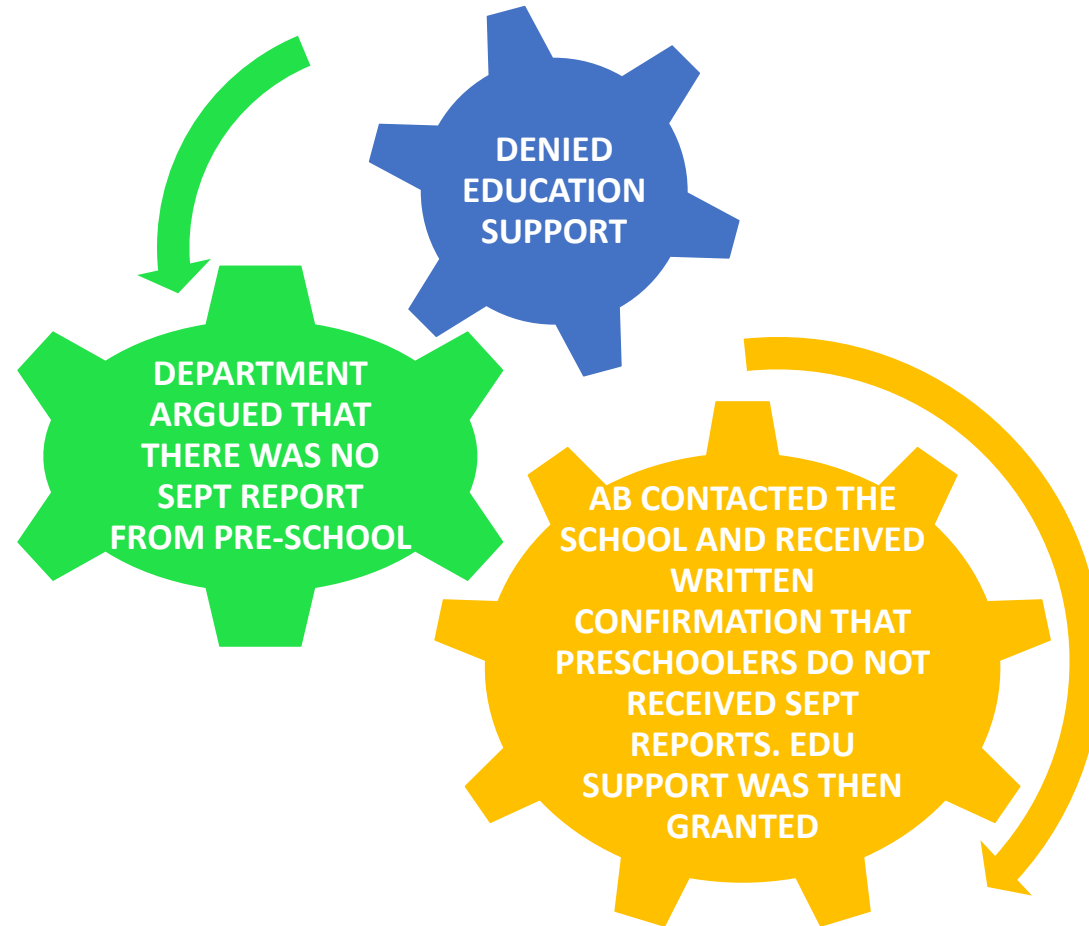

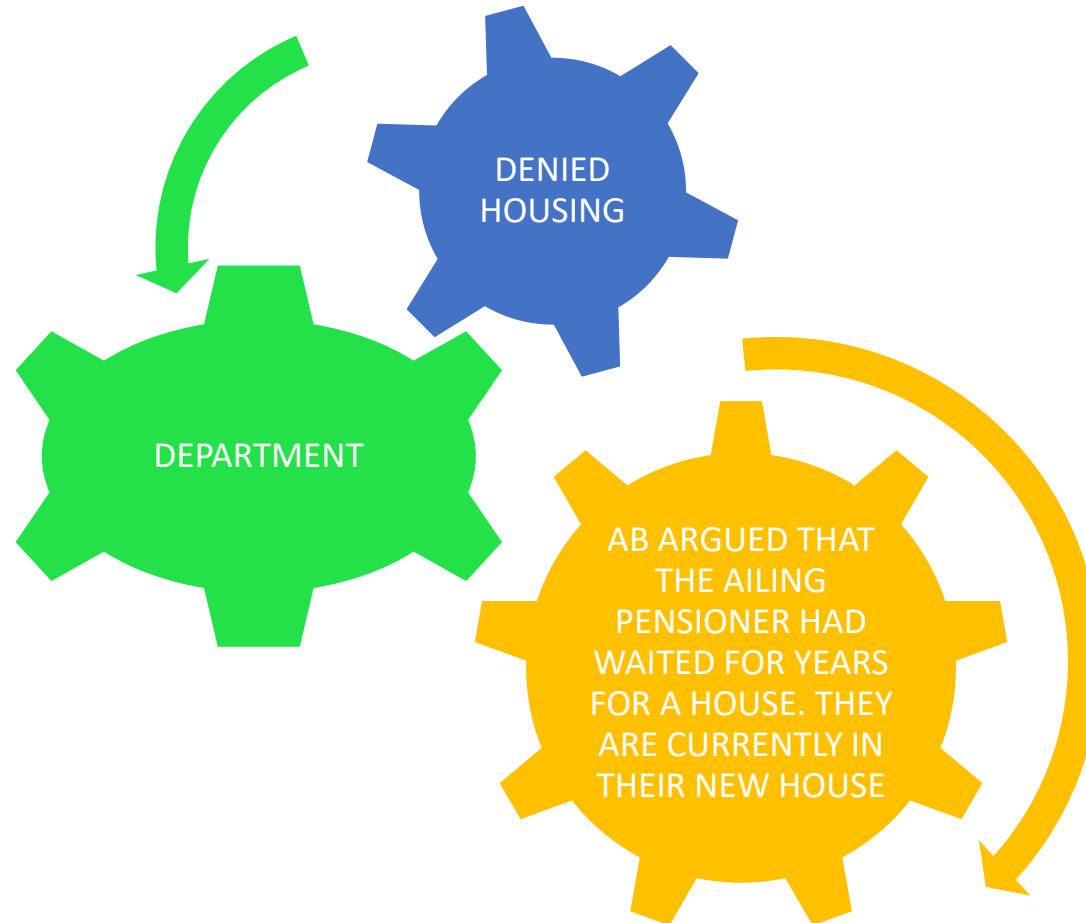

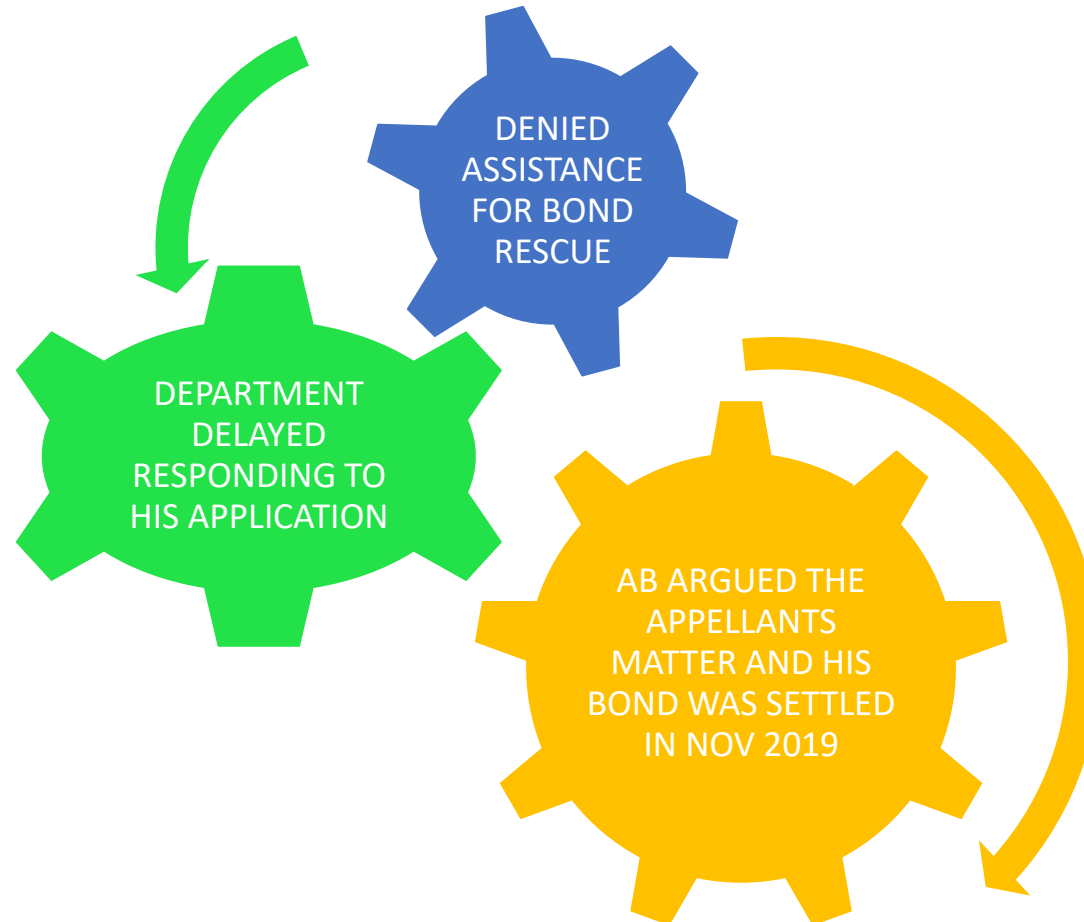
