


## Background




- Subsequent to the approval by Parliament, the Minister declared the Amnesties in terms of section 139(1) of the Firearm Control Act, 2000 (Act No. 60 of 2000).
- Both Amnesties were declared for a period of six (6) months and commenced from 01 December 2019 to 31 May 2020 and from 01 August 2020 to 31 January 2021 respectively.

□ The amnesty was premised on the following five (5) objectives:

- To reduce the number of illegally possessed firearms in circulation in South Africa.
- To provide firearm owners with the opportunity to hand in unwanted firearms.
- To prevent crime and violence and to promote safety.
- To address the fundamental causes of crime in order to effectively protect our communities.
- To ensure people living in South Africa feel and have no fear of crime.
- □ The Report includes the Firearm Amnesties for 2019/2020 and 2020/2021.




### Monthly Comparisons of surrendered Firearms



#### Total Number of firearms surrendered 80 263 (as on 2021-02-05)




#### **Firearms surrendered per province**



**2019/2020 2020/2021** 








Total number of firing test samples received at Forensic Science Laboratory **44 195** and **30 463** captured on the ABIS system.



Total of **2 059** and **280** Firearm Amnesty applications were finalised for 2019/2020 and 2020/2021 respectively.

## **Marketing and Communication**



Firearm Amnesties were communicated and marketed internally and externally as depicted below:

- Branding materials and pamphlets (in the various languages) was procured and distributed in all provinces;
- Messages on Social Media platforms (Facebook, Twitter, Instagram);
- Information including Frequently Asked Questions uploaded on the website;
- Media statements issued and awareness campaigns conducted at various platforms (radio and television);
- Guidelines and Process Flow communicated internally at all levels;
- Internal communication was intensified through: Screen saver, Web banner, Email Footer, Salary advices and daily messages through emails.

### Monitoring



A National Firearm Amnesty Task Team visited selected stations in all provinces to monitor compliance and the following interventions were implemented:

- Arrangements made for firearms at smaller and isolated stations to be moved to bigger stations daily under armed escort;
- Stations with full storage facilities were directed to move amnesty firearms to the provincial central storage facilities.
- Stations grouped together to enhance Automated Ballistic Identification System (ABIS) testing of firearms;
- Additional members activated on the Enhanced Firearm Register System (EFRS) to deal with amnesty firearm applications; and
- National and Provincial roving teams established to oversee and ensure a smooth Firearm Amnesty process.

Task Team consisting of Divisions: Finance Management and Administration, Technology Management Services and Visible Policing (Central Firearm Register) was established to address the linkage of payments and firearm applications.

## Conclusion



Section 139 (4) depicts the purpose of Amnesty in terms of section 139 (1)(a) and (b).

The declared Firearm Amnesties afforded the communities an opportunity to surrender illegal/ unwanted firearms, firearm parts and/or ammunition notwithstanding firearm owners with expired licences.

Most of firearms received were applied for re-licencing, as a result the volume of applications received increased.
