RE: PROGRESS REPORT ON THE ISSUES OF THE FORMER MUNICIPAL MANAGER: MS. M.M. MATHEBELA.

The above matter refers,

An application which was filed by the municipality to review the decision of the Chairperson of the disciplinary hearing in a matter between the Municipality and the former Municipal Manager, was set down for hearing at the Labour Court on the 13<sup>th</sup> May 2021.

On the 13<sup>th</sup> May 2021, the Court could not ventilate on the merits of the application, instead, the Court issued out a directive for the postponement of the matter sine die and consolidation of the matters. The Committee will appreciate that there are currently three (3) separate applications which have been filed by both parties at the Labor Court:-

- a) An application filed by the Municipality to review the decision of the chairperson of the disciplinary hearing.
- b) An application filed by the Municipality to set aside the settlement agreement which has been signed by both parties.
- c) An application filed by the former Municipal Manager to have the settlement made an order of court: Case number.

On the 13<sup>th</sup> May 2021 the Court issued out a Court Order postponing the matter and that parties must prepare affidavits for the consolidation of all these three (3) applications.

Copy of the Court Order is attached for your easy reference.

### RECOVERY PROCESS.

The Municipality has already issued out summonses against the former Municipal Manager and the Chief Financial Officer at the High Court, Polokwane. The Case Number is; 7897/2020. The matter is defended. Pleadings have been exchanged and closed. The matter still before Court.
