INTRODUCTION

- On 3rd March 2021, the Committee was briefed by the Department of Mineral Resources and Energy (DMRE) on the:
 - License application process;
 - Types licenses issued by the Department;
 - Licence application backlog; and
 - Turnaround plan to address the backlog and application process.
- The Department committed to address the licence application backlog in affected regional.
- The Committee directed the Department to:
 - Implement its backlog turnaround plan to eradicate the license application backlog within three months;
 - Present an improved plan for the South African Mineral Resources Administration's (SAMRAD's)
 online application system within six months; and
 - The above should be included in 2021/22 Annual Performance Plan.







PROGRESS UPDATE ON CLEARING MINING LICENSE BACKLOG

- The Department started implementing the turnaround plan in Mpumalanga regional office which has the highest backlog.
- The Department is pleased to report that:
 - The above matters two directives have been included in the Annual Operational Plan (AOP). They may be escalated to the Annual Performance Plan after the Strategic Planning Session;
 - The procurement of an online application system is underway; and
 - Clearing of the backlog is work in progress not much progress has been made.

CHALLENGES

- Disruptions caused by Covid-19 closures and also directives on the percentage of employees at premises
- Inability to move staff around given Covid related fears and logistical arrangements
- Connectivity from use of desktops to Laptops has to be phased in
- Inadequate staffing to deal with the volume of work







INTERVENTIONS

- Re-skill personnel from DOE and encourage multi-skilling within the Branch
- Finalizing recruitment process to fill critical and vacant positions
- Improved ability to work remotely. Conversion of use of desktops to laptops will be phased in.
- Institute consequence Management where necessary to improve accountability
- Temporary assignment of personnel from WC and FS to assist with Northern Cape backlog.
- Relocating mineral regulation office in Gqeberha to EL to be more central and minimize travel to site and time out of office
 - Procurement of the online licensing system.







- Commenced with the procurement process of a new modern IT system through the State Information Technology Agency (SITA)
- Appointment of a service provider expected to be completed by end of October 2021
- The procured system is expected to:
 - Simplify and improve efficiency in rendering of services to investors in the mining industry and the public
 - Ensure provision of reliable and precise information on the location of exploration and mining rights
 - Provide a technology layer that is responsive and allows for modern workplace functionality, transparency, easily accessible by the users and to ensure compliance with our legislation
 - Reduce the turnaround time in the process of granting exploration and mining rights
 - Enhance investment in the mining sector and to grow the economy
 - Provide a seamless interface for investors through the licensing value chain
 - Provide a one-stop-shop solution where services rendered by the DMRE can be accessed, monitored and maintained

CHALLENGES

- COVID pandemic and associated restrictions prevent full staff complement to be present in the office to receive, process and analyse applications timeously.
- Rotational and staggered staff attendance in Covid-19 Regulations has unintended consequences on the turnaround time of applications.
 - Departmental/ Office closures for decontamination due to positive cases affect the turnaround time of applications.
 - High volume of application e.g., Change of Hands (financial distress) selling retail businesses, and wholesale applications.







INTERVENTIONS

- Introduction of overtime work during weekends have assisted in processing applications.
- PPALS system update will enable regional offices to transmit applications to the Head
 Office online with effect from 27 August 2021.
 - This will improve operational efficiencies as:
 - Quick turnaround time by reducing the time it takes to transfer a physical applications from the regional office to HQ via post or courier would be reduced;
 - Prompt update of application process; and
 - Quick decision making process.
