We refer to The Embrace Project petition, entitled 'We, the women of South Africa', which was delivered to you at the Union Buildings on Monday, 30

As you know, the petition, which gained over 28 000 signatures in the span of a month, requires that the President account for the lack of political will to respond to gender-based violence and femicide in South Africa despite the introduction of the Presidency's National Strategic Plan on Gender Based Violence and Femicide, the GBVF Respond Fund and numerous legislative amendments which await the President's signature.

When the petition was delivered to you on Monday, 30 August 2021, you undertook to respond to us within 14 days at the latest. It has been 20 days since the petition's delivery, and we have yet to receive a response from you.

In addition to my email follow-up below, which has not even received an acknowledgment of receipt, I have tried to call you on your mobile number (071 313 3744) but have received no response. I have also tried to call the Office of the Presidency a number of times but not once was my call answered.

Our petition received a lot of media coverage after its handover because it relates to GBVF and the Presidency's lack of political to combat it. If we are continuously ignored by the Office of the Presidency we will report that to the media. Such a report would cause further reputational damage to the Office of the Presidency when the public perception is already that the President is paying lip service to the issue of GBVF.
