#### **1. DATES OF DELIBERATION:**

The Limpopo Legislature Portfolio Committee on Cooperative Governance, Human Settlements and Traditional Affairs (CoGHSTA) was briefed by the NCOP Permanent Delegate Honourable Tebogo Mamorobela with the assistance by officials from the National Department of Agriculture, Land Reform and Rural Development on Thursday, 04 August 2022 via Microsoft teams, virtual meeting.

The Limpopo Legislature Portfolio Committee on CoGHSTA conducted public hearing on the Bill on Monday, 15 August 2022. Stakeholders were invited from all five district of the Limpopo Province.

After the public hearing, stakeholders were given until Friday 26 August 2022 to also submit written presentations if any.

CoGHSTA further met on Monday, 29 August 2022 for consideration and adoption of the Negotiating Mandate and further met on Monday 10 October 2022 for consideration and adoption of the Final Mandate. The Portfolio Committee noted that no further amendments were made on the Bill by the NCOP and therefore voted in favour of the Bill.

## **2. VOTE OF LIMPOPO LEGISLATURE:**

The Limpopo Provincial Legislature votes in favour of the Bill and confers final mandate to the province's Permanent Delegate to the NCOP to vote in favour of the Bill.
