Update as of 14th September 2022

- It is a known fact that Knoflokskraal has been reclaimed as ancestral land, the other parties to the court case suggest otherwise.
- 14th September 2022, all leaders has been called to a Unity meeting on a sacred piece of land called a kraal.
- A unity council has been established which consisted of all formations, Royal Houses, Organizations etc.
- The intent of the Unity Council was to serve as an interim body for 6 months that would aid Unity, create cohesion, to eventually formalize
- A traditional authority.
- All formations has been invited to a Bosberaad which lasted a month to continue Unity talks, but more so organize ourselves to Govern Knoflokskraal, naturally Organizations or as they call themselves Civilians has a particular view and are not for the culture, yet the reclaimers provided them with land initially.
- The KRA Knoflokskraal Royal Authority has been birthed as intended 14th September consisting of Royal Houses, Blood lines of various tribes and includes the Reclaimers of the said land, serving as respondents at High Court. All other groups are acknowledged by KRA as ALL of them received land from the actual reclaimers.

KRA is focussing on multi-sectoral programs on Knoflokskraal. The main aims of these programs is to empower indigent communities to fight the scourge of poverty with its accompanying social skills.

Objectives:

To continuously seek for opportunities for Indigenous Communities upliftment. To contribute to Government's mandate of poverty alleviation.

To actively contribute to the Khoisan community development initiatives.

To provide Training and Development specifically for the advancement of promoting the Khoi & San Culture.

To support projects developed and Implemented by Indigenous women and youth organisations and small businesses with a focus on empowering and strengthening leadership of Indigenous women through awareness, collaborations and other methodologies.




HOW COULD THAT BE?

KRA

- We request our Human basic needs to be prioritized
- We request the Culture to be respected by all spheres of Government
- To be acknowledged as a cultural village
- To continue consultation with various groups and aid Unity
- Enhance Echo Tourism within the Elgin Valley as we are in a protected Biosphere and with the Indigenous Brown people living there now the Biosphere is complete as a Khoi&San Village.

Government

- Public Works to conclude provided expectations as of December 2022
- SAPS to be more vigilant on Knoflokskraal
- TWK to support with basic municipal services like waste removal, sanitation, to be given go ahead for a servitude agreement to provide these basic services
- Further engagements to include the Human Rights Commissioner, the delegation to include brown people that understand the culture, that are education to deal with Indigenous communities.
- After two years engagements should take precedence with decision makers at the round table
