PORTFOLIO COMMITTEE ON FINANCE, ECONOMIC DEVELOPMENT & TOURISM FINAL MANDATE ON THE *DIVISION OF REVENUE BILL* [B2 – 2023]

1. INTRODUCTION

The *Acting* Chairperson of the Portfolio Committee on Finance, Economic Development & Tourism, Hon G van Staden, tabled the Committee's negotiating mandate on the *Division of Revenue Bill* [B2 – 2023], as adopted by the Portfolio Committee on Tuesday, 25 April 2023.

2. PROCESS FOLLOWED

- 2.1 The Speaker of the Northern Cape Provincial Legislature has on receipt of the Bill referred the *Division of Revenue Bill, 2023* to the Portfolio Committee on Finance, Economic Development & Tourism.
- 2.2 On the Thursday, 20 April 2023, the Portfolio Committee received a briefing on the Bill from Hon H Aucamp, NCOP Permanent Delegate, Ms Noxolo Mbambo, Mr Bongani Daka and Ms Pretty Mavhungu from National Treasury.
- 2.3 Public Participation processes that were facilitated:
 - 2.3.1 Hybrid public hearings have been scheduled in the Ruth First Auditorium (Frances Baard District), Kuruman (John Taolo Gaetsewe District), Pofadder (Namakwa and ZF Mgcawu Districts), and Carnarvon (Pixley Ka Seme District and Namakwa District) on Thursday, 20 April 2023.
 - 2.3.2 A request was also forwarded to all stakeholders in all regions of the Province on Wednesday, 05 April 2023 for written submissions on the Bill.

3. PORTFOLIO COMMITTEE POSITION AT THE NEGOTIATING STAGE

The Portfolio Committee on Finance, Economic Development & Tourism supports the Bill.

The House conferred on the Permanent Delegates the authority to participate in negotiations and to raise the concerns expressed.

4. COMMITTEE POSITION AFTER CONSIDERATION OF NEGOTIATING MANDATE BY THE NCOP SELECT COMMITTEE

The Portfolio Committee's Negotiating Mandate indicated that the Northern Cape will support the *Division of Revenue Bill* [B2 – 2023].

5. FINAL VOTING MANDATE

In terms of Section 65 of the Constitution, the Portfolio Committee on Finance, Economic Development & Tourism recommends that the House confer authority on the Head of its Delegation to the NCOP to vote in support of the *Division of Revenue Bill* [B2 – 2023]
