FINAL MANDATE FOR THE FUND-RAISING AMENDMENT BILL [B29B-2020]

(Section 76 Bills)

1. INTRODUCTION

The Chairperson of the Portfolio Committee on Health and Social Development, Hon S Tities, tabled the Committee's Final Mandate on the **Fund-raising Amendment Bill, [B29B-2020]** as adopted by the Portfolio Committee on **15 September 2023**.

2. PROCESS FOLLOWED

- 2.1 The Speaker of the Northern Cape Provincial Legislature referred the **Fund-raising Amendment Bill, [B29B-2020]**, to the Portfolio Committee on Health and Social Development, on **06 October 2022**.
- 2.2 The Portfolio Committee received a briefing on the Bill on **26 May 2023**, from the Northern Cape's Permanent Delegate to the NCOP, Hon D Christians. A representative from the National Department of Social Development made a presentation on the Bill.
- 2.3 Portfolio Committee resolved at the meeting of **26 May 2023**, to conduct Public Hearings on the Bill. An Advert was developed for placement on Institutional social media platforms, to solicit views of communities and stakeholders with regard to the **Fund-raising Amendment Bill [B29B-2020]**. Furthermore, Radio adverts/Jingles on eight radio stations were aired.
- 2.4 Public hearings were conducted on **07 June 2023** in **Upington**, as well as on **12 June 2023** in **De Aar**. One Radio interview took place in ZF MCGAWU and PIXLEY KA SEME districts. Both written and oral submissions were called for during these hearings. The Public engaged with the Members of the Provincial Legislature in respect of the Bill.

3. PORTFOLIO COMMITTEE POSITION AT THE NEGOTIATING STAGE


The Portfolio Committee on Social Development supports the bill. The House confer on the permanent delegate the Authority to participate in the negotiations and raise the concerns expressed.

4. COMMITTEE POSITION AFTER CONSIDERATION OF NEGOTIATING MANDATE BY THE SELECT COMMITTEE

The Portfolio Committee's Negotiating Mandate indicated that the Northern Cape support the **Fund-raising Amendment Bill [B29B-2020]**.

In terms of 65 of the Constitution, the Portfolio Committee on Health and Social Development recommends that the House confer authority on the Head of its delegation to the NCOP **to vote in support** of the **Fund-raising Amendment Bill [B29B-2020]**.
