**APPOINTMENT OF THE BOARD OF PAN SOUTH AFRICAN LANGUAGE BOARD

The purpose of this letter is to consult the Portfolio Committee in relation to the reconstitution of the Board of the Pan South African Language Board. I have approved that the Department commence with the process of reconstituting the PanSALB Board.
