#### **PURPOSE**

The purpose of this report is to provide a briefing guide on delays, and the corrective processes undertaken to disburse the National School Nutrition Programme grant resources, to benefitting schools in the Province and share the performance of the programme to date.







#### **NSNP PROGRAM OVERVIEW**

The National School Nutrition Programme is funded through a conditional grant and the output activities are aligned to the Division of Revenue Bill which are gazetted in the annual conditional grant framework.

The three pillars of the Programme include:

- 1. Provision of a nutritious meal to learners (Main meal and/or Breakfast)
- 2. Nutrition Education and Advocacy (Deworming, Hygiene)
- 3. Promoting Sustainable Food Gardens

The National School Nutrition Programme is implemented using a decentralized model and provides resources to schools for the purpose of employing Volunteer Food Handlers, Procuring Food Items and Equipment, Procuring Gas/ Fuel.

## EC PROCUREMENT MODEL: DECENTRALIZED



- The Eastern Cape Department uses a decentralized funding system to implement the National School Nutrition Programme.
- The funds are received by the Department of Basic Education (DBE) after compliance with the business planning framework and processes.
- A compliance certificate is issued by DBE following adherence to all pre-requisites such as the feeding cost, number of feeding days, volunteer food handler stipends, submission of a menu and a monitoring plan.
- Further to this the compliance to the EC 4.1, gazette for transfer of funds and cash flow projections submissions are collated by the Department to enable Provincial Treasury to issue correspondence permitting the commencement of expenditure







#### BACKGROUND TO DELAYS

- The National School Nutrition Programme, develops and circulates the disbursement schedule each budget year to commit the Department to earmarked dates throughout the budget year.
- The schedule indicates the date of the expected run, and 24 April 2023 was the scheduled date.
- Prior to the run, several activities have to be concluded for the process to comply with the required financial and administrative requirements.
- First is the database of operational schools, updated and verified learners
- Second is the inclusion of any new schools that were gazetted after the business plan has been approved.
- In the beginning of each new financial year a database formulated from the EMIS data is utilized to align funding to learners.

#### DATA CHALLENGES

- The departmental Education Management Information Systems, EMIS, Unit experienced a delay in finalizing the collection of this data during the onset of the 2023 academic year.
- Some schools struggled submitting data due to challenges with the network, that were perpetuated by load-shedding in some areas.
- There was a certain number of schools that experienced challenges with databases that could not meet the set validation criteria and were rejected due to this.







### **CORRECTIVE MEASURES**

- During the commencement of the financial year there were delays in the conclusion of the input process by schools.
- The Department mobilized the support of District Based EMIS officers to consolidate the information as accurately as possible. All schools received their allocated funding by 09 May.
