1. INTRODUCTION

The Chairperson of the Portfolio Committee on Agriculture, Land Reform, Rural Development, Environment & Conservation, Hon G van Staden, tables the Committee's report on the *Agricultural Product Standards Amendment Bill* [B15B–2021] as adopted by the Portfolio Committee on 02 November 2023

- 2.1 The Speaker of the Northern Cape Provincial Legislature referred the *Agricultural Product Standards Amendment Bill* [B15B–2021] to the Portfolio Committee on Agriculture, Land Reform, Rural Development, Environment & Conservation on 26 July 2023.
- 2.2 The Portfolio Committee received a briefing on 11 September 2023, from the Northern Cape's Permanent delegate to the NCOP, Hon Mmabatho Mokause. Mr. Smith, Snr official from the National Department of Forestry, Fisheries and Environment made a presentation on the Bill.
- 2.3 Public Hearing were conducted on the 15 September 2023 in Kimberley. Both written and oral submissions were called for during these hearings. The public engaged with the Members of the Provicial Legislature in respect of the Bill
- 2.4 On 18 September 2023, the Portfolio Committee on Agriculture, Land Reform, Rural Development, Environment & Conservation deliberated and considered the negotiating mandate of the Agricultural Product Standards Amendment Bill [B15B-2021]
- 2.5 On the 07 September 2022, the Portfolio Committee on Agriculture, Land Reform, Rural Development, Environment & Conservation deliberated and considered the final mandate of the Agricultural Product Standards Amendment Bill [B15B-2021]
