

Government allocates more budget for social grants each year, but that gets undermined by the skyrocketing cost of living that has gotten severe in the past years.

 Cost of living crisis - inequality, poverty, unemployment.

Household food basket has increased to an average of R5 098, which is over the minimum wage for general workers.

Between 2018 and 2022, more people have experienced hunger.

Social grants increases still not enough.

 R350 grant does not match the food poverty line of R760.

## R350 SRD Grant

Rising food prices = increase of R74 for a basic nutritious meal.
