We have no further comments or questions concerning the content of this Bill, which appears to be in line with the list of proposed portfolio committee amendments to the South African Institute for Drug-Free Sport Amendment Bill [B 41–2023] of 23 November 2023, which we reviewed and confirmed as appearing to be in line with the Code on 19 March 2024.

As previously mentioned, we kindly ask that you keep us informed and updated as to the next legislative steps leading to the formal adoption of the amendments. Once the amended SAIDS Act been formally adopted, published in the official gazette, and subsequently entered into force, we kindly ask that you send us a written confirmation, as well as a final copy of the formally adopted Act.

Moreover, and importantly, if any further changes are made to the text of this Bill before it is formally adopted, it is imperative that WADA be notified and given the time and opportunity, in line with our ISO-certified process three-week deadlines, to review these changes and determine whether they are in line with the Code.
