BILL

To appropriate additional adjusted amounts of money from the Provincial Revenue Fund in terms of sections 25 and 31 of the Public Finance Management Act, 1999, and to provide for matters incidental thereto.

WHEREAS the National Treasury has allocated additional funds to the Province in respect of the Education Infrastructure Grant;

AND WHEREAS section 31 of the Public Finance Management Act, 1999 (Act 1 of 1999), provides that the Provincial Minister responsible for finance may table an adjustments budget in the Provincial Parliament in respect of funds that have become available to the Province;

AND WHEREAS section 26 of the Public Finance Management Act, 1999, provides that the Provincial Parliament must appropriate money for each financial year for the requirements of the Province;

AND WHEREAS the Western Cape Government acknowledges the widespread and severe detrimental impact of prolonged load-shedding on municipal services and the economy, and its responsibility in terms of section 154(1) of the Constitution of the Republic of South Africa, 1996, to support and strengthen the capacity of municipalities to perform their functions;

AND WHEREAS municipalities need assistance in the delivery of basic services such as water and wastewater services by means of an emergency response to prolonged load-shedding;

AND WHEREAS the Provincial Minister responsible for finance in the Province has authorised the use of funds from the Provincial Revenue Fund, in accordance with section 25(1) of the Public Finance Management Act, 1999, to defray expenditure of an exceptional nature that was not provided for and that could not, without serious prejudice to the public interest in the Province, be postponed to a future appropriation by the provincial legislature;

AND WHEREAS section 25(6) of the Public Finance Management Act, 1999, provides that expenditure incurred in terms of section 25(1) of that Act, must be included either in the next provincial adjustments budget for the financial year in which the expenditure was authorised, or in other appropriation legislation tabled in the provincial legislature within 120 days of the Provincial Minister responsible for finance in the Province authorising the expenditure, whichever is the sooner.

B E IT THEREFORE ENACTED by the Provincial Parliament of the Western Cape, as follows:—

Interpretation

1. In this Act, unless the context indicates otherwise, any word or expression to which a meaning has been assigned in the Western Cape Appropriation Act, 2022 (Act 2 of 2022), has the meaning assigned to it in that Act.

Appropriation of adjusted amounts of money for requirements of Province

2. (1) Adjusted appropriations by the Provincial Parliament of money from the Provincial Revenue Fund for the requirements of the Province in the 2022/23 financial year, and money appropriated in terms of section 25 of the Public Finance Management Act, to votes and main divisions within votes, and for the specific listed purposes, are set out in the Schedule. 5

(2) The spending of the appropriation contemplated in subsection (1) is subject to the Public Finance Management Act.

Short title

3. This Act is called the Western Cape Additional Adjustments Appropriation Act 10 (2022/23 Financial Year), 2023.

**MEMORANDUM ON THE OBJECTS OF THE WESTERN CAPE
ADDITIONAL ADJUSTMENTS APPROPRIATION BILL
(2022/23 FINANCIAL YEAR)**

1. BACKGROUND

- 1.1 National Treasury published Notice No. 3070 on 21 February 2023 that relates to the Education Infrastructure Grant. In compliance with section 18 of the Division of Revenue Act, 2022 (Act 5 of 2022), the national Department of Basic Education, following revised allocations, stopped the transfer of funds to certain provinces and in terms of section 19 of the Division of Revenue Act, 2022, reallocated an amount of R115,462 million to the Western Cape Province (the Province).
- 1.2 Furthermore, the load-shedding prevalent throughout the Province has had a widespread and severe detrimental impact on municipal services and the economy. Electricity disruptions are having a severe impact on the continuous treatment of water and wastewater services and in some cases the water supply has been disrupted completely and the water quality compromised. Failure to address this crisis could result in prolonged failures in water supply and sanitation in municipalities, which would likely result in a significant health crisis. All indications are that the high levels of load-shedding will continue for some time and will have a further negative impact on municipal service delivery.
- 1.3 The impact of the elevated and sustained load-shedding on water and wastewater services was not known when the 2022 main and adjustment budgets were finalised and have surpassed the ability of municipalities in the Province to mitigate effectively the widespread and severe detrimental impact of load-shedding without assistance from the Province.
- 1.4 Section 154(1) of the Constitution of the Republic of South Africa, 1996, obliges the Province to support and strengthen the capacity of municipalities to, among other things, perform their functions.
- 1.5 Given the urgency of the situation, the Provincial Minister responsible for finance in the Province has, in terms of section 25(1) of the Public Finance Management Act, 1999 (Act 1 of 1999), authorised that funds from the Provincial Unforeseen and Unavoidable Reserve Fund be made available to assist municipalities with the unforeseen and immediate impact of prolonged load-shedding on water and wastewater services.

2. CONTENTS OF THE BILL

2.1 Clause 1:

Clause 1 incorporates the definitions used in the Western Cape Appropriation Act, 2022 (Act 2 of 2022), into the Bill.

2.2 Clause 2:

Clause 2 provides that adjusted appropriations from the Provincial Revenue Fund attributable to votes and main divisions within votes for specific listed purposes are set out in the Schedule to the Bill. The spending of these appropriations is subject to the Public Finance Management Act, 1999.

2.3 Clause 3:

Clause 3 provides for the short title of the Bill.

4. FINANCIAL IMPLICATIONS

- 4.1 R115,462 million, an unspent portion of the Education Infrastructure Grant, was reallocated to the Western Cape Province following revised allocations by the national Department of Basic Education and will be made available to Vote 5: Education as listed in the Schedule to the Bill.
- 4.2 R88,815 million will be made available to Vote 14: Local Government as listed in the Schedule to the Bill from funding set aside in the 2022/23 financial year in the Provincial Unforeseen and Unavoidable Reserve Fund. Some of these funds will now be released to the vote for transfer to municipalities for the purchase and installation of back-up energy supplies (which may include generators, renewable power sources, batteries and all ancillary costs associated with the installation) to secure the delivery of water and wastewater services, and which funds were not previously provided for in the 2022/23 provincial budget and could not, without serious prejudice to the public interest in the Province, be postponed to a future appropriation by the Provincial Parliament.

5. LEGISLATIVE COMPETENCE

The Provincial Minister responsible for finance in the Province is satisfied that the provisions of the Bill fall within the legislative competence of the Province.

WETSONTWERP

Tot bewilliging van bykomende aangesuiwerde bedrae geld uit die Provinciale Inkomstefonds ingevolge artikels 25 en 31 van die Wet op Openbare Finansiële Bestuur, 1999; en om voorsiening te maak vir aangeleenthede wat daarmee verband hou.

AANGESIEN die Nasionale Tesourie bykomende fondse aan die Provincie toegewys het ten opsigte van die Toekenning vir Onderwysinfrastruktuur;

EN AANGESIEN artikel 31 van die Wet op Openbare Finansiële Bestuur, 1999 (Wet 1 van 1999), bepaal dat die Provinciale Minister verantwoordelik vir finansies 'n aansuiweringsbegroting in die Provinciale Parlement ter tafel kan lê ten opsigte van fondse wat vir die Provincie beskikbaar geword het;

EN AANGESIEN artikel 26 van die Wet op Openbare Finansiële Bestuur, 1999, bepaal dat die Provinciale Parlement vir elke finansiële jaar geld vir die behoeftes van die Provincie moet bewillig;

EN AANGESIEN die Wes-Kaapse Regering die wydverspreide en ernstige nadelige impak van langdurige beurtkrag op munisipale dienste en die ekonomie erken, en sy verantwoordelikhed ingevolge artikel 154(1) van die Grondwet van die Republiek van Suid-Afrika, 1996, om die kapasiteit van munisipaliteite te ondersteun en versterk om hul funksies te verrig;

EN AANGESIEN munisipaliteite hulp benodig met die lewering van basiese dienste soos water- en afvalwaterdienste deur middel van 'n noodreaksie op langdurige beurtkrag;

EN AANGESIEN die Provinciale Minister verantwoordelik vir finansies in die Provincie die gebruik van fondse uit die Provinciale Inkomstefonds gemagtig het ingevolge artikel 25(1) van die Wet op Openbare Finansiële Bestuur, 1999, om uitgawes van 'n buitengewone aard te dek waarvoor daar huidig nie voorsiening gemaak is nie en wat nie, sonder ernstige benadeling van die openbare belang in die Provincie, tot 'n toekomstige bewilliging deur die provinsiale wetgewer uitgestel kan word nie;

EN AANGESIEN artikel 25(6) van die Wet op Openbare Finansiële Bestuur, 1999, bepaal dat uitgawes aangegaan ingevolge artikel 25(1) van daardie Wet, ingesluit moet word óf by die volgende provinsiale aansuiweringsbegroting vir die finansiële jaar waarin die uitgawes gemagtig word, óf by ander bewilligingswetgewing wat in die provinsiale wetgewer ter tafel gelê moet word binne 120 dae vanaf die Provinciale Minister verantwoordelik vir finansies in die Provincie die uitgawe gemagtig het, wat ook al die gouste is.

**MEMORANDUM OOR DIE OOGMERKE VAN DIE WES-KAAPSE
BYKOMENDE AANSUIWERINGSBEGROTINGSWETSONTWERP
(2022/23- FINANSIËLE JAAR)**

1. AGTERGROND

- 1.1 Nasionale Tesourie het Kennisgewing Nr. 3070 op 21 Februarie 2023 gepubliseer, wat met die Toekennung vir Onderwysinfrastruktuur verband hou. Ingevolge artikel 18 van die “Division of Revenue Act, 2022” (Wet 5 van 2022), het die nasionale Departement van Basiese Onderwys, nadat hersiene toekennings gedoen is, die oordrag van fondse na sekere provinsies gestaak en ingevolge artikel 19 van die “Division of Revenue Act, 2022”, ’n bedrag van R115,462 miljoen aan die Wes-Kaap Provinsie (die Provinsie) hertoegewys.
- 1.2 Verder het die beurtkrag wat regdeur die Provinsie heers ’n wydverspreide en ernstige nadelige uitwerking op munisipale dienste en die ekonomie gehad. Elektrisiteitsonderbrekings het ’n ernstige impak op die voortdurende behandeling van water- en afvalwaterdienste gehad en in sommige gevalle is die watertoevoer heeltemal ontwrig en die watergehalte in gedrang gebring. Versuim om hierdie krisis die hoof te bied, kan tot langdurige mislukkings in watervoorsiening en sanitasie in munisipaliteite lei wat waarskynlik tot ’n beduidende gesondheidskrisis sal lei. Alle aanduidings is dat die hoë vlakte van beurtkrag vir ’n geruime tyd sal voortduur en ’n verdere negatiewe impak op munisipale dienslewering sal hê.
- 1.3 Die impak van die verhoogde en volgehoud beurtkrag op water- en afvalwaterdienste was nie bekend toe die hoof- en aansuiweringsbegrotings vir 2022 gefinaliseer is nie en oorskry munisipaliteite in die Provinsie se vermoë om doeltreffend sonder hulp van die Provinsie die wydverspreide en ernstige nadelige uitwerking van beurtkrag te verklein.
- 1.4 Artikel 154(1) van die Grondwet van die Republiek van Suid-Afrika, 1996, verplig die Provinsie om munisipaliteite se kapasiteit te ondersteun en te versterk om onder meer hul funksies te verrig.
- 1.5 Gegewe die dringendheid van die situasie het die Provinsiale Minister verantwoordelik vir finansies in die Provinsie ingevolge artikel 25(1) van die Wet op Openbare Finansiële Bestuur, 1999 (Wet 1 van 1999), gemagtig dat fondse uit die Provinsiale Onvoorsiene en Onvermydelike Reservewefonds beskikbaar gestel word om munisipaliteite met die onvoorsiene en onmiddellike impak van langdurige beurtkrag op water- en afvalwaterdienste by te staan.

2. INHOUD VAN DIE WETSONTWERP

2.1 Klousule 1:

Die besteding van hierdie bewilliging is aan die Wet op Openbare Finansiële Bestuur, 1999, onderhewig.

4. FINANSIËLE IMPLIKASIES

- 4.1 R115,462 miljoen, 'n onbestede gedeelte van die Toekenning vir Onderwysinfrastruktuur, is ná hersiening van die toekennings deur die nasionale Departement van Basiese Onderwys aan die Wes-Kaap Provinsie hertoegewys en sal aan Begrotingspos 5: Onderwys beskikbaar gestel word soos in die Bylae tot die Wetsontwerp gelys.
- 4.2 R88,815 miljoen sal aan Begrotingspos 14: Plaaslike Regering beskikbaar gestel word soos gelys in die Bylae tot die Wetsontwerp uit befondsing wat in die 2022/23- finansiële jaar in die Provinsie se Onvoorsiene en Onvermydelike Reserwefonds opsy gesit is. 'n Gedeelte van hierdie fondse sal nou aan die begrotingspos toegeken word vir oordrag aan munisipaliteite vir die aankoop en installering van rugsteun-energietoevoer (wat kragopwekkers, hernubare kragbronne, batterye en alle bykomende koste verbonde aan die installasie mag insluit) om die lewering van water- en afvalwaterdienste te verseker, waarvoor sodanige fondse nie in die 2022/23- provinsiale begroting voorsiening gemaak is nie en wat nie, sonder ernstige benadeling van die openbare belang in die Provinsie, tot 'n toekomstige bewilliging deur die Provinciale Parlement uitgestel kan word nie.

5. WETGEWENDE BEVOEGDHEID

Die Provinciale Minister verantwoordelik vir finansies in die Provinsie is tevrede dat die bepalings van die Wetsontwerp binne die wetgewende bevoegdheid van die Provinsie ressorteer.
