★309. Mr S J F Marais (DA) to ask the Minister of Defence and Military Veterans:

Against the global outrage and condemnation of the Russian Federation's invasion of Ukraine, and specifically the resultant rising fuel and food costs that has contributed to the suffering of every South African, (a) what motivated her to accept the invitation from the Russian Minister of Defence, who is the architect of the invasion, which gave rise to alleged human rights abuses and atrocities committed by Russian troops against ordinary Ukrainian citizens, to attend the 10th Moscow Conference on International Security and (b) how will the Republic and the SA National Defence Force benefit directly from her attendance at the specified conference, given its dire financial constraints?
