- (1) (a) What number of Family Violence, Child Protection and Sexual Offences (FCS) units exist in KwaZulu-Natal, (b) for which police stations is each unit responsible and (c) where is each FCS unit situated;
- (2) what (a) is the (i) optimal and (ii) actual number of investigating officers working at each FCS unit, (b) number of the investigating officers have (i) attended and (ii) passed all the required courses needed to investigate the specified serious crimes and (c) number of dockets does each investigating officer have as at 1 June 2021;
- (3) what number of (a) vehicles does each FCS unit have and (b) the specified vehicles are currently in working order?
