DIRECTIVE SERVED IN TERMS OF SECTION 30(3) OF THE OCCUPATIONAL HEALTH AND SAFETY ACT, ACT 85 OF 1993.

I have carried out an inspection with regard to the hazardous condition of the Department of Home Affairs which was reported to me by Aliwal North L/C.

In terms of Section 30(3) of the aforesaid Act, you are hereby directed to take steps as specified below.

- CR 11(1)(a) Appoint the Structural engineer to assess the structure if it is suitable to be occupied.
- 2. EIR 7(2) Ensure that you produce a certificate of compliance for your electrical Installations to an Inspector.
- 3. EMR 7(4) Ensure that your switchboard controlling apparatus is marked or labelled.
- 4. ERW 3(1) Ensure that you fix or replace the damaged light fitting in the toilet.
- ERW 6(2)(b) Ensure that you make available and maintain an unimpeded workplace for every employee in your workplace.

- 6. ERW 6(2)(c) keep every indoor workplace clean, orderly and free of materials, tools and similar things which are not necessary for the work done in such a workplace.
- 7. ERW 6(2)(e) ensure that you keep roof and walls of every indoor workplace sound and leak-free.
- 8. ERW 9(1)(a) Ensure that your office is in a position of an emergency exit door.
- 9. ERW 9(2) Ensure that you make fire-extinguishers available.
- 10. FR 2(1) Ensure that you make toilet facilities available for your employees at least one toilet for Males and one toilet for females, as well for your clients (Male & Female).
- 11. The structural assessment report must be submitted to the office of the Inspector Occupational Health and Safety within 30 days from the date of this directive at the above address.

Failure to comply with the requirements of this directive constitutes a criminal offence and will render you liable to prosecution.
