2224. Mr H A Shembeni (EFF) to ask the Minister of Police:

With reference to the more than 300 members of the SA Police Service who were enlisted in 2008 as reservists, but are still working as security guards in KwaZulu-Natal, on what date will the status of the specified members change?

REPLY:

According to available records, a total of 184 temporary (casual) employees, some who were at the time also reservists, were appointed as permanent employees during 2008 as Security Officers in terms of the Public Service Act, 1994 in the KwaZulu-Natal Province.

The South African Police Service (SAPS) instituted several initiatives for the affected employees to be absorbed in different occupations (such as clerks etc.) after their permanent appointment, and during recruitment drives for appointment as members of the Service, some requirements were relaxed and the affected employees were invited to apply for appointment as entry level Constables. A total of 93 of these employees are still employed as security officers.

The Public Service Act, 1994 as well as the Public Service Regulations, 2016 prescribes the advertisement of posts, as well as a selection process, for employees appointed in terms of the Public Service Act, 1994 to advance to higher positions.

Posts in the SAPS are advertised regularly, and the affected employees are not excluded to participate in such processes if they meet the stipulated requirements.
