- (2) whether any cash was stolen and/or lost; if not, what is the position in this regard; if so, what are the relevant details;
- (3) whether any court cases have been impacted by items of evidence that were stolen and/or lost; if not, what is the position in this regard; if so, what are the CAS numbers of such cases:
- (4) whether he will make a statement on the matter?
