TO MEMORANDUM OF AGREEMENT

(Concluded on January 2013, for Cooperation on the Establishment of a Chair for Education in Human Settlements Development Management)

Made and entered between:

NATIONAL DEPARTMENT OF HUMAN SETTLEMENTS

Herein represented by Mr Mbulelo Tshangana in his capacity as the Director-General and he being duly authorized hereto.

(Hereinafter referred to as "the Department/DHS")

And

NELSON MANDELA METROPOLITAN UNIVERSITY (NMMU)

Herein represented by Prof Derrick Swartz in his capacity as Vice Chancellor and he being duly authorized thereto.

(Hereinafter referred to as "NMMU/the University")

THE PARTIES AGREE TO AMEND THE TERMS AND CONDITIONS OF THE SERVICE LEVEL AGREEMENT TO THE EXTENT PROVIDED FOR HEREIN:

1. RECORDAL

- A. Whereas the Department and NMMU concluded a Memorandum of Agreement on 06 November 2012 in terms of which the Parties collaborated on the establishment of a Chair for Education in Human Settlements Development Management.
- B. And whereas the Director-General in a memorandum signed on 19 June 2017, approved for an extension and/or variation of the Memorandum of Agreement concluded on 06 November 2012.
- C. Accordingly, the University's funding within the scope of the project is herein amended and/or varied as detailed in this Addendum.

2. DEFINITIONS

- 2.1 "Main Agreement" means the Memorandum of Agreement concluded between the parties on 06 November 2012;
- 2.2 "Addendum" means this agreement; and
- 2.3 "Parties" means the Department and the University as fully described on the first page of this Addendum.



3. AMENDMENTS

3.1 Clause 8.3 under heading "FUNDING WITHIN THE SCOPE OF THE PROJECT", of the main Agreement is herein amended to include the following: funds totaling R7 000 000 (Seven Million Rand) will be transferred to NMMU in two installments over two years. R3 500 000 (Three Million Five Hundred Thousand Rand) will be transferred in the 2017/18 financial year another equal amount for 2018/2019.

3.2 The funds will be utilized for the following:

3.2.1 BHSD Administration and teaching

3.2.2 Chair Entity Administration Support (within applicable NMMU human resources and engagement).

3.2.3 Funds to the value of R220 000 for the training of the Portfolio of Human Settlements Parliamentary Support team.

3.2.4 Support to Human Settlements Sector Professionalisation (Accredited Journal, Professional Body, Ministerial Advisory / Working Group)

3.2.5 Support to Human Settlements Sector Discourse Management (Annual National Conferences, Ministerial Seminars/ Dialogues)

3.3 The Memorandum of Agreement is hereby extended to 30 December 2019.

4. PAYMENT

4.1 The budgeted payment for this extension and/or variation shall not exceed R 7 000 000.00 (Seven Million Rand) to be transferred over two years as fully described below. This amount is inclusive of VAT and all disbursements.



5. VARIATION

The parties hereby agree that they are bound not only by the varied terms and conditions as set out in this Addendum, but also agree that they will continue to be bound by those terms and conditions in the Memorandum of Agreement which have not been varied. In the event that a dispute should arise with regard to this Addendum, the main agreement will prevail.
