Response

The municipality through the Municipal Infrastructure Grant programme has prioritised the construction of the Community Hall in Hazyview, Ward 25. The project was approved to the value of R8 725 211.56 in October 2018 and Implemented in 2018/19 financial year. The service providers appointed were RSK3 Consulting Engineers and Project Managers JV Appollo Engineering (PTY) (Consultant) appointed value was R880 174.81 and Mgugwana Investment (Contractor) appointed value was R7 250 593.03.

#### The completed scope of work includes the following:

- 1. Construction of a 350 seater community hall, (sub-structure and super-structure).
- 2. Construction of a quardhouse.
- 3. Installation of electricity.
- 4. Fencing
- 5. Borehole
- 6. Septic tank system
