Mr D W Bryant (DA) to ask the Minister of Forestry, Fisheries and the Environment:

- (1) In light of the recent responses to allegations of sewage outfalls in Cape Town,
- (a) what number of marine sewage outfalls are in the Republic?
- (b) where are the specified outfalls located?
- (2) whether all the outfalls are licensed and in the permitted regulations of the Coastal Waters Discharge Permit; if not, why not; if so, what are the relevant details:
- (3) what is the total volume of sewage licensed to be discharged into the ocean?

774. THE MINISTER OF FORESTRY, FISHERIES AND THE ENVIRONMENT REPLIES:

(1)

(a) According to a study commissioned by the department in 2015 (Status Quo of Effluent Disposal in South Africa), there are approximately 126 sea outfalls discharging various types of effluent (as an example, municipal and industrial effluent) into the coastal waters of South Africa. Of these, the largest proportion is in the Western Cape (64%), followed by KwaZulu-Natal (17%), the Eastern Cape (13%) and lastly, the Northern Cape (6%).

The study found the following breakdown per coastal province:

Northern Cape =7

Western Cape =81

Eastern Cape = 17

KwaZulu-Natal = 21

As part of the study, a total of 62 outfalls have been identified as having received an authorisation from the Department of Water and Sanitation prior to the promulgation of the Integrated Coastal Management Act, 2008 (Act No. 24 of 2008) (ICM), which empowers the Department of Forestry, Fisheries and the Environment to issue coastal waters discharge permits for such marine outfalls.

(b) The following table summarises the existing municipal discharges per coastal province, district municipality and discharge zone:

(2) The department started issuing Coastal Waters discharge Permits (CWDPs) in 2015. Municipalities are at various stages of applying for permits. Some municipalities have permits in place whilst others have submitted renewal applications. The Coastal Waters Discharge Permit regulations promulgated in 2019 prescribed the information and specialist studies requirement by the department in order to reach a decision on applications received. In some cases, applicants, including municipalities, were requested to supply additional information in order for the department to make an informed decision.
