920. Dr P J Groenewald (FF Plus) to ask the Minister of Police:

- (1) Whether his department awarded any tenders connected to the Covid-19 pandemic; if not, what is the position in this regard; if so, what (a) are the names of the businesses to whom these tenders were awarded, (b) are the amounts of each tender awarded and (c) was the service and/or product to be supplied by each business;
- whether there was any deviation from the standard supply chain management procedures in the awarding of the tenders; if so, (a) why and (b) what are the relevant details in each case;
- (3) what was the reason for which each specified business was awarded the specified tender?
- (4) whether he will make a statement on the matter?

REPLY:

- (1) Tenders which were connected to the Coronavirus (COVID-19) pandemic, were not advertised or awarded by the South African Police Service (SAPS). The procurement of personal protection equipment, to protect SAPS members from the COVID-19, were done on a quotation basis and are from the existing National Treasury Transversal Contract (RT76-2020).

(2)(a)(b) No, there were no deviations. Procurement actions were concluded by utilising the National Treasury instructions, numbers 8 of 2019/2020, 3 of

2020/2021 and 5 of 2020/2021, read together with the National Treasury Instruction 3 of 2016/17, paragraph 8.1 and 8.2, which authorises the accounting officer to deviate from competitive bids, in cases of emergency.

The State President of the Republic of South Africa declared the COVID-19 epidemic as a National Disaster, on 15 March 2020 and, therefore, the emergency procurement was justified.

- Quotations were sourced to address the SAPS's urgent and specific requirements. Where multiple quotations could be obtained, the awards were made, in terms of the Preferential Procurement Policy Framework Act (PPPFA) Regulations, as prescribed by the National Treasury. For the other requirements, awards were made to suppliers who had stock available.
- (4) The Minister will decide whether he will make a statement, in this regard.
