- (2) whether her Office has provided any form of assistance in the fight against human trafficking; if not, why not; if so, what are the relevant details in terms of the assistance provided to the SA Police Service? NW1200E

REPLY:

(1) The core business of the department is to regulate mainstreaming of women, youth and persons with disabilities in all government policy frameworks and programmes: This includes providing leadership, enforcing accountability and compliance with reporting requirements and monitoring progress on implementation of the National Strategic Plan on Gender Based Violence and Femicide including trafficking in persons.

In the case of trafficking in persons, the department's responsibility is to monitor, progress made by relevant departments, e.g. SAPS, DOJCD and NPA implementing trafficking in persons programmes and initiatives. The reports are collated on a monthly basis and sent to the Presidency.
