Reckless Pool Vehicle Driving Incident - Head Office: The 3 incidents occurred on 11 April (11-12 am) on the R539 road (N4 Shoemanskloof). Between Mbombela and Machadodorp. 1. This was where this particular vehicle decided to ignore the waiting line and drove onto the opposite road risking colliding with the oncoming traffic. I then reported the matter at NYDA in Witbank office and they also intervened without any luck. I had been corresponding with Ms Dikeledi and she went there herself. Early this year she let me know that the matter has been handed over to the legal department. It's almost two years now, since the service provider was paid without them delivering the trailer to me. I have lost a lot of income from not having the trailer, as I was renting one and the owner took it back in late 2019. Please can something be done to help me in this matter.
