UNDERSPENDING 2021/2022

How much did the SAPS underspend in 2021/2022?

- Of the total South African Police Service (SAPS) budget of R100,4 billion allocated for the 2021/2022 financial year, the actual expenditure, as at 31 March 2022, was 99,13%, which is a noticeable improvement on the spending performance of the 2020/2021 financial year.
- Underspending was, therefore, only 0,87%.

AUDIT OPINION 2021/2022 (1)

Will the SAPS be getting an unqualified audit report, for 2021/2022?

- After the 2020/2021 financial year's audit was concluded, a Post Audit Action Plan (PAAP) was compiled to strive for an improvement in the audit outcomes.
- Frequent Audit Steering Committee meetings are held to monitor implementation of the PAAP and progress on the 2021/2022 financial year's audit.
- No material findings were issued in the interim audit and the Department is positive that an unqualified audit opinion is again possible for SAPS, for the 2021/2022 financial year's final audit.

FILLING OF CRITICAL POSTS

What is the position regarding the filling of critical posts, including the post of the Divisional Commissioner: Crime Intelligence?

- Critical vacant posts in the SAPS are advertised and filled on a regular basis.
- The post of Divisional Commissioner: Crime Intelligence has been advertised and the filling of the post is currently being prioritised.

TERM OF OFFICE OF THE NATIONAL COMMISSIONER: CONTRACT (1)

PRESIDENT'S MINUTE NO 103/2022

I hereby in terms of section 207(1) of the Constitution of the Republic of South Africa, 1996, appoint, with effect from 01 April 2022, **General Schlahle Fannie Masemola** as National Commissioner of the South African Police Service.

Given under my Hand and the Seal of the Republic of South Africa at Johannesburg this 01 day of APril Two thousand and Twenty-Two.

TERM OF OFFICE OF THE NATIONAL COMMISSIONER: CONTRACT (2)

- 1.2 This Contract shall be in force for the period commencing on 1 April 2022 and ending on 31 March 2027 and is entered into in terms of section 7 of the South African Police Service Act, 1995 (Act No 68 of 1995) (hereinafter referred to as "the Act").
- 1.3 During the period of this Contract, the Employee shall ---
 - 1.3.1 serve the Employer as National Commissioner of the South African Police Service at such place as may from time to time be directed by the Employer;
 - 1.3.2 be responsible for the efficient management and administration of the South African Police Service (hereinafter referred to as the Service) as contemplated in section 207(2) of the Constitution, the Act, section 7(3)(b) read with section 7(4) of the Public Service Act, 1994 (Proclamation No 103 of 1994) and as set out in the performance agreement referred to in clause 6.1; and
 - 1.3.3 be responsible for exercising the powers and performing the functions specifically entrusted to the office of the National Commissioner of the South African Police Service and the Head of the Department of Police, in particular as set out in the Constitution, the Act or any other law.

TERM OF OFFICE OF THE NATIONAL COMMISSIONER: CONTRACT (3)

- 3.1 The term of office of the Employee may be terminated as provided for in the Act.
 - 3.3 Subject to the provisions of the Act, either party may, after consultation and agreement with the other party, terminate this Contract before the expiry of its term or an extended term by giving to the other party three months' notice of termination, which notice shall be given in writing on or before the last day of a month and take effect on the first day of the succeeding month.
 - 3.4 Should notice of termination be given as contemplated in clause 3.3, the Employer has the right to require the Employee to vacate the office occupied by him and to leave the premises of the Department on a day stipulated by the Employer before the expiry of the three months' notice period and not to present himself for duty any time thereafter.

TERM OF OFFICE OF THE NATIONAL COMMISSIONER: CONSTITUTION

- Section 207(1) of the Constitution provides that:
 - The President, as head of the national executive, must appoint a woman or a man as the National Commissioner of the police service, to control and manage the police service.

TERM OF OFFICE OF THE NATIONAL COMMISSIONER: SOUTH AFRICAN POLICE SERVICE ACT

- Section 7(1) of the SAPS Act, 1995 provides that the person who is appointed as National Commissioner by the President shall occupy that office for a period of up to five years from the date of his or her appointment or such shorter period as determined by the President.
- Section 7(2) of the SAPS Act, 1995 provides that the President may <u>extend</u> the term of office of the National Commissioner at the expiry of the initial term for periods not exceeding five years at a time.
- Section 45 of the SAPS Act, 1995 deals with the retirement of members of the Service.
 - Section 45 (4) provides that the National Commissioner may retire from the SAPS and he
 or she shall be so retired at the expiry of the term or terms referred to in section 7 of the
 <u>SAPS Act</u>, 1995.

TERM OF OFFICE OF THE NATIONAL COMMISSIONER: CONCLUSION

- In terms of the above it is clear that that
 - The President appoints the National Commissioner;
 - The contract of employment is between the President and the National Commissioner;
 - Section 7 of the SAPS Act, 1995, provides that the contract is effective for up to 5 years from the signing thereof;
 - Section 45 of the SAPS Act, 1995, makes it clear that the retirement of the National Commissioner takes place at the expiry of the contract term or the extension thereof; and
 - It is, therefore, a fixed-term contract, not dependent on age.
