INTRODUCTION

- The Department of Public Works receives the conditional grant and capital budgets mainly from the Department of Health and the Department of Education.
- KZN Public Works has been successful in the previous years to spend the allocations and the Infrastructure Delivery Improvement Programme has assisted in this regard.



DEPARTMENT OF HEALTH CONDITIONAL GRANTS

- There are two (2) infrastructure programmes for KZN Department of Health that are Conditional Grant Funded, namely:
 - Hospital Revitalisation Programme
 - Forensic Mortuaries Upgrading Programme

MTEF ALLOCATION VS BUDGET BIDS

- The budget bid indicated above was submitted to Treasury, and there were drastic cuts from what was submitted and the outcome was even less than the MTEF allocation.
- Due to the budget cut in the Hospital Revitalisation Programme covering the 3 year MTEF period 2007 2010, Hospital Revitalisation Programme changed many of the plans for hospitals receiving funding from the Hospital Revitalisation Grant, especially in view of the drastic 57% cut for the 2008 / 2009 financial year which has caused many projects to be put on hold.



HOSPITAL REVITALISATION PROGRAMI

- During 2006/2007 financial year, Public Works did r receive the Infrastructure Plan from Department of Health
- The allocation of R492 million was received in 2006/2007 financial year, which included Provincial Infrastructure Fiscal Funding and Conditional Gants
- 86% of the allocated budget was spent, which is R² millions of R492 millions received



HOSPITAL REVITALISATION PROGRAMME

- In August 2007, the Infrastructure Plan for 2007/08 was received from Department of Health
- Total allocation received was R632 millions and R278 millions was for Revitalisation Programme which Conditional Grants funded and R354 millions was for the provincial capital projects.
- Expenditure to date on conditional grants is R148 millions, and there is possibility of under spending by R20 million in 2007/2008 financial year.




Expenditure to date on provincial allocation is R242 millions and all will be spent this financial year.

FORENSIC MORTUARIES

- In November 2007, Department of Public Works was instructed by Department of Health to construct forensic mortuaries.
- The budget allocation for 2007/2008 financial year is R56 million
- Fast track plan has been instituted by Public Works and all these mortuaries will be on site by April 2008
