- Duties includes:
- Direct, control and oversee the operations of the Fund
- To act with due care, diligence and good faith
- To avoid conflict of interest and act impartially
- To protect Member's interests

- ⇒ Retirement (14% to 16.50%)
- ⇒ Risk (6% to 7%)
- Retirement contributions invested with Investment Managers
- Risk contributions paid to Insurers and the balance transferred to a risk reserve account

WITHDRAWAL BENEFIT

- Dismissal and Resignation (Six Months Waiting Period Before Payment)
- ⇒ Retrenchments (Immediate Payment)
- BENEFIT
- ⇒ Total Retirement Contributions (14% to 16.50%)
- ⇒ Total Voluntary Contributions
- ⊃ Total Transferred Portion
- ⇒ Net investment Return
- ⇒ Lump Sum (Attracts Tax)
- Deferred Benefit, Transfer to Provident Preservation, Retirement annuity or New Employer's Provident Fund (Tax Free)

- ⇒ Normal Retirement (60 years underground & 63 years surface)

TERMINALLY ILL AND ILL **HEALTH BENEFIT**

- ⇒ Early Retirement
- Repatriation on medical grounds
- D BENEFIT:
- □ Total Retirement Contributions (14% to 16.50%)
- ⇒ Total Voluntary Contributions
- □ Total Transferred Portion
- ⇒ Net investment Return
- The Employer continues to pay premiums for the Death Benefit for 12 months, 'terminally ill'

DEFERRED BENEFIT

- Members can park their benefit until they reach retirement age (resignation, dismissal, retrenchment)
- ⇒ Minimum Amount R10 000
- ⇒ No Further Contributions
- Death Benefit 3 x Annual Salary Ceases
- ⇒ Funeral Benefit Ceases
